Australian Securities and Investments Commission
Corporations Act 2001 — Paragraph 911A(2)(l) — Exemption

Under paragraph 911A(2)(l) of the *Corporations Act 2001* (the *Act*) the Australian Securities and Investments Commission (*ASIC*) exempts American Express Bank Limited ARBN 108 778 767 (*American Express*) from the requirement to hold an Australian financial services licence for the provision of the financial services set out in Schedule A in the case referred to in Schedule B.

Schedule A

The provision of any of the following financial services (the *financial services*) in this jurisdiction to wholesale clients:

- (a) providing financial product advice;
- (b) dealing in a financial product;
- (c) making a market for a financial product; or
- (d) providing a custodial or depository service;

in respect of any of the following financial products:

- (e) eligible deposit products;
- (f) derivatives;
- (g) foreign exchange contracts;
- (h) securities;
- (i) facilities for making non-cash payments;
- (j) debentures, stocks or bonds issued by a government;
- (k) managed investment products; or
- (l) interests in a managed investment scheme that is not required to be registered under Chapter 5C of the Act.

Schedule B

Where all of the following apply: -

- (1) American Express is a body corporate incorporated in a State of the US;
- (2) American Express is an investment company or is an affiliate of an investment company organised under or subject to Article XII of the New York Banking Law;
- (3) American Express is regulated by the NYSBD under section 36.6 of the New York Banking Law in accordance with the Supervision Agreement;
- (4) American Express:
 - a. is registered under Division 2 of Part 5B.2 of the Act; or
 - b. has not failed for more than the last 10 business days to have an Agent;

- (5) American Express' primary business is the provision of financial services;
- (6) Neither American Express nor its Agent has been notified by ASIC that American Express is excluded from relying on this instrument;
- (7) If American Express becomes aware or should reasonably have become aware of matters that give it reason to believe that it has failed, other than in an immaterial respect, to comply with a requirement set out in Schedule C:
 - a. 15 business days have not passed since American Express became so aware or should reasonably have become so aware without American Express providing full particulars of the failure to ASIC (to the extent that the body knows those particulars or would have known them if it has undertaken reasonable enquiries); and
 - b. 30 business days have not passed from ASIC receiving those particulars from the body without ASIC notifying the body that it may continue to rely on this instrument; and
- (8) American Express has not notified ASIC that it will not rely on this instrument; and
- (9) American Express has provided ASIC with: -
 - a. evidence that paragraphs (1), (2) and (3) of this Schedule are satisfied that ASIC has stated in writing is adequate;
 - b. a notice that it will provide financial services in this jurisdiction in reliance on this instrument;
 - c. a deed of American Express for the benefit of and enforceable by ASIC and the other persons referred to in subsection 659B(1) of the Act that applies notwithstanding that American Express may have ceased to rely, or never have relied, on this instrument, which deed provides that:
 - (i) the deed is irrevocable except with the prior written consent of ASIC;
 - (ii) American Express submits to the non-exclusive jurisdiction of the Australian courts in legal proceedings conducted by ASIC (including under section 50 of the ASIC Act) and, in relation to proceedings relating to a financial services law, by any person referred to in subsection 659B(1) of the Act and whether brought in the name of ASIC or the Crown or otherwise;
 - (iii) American Express covenants to comply with any order of an Australian court in respect of any matter relating to the provision of the financial services;
 - (iv) if American Express is not registered under Division 2 of Part 5B.2 of the Act, service of process on American Express in relation to legal proceedings conducted by ASIC (including under section 50 of the ASIC Act) and, in relation to proceedings relating to a financial services law, by any person referred to in subsection 659B(1) of the Act and whether brought in the name of ASIC or the Crown or otherwise can be effected by service on the Agent; and
 - (v) American Express covenants that, on written request of either the NYSBD or ASIC, it will give or vary written consent and take all

other practicable steps to enable and assist the NYSBD to disclose to ASIC and ASIC to disclose to the NYSBD any information or document that the NYSBD or ASIC has that relates to American Express; and

- d. written consents to the disclosure by the NYSBD to ASIC and ASIC to the NYSBD of any information or document that the NYSBD or ASIC has that relates to American Express. The consents must be in such form (if any) as ASIC specifies in writing.

Schedule C

- (1) American Express must provide each of the financial services in this jurisdiction in a manner which would comply with the US regulatory requirements if the financial service were provided in the US in like circumstances.
- (2) American Express must;
 - (a) notify ASIC as soon as practicable and in such form if any as ASIC may from time to time specify in writing, of the details of:
 - (i) each significant change to, including the termination of, the Supervision Agreement entered into between the NYSBD and American Express relevant to the financial services American Express provides or intends to provide in this jurisdiction; and
 - (ii) each significant particular exemption or other relief which American Express obtains from the US regulatory requirements relevant to the financial services American Express provides or intends to provide in this jurisdiction; and
 - (aa) notify ASIC by 31 March and 30 September of each year in such form if any as ASIC may from time to time specify in writing:
 - (i) either:
 - a. of the details of each significant change (*a notifiable regulatory change*) to the US regulatory requirements (including in the power or authority of the NYSBD to supervise, monitor or procure compliance by American Express with the US regulatory requirements with respect to the provision of financial services) and in the Supervision Agreement in the 6 months (*the notification period*) ending on the 15th day of the month by the end of which the notification is required that is relevant to the financial services the body provides or intends to provide in this jurisdiction and is not a change that ASIC has stated in writing is not required to be notified for the purpose of this instrument; or
 - b. where there have been no notifiable regulatory changes- that there have been no notifiable regulatory changes; and

- (ii) either:
 - a. of the details of each enforcement or disciplinary action (***a notifiable regulatory action***) taken by the NYSBD or any other overseas regulatory authority against American Express during the notification period; or
 - b. where there have been no notifiable regulatory actions – that there have been no notifiable regulatory actions; and
- (b) provide written disclosure to all persons to whom the financial services are provided in this jurisdiction (before the financial services are provided) containing prominent statements to the following effect:
 - (i) American Express is exempt from the requirement to hold an Australian financial services licence under the Act in respect of the financial services; and
 - (ii) American Express is regulated by the NYSBD under the New York Banking Law, which differs from Australian laws.

Interpretation

In this instrument:

Agent means a natural person resident in this jurisdiction or a company, whose name and address were last notified to ASIC by American Express for the purposes of this instrument, and who is authorised to accept on American Express' behalf, service of process from ASIC and, in relation to proceedings relating to a financial services law, from any person referred to subsection 659B(1) of the Act;

American Express Banking Corporation means the parent company of American Express which is an investment company incorporated under Article XII of the New York Banking Code and regulated by the NYSBD;

custodial or depository service has the meaning given by section 766E of the Act;

derivative has the meaning given by section 761D of the Act;

eligible deposit product means any deposit-taking facility including a deposit product as defined in section 761A of the Act;

financial product has the meaning given by section 763A of the Act;

financial product advice has the meaning given by section 766B of the Act;

financial service has the meaning given by section 766A of the Act;

financial services law has the meaning given by section 761A of the Act;

foreign exchange contract has the meaning given by section 761A of the Act;

making a market has the meaning given by section 766D of the Act;

New York Banking Law means Chapter 2 of the Consolidated Laws, The Banking Law enacted April 16 1914 in the State of New York;

non-cash payments has the meaning given by section 763D of the Act;

notice and notified mean, respectively, written notice and notified in writing;

NYSBD means the New York State Banking Department;

overseas regulatory authority means a foreign regulatory authority (other than the NYSBD) which regulates financial services and which is established by or for the purposes of a foreign government or legislative body;

securities has the meaning given by section 761A of the Act;

Supervision Agreement means the agreement entered into between the NYSBD, American Express and American Express Banking Corporation dated 18 November 1997;

US means the United States of America;

US regulatory requirements means the rules that apply in relation to the financial services and banking activities including any applicable legislation, instruments made under that legislation and any relevant policies or other documents (however described) issued by the NYSBD; and

wholesale client has the meaning given in section 761G of the Act.

Corporations Act 2001 — Paragraph 601QA(1)(a) — Exemption

Under paragraph 601QA(1)(a) of the *Corporations Act 2001* (the *Act*) the Australian Securities and Investments Commission (*ASIC*) exempts the person specified in Schedule A from subsection 601FC(4) of the Act in the case set out in Schedule B and on the conditions set out in Schedule C.

Schedule A

Perpetual Trust Services Limited ACN 000 142 049 (the *Responsible Entity*) as the responsible entity of Fidelity Global Property Securities Fund ARSN 116 073 011 (the *Scheme*).

Schedule B

The investment of scheme property or the keeping of scheme property invested, in a managed investment scheme (the *REIT*) that:

- (a) is not registered under Chapter 5C of the Act; and
- (b) is operated by a body that is incorporated or formed in the United States of America (USA) or a State of the USA; and
- (c) has qualified by election as a real estate investment trust as referred to in section 856 of the Internal Revenue Code of 1986 of the USA (the *Code*) or any provision that replaces that section and the responsible entity reasonably believes that such election has not been terminated or revoked under subsection 856(g) of the Code; and
- (d) has issued interests that are registered under the Securities Exchange Act of 1934 of the USA, and is an issuer that is required by that legislation to file annual and other periodic reports with the Securities and Exchange Commission of the USA (the *SEC*); and
- (e) is subject to the enforcement and other powers of the SEC of the USA under the Securities Act of 1933, Securities Exchange Act of 1934 and the Sarbanes-Oxley Act of 2002 of the USA; and

where the interests in the REIT are traded on the New York Stock Exchange, the American Stock Exchange, the National Association of Securities Dealers Automated Quotation National Market, or the Nasdaq Stock Market of the USA.

Schedule C

1. Before the investment of scheme property or the keeping of scheme property in a REIT referred to in Schedule B, the Responsible Entity must prepare and keep for seven years, for each investment, a document signed by an officer or agent of the Responsible Entity explaining why the investment would comply with the

Responsible Entity's duties, considering the regulation that applies to the REIT
and any other relevant matter; and

2. The Responsible Entity must at reasonable intervals make such enquiries as are reasonably necessary to confirm that each REIT referred to in Schedule B meets paragraph (c) of Schedule B.



**Australian Securities and Investments Commission
Corporations Act 2001 — Paragraphs 601QA(1)(a), 911A(2)(l), 992B(1)(a) and
1020F(1)(a) — Exemption**

1. Under paragraph 601QA(1)(a) of the *Corporations Act 2001* ("the Act") the Australian Securities and Investments Commission ("ASIC") hereby exempts the persons referred to in Schedule A in the case referred to in Schedule B on the conditions set out in Schedule C from compliance with section 601ED.
2. Under paragraphs 911A(2)(l), 992B(1)(a) and 1020F(1)(a) of the Act, ASIC hereby exempts the persons referred to in Schedule A in the case referred to in Schedule B on the conditions set out in Schedule C from:
 - (a) sections 992A, 992AA and 1017F of the Act; and
 - (b) the requirement to hold an Australian financial services licence for the provision of financial services by that person in relation to dealing in or advising on interests in a managed investment scheme of the kind and offered on the basis referred to in Schedule B.

SCHEDULE A

Spicer Property Investments Pty Ltd ACN 113 818 871, Limatt Nominees Pty Ltd ACN 006 983 375 and Simmer Pty Ltd ACN 006 986 465.

Each person described in this Schedule A is referred to in this instrument as a "Promoter".

SCHEDULE B

Operating a managed investment scheme ("Scheme") that involves registered proprietors of Antigua Beach Resort located at 4-6 Queensland Avenue, Broadbeach, Queensland ("strata units"), making their strata units available to a Promoter for use as part of a serviced apartment, hotel, motel or resort complex where every interest in the Scheme ("Interest") has been issued because of an offer:

- (a) made before 2 March 2000;
- (b) made after 1 March 2000 and before 1 January 2001 and a Promoter provided to each person to whom the offer was made at or before the making of the offer, a document that the Promoter reasonably believed complied with Schedule D that was signed and dated by the person operating the serviced apartment, hotel, motel or resort complex ("operator") or, if the operator was not knowingly concerned in the offer, by a Promoter;
- (c) made after 31 December 2000 where:
 - (i) the offer relates only to the making available of strata units that on 31 December 2000 were owned by, or in relation to which there was a binding contract of sale with, a person other than a Promoter or any other person that a Promoter has reason to suspect was involved in development of the strata units or the operation of the Scheme; and

- (ii) no more than 20 persons (other than persons that were members on or before 31 December 2000) become members of the Scheme in any 12 months starting after 31 December 2000 because of an offer by a Promoter other than an offer permitted by paragraph (e), (f) or (g);
- (d) made after 31 December 2000 where:
 - (i) the offer is in accordance with a description of intended offers lodged with ASIC prior to the offer being made, and ASIC has not notified the Promoter in writing that such offer should not be made or issued;
 - (ii) the description lodged includes:
 - (A) the number of strata units planned in the real property to which the Scheme relates;
 - (B) the anticipated completion date of each incomplete building;
 - (C) the number of strata units that:
 - (I) are held by a Promoter or its associate that the Promoter intends to be sold other than to a Promoter or its associate;
 - (II) are held by a Promoter or its associate that the Promoter does not intend to be sold to a person other than a Promoter or its associate; and
 - (III) have been sold to a person that is not a Promoter or an associate of a Promoter;
 - (D) whether there have been any changes to the structure of the Scheme or other material changes to the information that has been given to ASIC in relation to the Scheme; and
 - (E) the anticipated completion of all currently intended sales; and
 - (iii) no promoter is aware that any disclosure statement required to be given to a person under this instrument or any Product Disclosure Statement required to be given to a person under the Act in relation to the scheme, was not given or was given but did not comply with this instrument or the Act as the case may be;
- (e) that is an excluded offer or an excluded invitation (as defined by subsection 66(3) of the Corporations Law as it stood prior to 13 March 2000) or an offer to which ASIC Class Order 98/1931 or a replacement for that Class Order applies;
- (f) that would not need disclosure to investors under Part 6D.2 of the old Corporations Act (as defined in subsection 1410(1) of the Act) because of section 708 (other than subsection 708(1)) assuming that the Scheme is registered and that Interests are securities; or
- (g) that would not need disclosure to investors under Division 2 of Part 7.9 because of section 1012D.

SCHEDULE C**05 / 1078**

1. Each Promoter must not engage in misleading or deceptive conduct or conduct that is likely to mislead or deceive in relation to the Interests.
2. Each Promoter must not intentionally or recklessly fail to comply with its obligations to any member of the Scheme in relation to an Interest to the material detriment of the member.
3. Each Promoter must notify ASIC in writing immediately if:
 - (a) it is, or becomes aware that there is reason to suspect that a Promoter has:
 - (i) engaged in misleading or deceptive conduct or conduct that is likely to mislead or deceive in relation to the Interests; or
 - (ii) not complied with its obligations to any member of the Scheme to the material detriment of the member,
 whether that conduct or non-compliance occurred before or occurs after the date of this instrument; and
 - (b) ASIC has not previously been notified of the conduct or non-compliance.
4. Each Promoter must ensure that, where the Promoter makes an offer of Interests for issue to which paragraph (c) of Schedule B applies during the transition period (within the meaning of subsection 1438(3) of the Act), the Promoter provides to each person to whom the offer is made at or before the making of the offer a document that the Promoter reasonably believes complies with Schedule D ("Disclosure Statement") that is signed and dated by the operator or, if the operator is not knowingly concerned in the offer, by the Promoter.
5. Each Promoter must ensure that, where the Promoter makes an offer of Interests for issue to which paragraph (d) of Schedule B applies during the transition period (within the meaning of subsection 1438(3) of the Act), the Promoter provides to each person to whom the offer is made at or before the making of the offer, a document that the Promoter reasonably believes complies with Schedule D that is signed and dated by the operator or, if the operator is not knowingly concerned in the offer, by a Promoter, and the document clearly and prominently discloses:
 - (a) the extent (if any) to which members of the Scheme have the same rights as those which are described in Schedule E of ASIC Class Order 02/88 (being rights to replace the operators of certain schemes);
 - (b) extent (if any) to which members of the Scheme do not have such rights; and
 - (c) the substance of the rights referred to in sub-paragraphs (a) and (b).

SCHEDULE D

1. The Disclosure Statement must:
 - (a) describe the main features of the Interests;
 - (b) set out the main terms and conditions of the offer;

- (c) provide answers to the questions set out in paragraph 2 of this Schedule (the questions need not be set out, and the answers can be provided in any order or format), sufficiently to enable a typical person that may be offered Interests ("investor") to make an informed decision whether to become a member of the Scheme, having regard to every matter which is material to such a decision that:
 - (i) is known to any person who authorised or caused the issue of the Disclosure Statement; or
 - (ii) it would be reasonable for such a person to obtain by making inquiries; and
 - (d) be a copy of a disclosure statement that has been given to ASIC if ASIC has requested a Promoter in writing that any disclosure statement relating to the Scheme be given to it.
2. The questions are:
- (a) What is being offered?
 - (i) How are the investor's property rights affected by holding an Interest?
 - (ii) What key rights will investors have in relation to the use of their strata unit by the operator?
 - (iii) What sort of serviced apartment, hotel, motel or resort complex is being operated under the Scheme and how will it be operated?
 - (iv) What are the key terms of any lease, licence or rights that investors are to confer on the operator in relation to the operation of the Scheme?
 - (v) Does the operator own or have rights in relation to any property that may adversely affect:
 - (A) how the Scheme would operate if the operator were changed; or
 - (B) the amount investors are likely to receive for use of their strata unit if the property ceases to be available (for whatever reason), and, if so, what are those rights? How could the adverse effect happen?
 - (b) What are the risks and returns of the investment?
 - (i) How, in general terms, will the operation of the serviced apartment, hotel, motel or resort complex generate returns for investors?
 - (ii) When and how are these returns to be calculated and made available to investors?
 - (iii) Are investors in the Scheme guaranteed or promised that they will receive a particular rate of return from the Scheme? If so:
 - (A) what are the conditions for receiving the benefits of this guarantee or promise;
 - (B) what (if any) are the circumstances in which the person providing the guarantee or promise may be unable to honour it;

- (C) what is the financial position of the person giving the guarantee or promise; and
- (D) on what basis do investors receive returns once the guarantee or promise expires?
- (iv) If no particular rate of return is guaranteed or promised:
 - (A) is the operator aiming to achieve a particular return;
 - (B) can investors expect any particular return; and
 - (C) are returns from the Scheme uncertain?
- (vi) If returns from the Scheme may vary from what is aimed for or expected, or are otherwise uncertain, what are the main factors which will affect the level of return? If occupancy rates will affect the returns what are the main factors that will affect occupancy rates?
- (vii) Do investors have potential liability to pay moneys in relation to the Scheme or their ownership of a strata unit in any circumstances? If so, what are these liabilities and what main factors will affect the amount of these liabilities? For example, how will any repairs, refurbishment or replacement of any part of the serviced apartment, hotel, motel or resort complex and its furniture and fittings be paid for?
- (viii) Is there a suggested minimum period of time that an investor's investment should remain in the Scheme? If so, why is that period of time suggested? What, if any, are the kinds of qualifications on that suggestion?

 - (i) If the operator signs the Disclosure Statement, who is it and what are its credentials in operating hotels, motels, resorts or serviced apartment complexes (including details of its principal activities and relevant experience)?
 - (ii) If the operator does not sign the Disclosure Statement, how, and on what basis, will the operator be selected to undertake the operation of the Scheme?
 - (iii) If the operator signs the Disclosure Statement and the operator is to engage a person to operate the hotel, motel, resort or serviced apartment complex on its behalf, what credentials will that person

have to operate the hotel, motel, resort or serviced apartment complex?

- (iv) What are the custodial arrangements for holding the money of the Scheme including money held for distribution to members and to meet expenses of the Scheme?
- (e) When can investments be withdrawn and transferred?
 - (i) When and how can an investor withdraw from the Scheme?
 - (ii) Can an Interest be transferred and, if so, in what circumstances? What legal requirements apply?
- (f) What information can be obtained?
 - (i) How can the entity signing the Disclosure Statement be contacted?

- 4. The Disclosure Statement must also include a prominent statement to the effect that investors do not have the benefit of the protection that applies to investors in a regulated managed investment scheme and that, in particular:
 - (a) the Scheme is not a registered scheme;
 - (b) neither the promoter nor the operator is a financial services licensee; and
 - (c) the Disclosure Statement is not a Product Disclosure Statement containing the information required by the Corporations Act.



**Australian Securities and Investments Commission

1. Under paragraph 601QA(1)(a) of the *Corporations Act 2001* (the *Act*), the Australian Securities and Investments Commission (*ASIC*) exempts the persons referred to in Schedule A from section 601ED of the Act in the case referred to in Schedule B on the conditions set out in Schedule C.
2. Under paragraphs 911A(2)(l), 992B(1)(a) and 1020F(1)(a) of the Act ASIC exempts the persons referred to in Schedule A in the case referred to in Schedule B on the conditions set out in Schedule C from:
 - (a) sections 992AA and 1017F of the Act; and
 - (b) the requirement to hold an Australian financial services licence for the provision of financial services by that person in relation to dealing in interests in a managed investment scheme of the kind and offered on the basis referred to in Schedule B.

Schedule A

1. South Steyne Hotel Pty Limited ACN 094 240 767 (*promoter*)
2. Mirvac Management Limited ACN 086 453 205 or any of its related bodies corporate (*operator*).

Schedule B

Operating a managed investment scheme which involves an owner (*investor*) of real property (*strata unit*), in the investor's discretion, making their strata unit available for use by a person (*operator*) as part of a serviced apartment, hotel, motel or resort complex located at South Steyne and Ashburner Street, Manly, New South Wales and in relation to which on 1 March 2000 there was no person who had bought or agreed to buy a strata unit and who, before agreeing to buy, had been offered an interest in the scheme, where all of the following apply:

- (a) the sale of the strata unit is not and was not conditional on participation in the serviced strata scheme;
- (b) each investor and the operator may withdraw from participation in the scheme on no more than 90 days notice and an investor that withdraws will not be bound after that notice expires to allow use of their strata unit except for occupation of the strata unit:
 - (i) by a person other than the operator or an associate of the operator; and
 - (ii) under an agreement that the operator made with that person before the notice of withdrawal was given;

- (c) each investor may, if the investor withdraws from participation in the scheme, appoint another person to manage their strata unit;
- (d) the operator is licensed in relation to the conduct of the letting services under the law of a State or Territory or is an financial services licensee;
- (e) no payment is liable to be made by an investor to participate in the scheme other than:
 - (i) payment of money to buy the strata unit;
 - (ii) one or more payments of the investor's reasonable proportion of the operator's fees and expenses with respect to the management of the scheme where in any 3 month period the total of such payments relates to a period of no more than 3 months and where:
 - (A) that total is reasonably commensurate with the work done or to be done, or the expenses incurred or likely to be incurred (as the case may be), by the operator during the period to which the payments relate; and
 - (B) where a FFE Fund has been established for the investor — no payment or part thereof is used for the replacement, repair or refurbishment of furniture, fittings and equipment of the strata unit in relation to the period to which the payment relates unless all money in the Fund has first been expended; and
 - (iii) where a FFE Fund has been established for the investor — one or more payments into the Fund where:
 - (A) each payment is by way of a deduction from rental income of the scheme that would otherwise be paid to the investor in relation to a period and does not exceed 3% of the gross rent attributable to the investor for the period; and
 - (B) the balance of the Fund at all times does not exceed \$5,000 for each strata unit made available by the investor for use as part of the scheme;
- (f) there is no obligation on any person to ensure that other owners of strata units agree to participate in the scheme;
- (g) the serviced apartment, hotel, motel or resort complex is operated in accordance with a written agreement entered into or to be entered into between the operator and each investor which agreement includes provisions as specified in Schedule D;
- (h) the promoter or operator is not aware of any circumstances in which the Act required a Product Disclosure Statement to be given to a person in relation to the scheme and:

- (i) no Product Disclosure Statement was given to the person; or
- (ii) a Product Disclosure Statement was given to the person, but the Product Disclosure Statement did not comply with the Act.

Schedule C

1. The operator must ensure that any part of the scheme property held in cash or on deposit with an Australian ADI or another financial institution must be held on trust for the members in a trust account and subject to audit as to whether the moneys have been dealt with in accordance with the terms of the trust by a registered company auditor at least annually;
2. Each promoter that is involved in making an offer of interests in the scheme for issue must not engage in any misleading or deceptive conduct or conduct that is likely to mislead or deceive in connection with those offers;
3. The operator must comply with the provisions specified in Schedule D which are included in the agreement referred to in paragraph (g) of Schedule B.

Schedule D

1. *Transfer of management rights*
 - (a) If a majority of scheme members advise the operator in writing that they wish to terminate the operator's engagement, the operator must within 9 months transfer the management rights to a person that is chosen by the operator that has not been involved in the operation (including promotion) of the scheme and is not controlled by a person that has been involved in the operation (including promotion) of the scheme.
 - (b) If an operator fails to complete that transfer within the 9 month period, the operator must cause the transfer of the management rights to a replacement operator named in a written notice given by a majority of scheme members, at a price specified in the notice.
 - (c) A transfer referred to in paragraphs (a) or (b) must be done as soon as practicable, but if there is a body corporate for the real property to which the scheme relates, there must be a reasonable time for members of the body corporate to consider whether to make a decision referred to in paragraph 2(b) unless the body corporate has consented to the transfer.
2. *Consent of body corporate to new care-taking arrangements*
 - (a) If an operator receives a notice under paragraph 1(b) of this Schedule, the operator must advise all body corporate members of the name of the person to whom the transfer is to be made.

- (b) Unless the body corporate has consented to the transfer, an operator does not have to transfer the management rights to the person named in the notice described in paragraph 1(b) of this Schedule if a majority of body corporate members state in writing to the operator that the person should not be engaged by the body corporate to perform care-taking functions.
- (c) If a majority of body corporate members make a decision referred to in paragraph 2(b) of this Schedule, a majority of scheme members may then at any time name a replacement operator by a written notice, to whom the operator must transfer the management rights at a price specified in the notice and the notice will be taken to be given in accordance with paragraph 1(b) of this Schedule.
- (d) This paragraph 2 does not apply if the body corporate or a majority of body corporate members agree in writing to the transfer to the person named in a notice under paragraph 1(b) or 2(c) of this Schedule before that notice is given to the operator.

3. *Price payable on transfer*

The price scheme members specify in a notice under paragraph 1(b) of this Schedule must be one of the following:

- (a) the average of two valuations of the management rights by independent qualified valuers nominated by the Australian Property Institute (or another relevant independent professional body approved by ASIC); or
- (b) the highest bona fide bid for the management rights (excluding a bid by the operator or its associates) at an auction of which at least 60 days' notice had been given; or
- (c) the highest bona fide amount tendered (excluding any tender by the operator or its associates) for the management rights following reasonable efforts to market the property for at least 60 days.

4. *Voting*

- (a) In determining if there is a majority of scheme members or body corporate members, the operator and its associates and any person nominated as a replacement operator and associates of that person must not be counted.
- (b) For scheme members, a majority is based on their entitlement to vote at body corporate meetings if there is a body corporate for the property to which the scheme relates, and otherwise each member shall have one vote.
- (c) For body corporate members, a majority is based on their entitlement to vote at body corporate meetings.

- (d) A scheme member or a body corporate member makes a decision by signing a document that sets out the decision.

5. *Costs*

- (a) Any member may arrange a valuation or auction of, or may market, the management rights before or after the expiration of the 9 month period referred to in paragraph 1(a) of the Schedule for the purposes of determining a price to be specified in a notice under paragraph 1(b) of this Schedule.
- (b) If a member incurs any reasonable valuation, auction or marketing costs under paragraph 5(a) of this Schedule that member is entitled to be reimbursed out of the price payable by any person nominated by the members as transferee of the management rights when the price is paid to the operator.

6. *Assistance*

The operator must give reasonable assistance to enable the transferee to operate the resort, hotel, motel or serviced apartment complex including making available information concerning any prospective bookings.

7. *Definitions*

In this Schedule:

“scheme members” means investors in the scheme excluding the operator and its associates;

“management rights” means all real or personal property (including contractual rights) held by the operator or any of its associates that facilitates the operation of the scheme; and

“transfer” in relation to management rights means to assign or transfer the management rights or to cause another person to become the holder of those rights or rights substantially the same as those rights.

Interpretation

In this instrument:


“FFE Fund” means a fund established for an investor consisting of money paid by the investor and any interest accrued on that money, to be used from time to time in accordance with the written agreement referred to in paragraph (g) of Schedule B for the replacement, repair or refurbishment of furniture, fittings and equipment of the strata unit made available by the investor for use as part of the scheme; and

“offer” is to be interpreted in accordance with subsection 1010C(2) of the Act.
