Revocation, Exemption and Modification

1. Under subsection 1454(2) of the Corporations Law, as in force as at 1 July 1998 (*Old Law*) (as continued in force by section 1408 of the *Corporations Act 2001 (Act)*), and paragraph 601QA(1)(b) of the Act, the Australian Securities and Investments Commission (*ASIC*) revokes ASIC Instrument [01/0360] dated 29 March 2001, as amended by ASIC Instrument [05/0731] dated 28 June 2005.
2. Under paragraph 601QA(1)(a) of the Act, ASIC exempts the persons specified in Schedule A in the case referred to in Schedule B from subsection 601ED(1) of the Act until 2 April 2024 on the condition in Schedule C.
3. Under paragraph 601QA(1)(b) of the Act, ASIC declares that Chapter 11 of the Old Law, as continued in force by section 1408 of the Act, applies to the persons specified in Schedule A in the case specified in Schedule B as if:
