**Australian Securities and Investments Commission





Corporations Act 2001 — Paragraphs 992B(1)(a), 1020F(1)(a) and
1020F(1)(b) — Exemptions**

1. Under paragraph 1020F(1)(a) of the *Corporations Act 2001 (the Act)*, the Australian Securities and Investments Commission (*ASIC*) exempts ING Investment Management Holdings, N.V. and its related bodies corporate (each, an *Issuer*) from Part 7.9 of the Act where the Issuer:
 - (a) makes an eligible offer; or
 - (b) offers to arrange for the issue of financial products under an eligible offer; or
 - (c) issues a financial product under an eligible offer,on the conditions set out in the Schedule and for so long as the conditions are met.
2. Under paragraph 1020F(1)(b) of the Act, ASIC exempts a financial product that is the subject of an eligible offer from Part 7.9 of the Act where:
 - (a) a recommendation is made (by a person other than the Issuer) that a person to whom an eligible offer has been made acquire the financial product as a retail client; and
 - (b) the person who made the recommendation is not aware, and ought not reasonably to be aware, that any of the conditions set out in the Schedule have not been met.
3. Under paragraph 992B(1)(a) of the Act, ASIC exempts the Issuer from section 992A of the Act in relation to eligible offers made in the circumstances covered by paragraph 1 of this instrument made in the course of, or because of, unsolicited meetings or telephone calls reasonably held or made in connection with the eligible offer.



- (A) owned by the insured person or is one for which the insured person is legally responsible; or
 - (B) held on consignment; or
 - (C) financed under a floor plan arrangement; or
- ii. the motor vehicle is owned by a customer of the insured person or is one for which the customer is legally responsible and is situated within the business premises of the insured person or within areas of the immediate vicinity of those premises in the course of business for the purpose of servicing, repair, road testing, garaging, maintenance, alteration, inspection, valuation, testing, storage or delivery of the vehicle; and
- b. the motor trade vehicle insurance product does not provide insurance cover for liability for loss of, or damage to, people or property caused by or resulting from impact of the motor vehicle with some other thing while in transit outside the business premises of the insured person; and
- c. the other kinds of insurance cover provided by the motor trade insurance contract are not kinds of insurance cover referred to in Division 2 of Part 7.1 of the Corporations Regulations 2001 (the *Regulations*) as in force; and
- d. CGU is a member of an external dispute resolution scheme approved by ASIC under ASIC Class Order [CO 09/340] that covers complaints against CGU made in connection with the provision of financial services in relation to the motor trade vehicle insurance product.
6. This declaration ceases to apply if the motor trade insurance contract predominantly comprises the motor trade vehicle insurance product.

Interpretation

7. In this instrument:

motor vehicle means a vehicle that is designed:

- (a) to travel by road;
- (b) to use volatile spirit, steam, gas, oil, electricity or any other power (not being human power or animal power) as its principal means of propulsion; and
- (c) to carry passengers;

and includes a motor cycle but does not include:

(d) an omnibus; or

(e) a tram; or

(f) a motor vehicle the carrying capacity of which exceeds 2 tonnes.
