Australian Securities and Investments Commission Corporations Act 2001 – Paragraph 673(1)(b) - Declaration

Under paragraph 673(1)(b) of the Corporations Act 2001, the Australian Securities and Investments Commission declares that Chapter 6C of the Act applies to the persons referred to in Schedule A in the case referred to in Schedule B as if:

- (a) with effect until and including 30 September 2009, section 671B of the Act were modified to disregard relevant interests in voting shares arising as a result of the entry into, but not the completion of, the Sale Agreement and substantial holdings arising or increasing as a result of such relevant interests; and
- (b) subsection 671B(4) were modified to the extent necessary to provide that the information referred to in subsection 671B(3) of the Act does not need to be accompanied by a copy of the Sale Agreement.

Schedule A

National Australia Bank Limited ACN 004 044 937 (NAB) and its related bodies corporate.

Schedule B

Where:

- (a) a person referred to in Schedule A acquires a relevant interest in voting shares as a result of entry into the Sale Agreement; and
- (b) the Sale Agreement does not contain information that:
 - (i) is not generally available; and
 - (ii) that a reasonable person would expect, if it were generally available, would have a material effect of the price of value of securities of NAB or an entity in which a person referred to in Schedule A acquires a relevant interest as a result of entry into the Sale Agreement.

Interpretation

In this instrument:

"Sale Agreement" means the sale agreement dated on or about 22 June 2009 between NAB (or its wholly-owned subsidiary) and Undershaft (No. 1) Ltd and Aviva Group Holdings Limited the latter two companies both incorporated in England in relation to the sale of Aviva Australia Holdings Limited ACN 095 045 784.

Australian Securities and Investments Commission Corporations Act 2001 — Paragraph 911A(2)(I) — Exemption

Enabling legislation

1. The Australian Securities and Investments Commission (ASIC) makes this instrument under paragraph 911A(2)(l) of the Corporations Act 2001 (Act).

Commencement

2. This instrument commences on the date of its gazettal.

Exemption

- A related body corporate of ARC Equity Partners Pty Limited ACN 134 400 230 (AEP) that is a trustee of a wholesale real property scheme (trustee) does not have to comply with the requirement to hold an Australian financial services licence (AFS licence) for the provision of the following financial services (wholesale real property financial services):
 - (a) dealing in general insurance products that form part of the trust property of the wholesale real property scheme; and
 - (b) providing a custodial or depository service in relation to the products mentioned in paragraph (a).

Where relief applies

- 4. The exemption in paragraph 3 is only available where all of the following apply:
 - (a) AEP holds an AFS licence that:
 - (i) authorises AEP to provide wholesale real property financial services; and
 - (ii) contains conditions to the effect that AEP must:
 - (A) as far as possible, comply with the Act as if the trustee was providing wholesale real property financial services as AEP's representative; and
 - (B) have in place a deed poll that contains enforceable, unlimited and irrevocable covenants, for the benefit of each

person (*beneficiary*) to whom the trustee provides a wholesale real property financial service, to the effect that AEP will indemnify the beneficiary in relation to any liability (other than an exempt liability) that arises from the trustee's provision of a wholesale real property financial service to the beneficiary; and

- (C) for the purposes of the relevant financial conditions of AEP's AFS licence treat the assets, liabilities, cash inflows and cash outflows of the trustee as though they were included in the assets, liabilities, cash inflows and cash outflows of AEP; and
- (b) either of the following applies:
 - (i) the trustee and AEP have only issued any interests in the wholesale real property scheme to a person as a wholesale client and have, from the later of the date of this instrument and when the trustee or AEP first issue an interest in the scheme, taken all reasonable steps to ensure that interests in the scheme are only acquired by a person as a wholesale client; or
 - (ii) if the trustee or AEP becomes aware or should reasonably have become aware of matters that give it reason to believe that it has failed, other than in an immaterial respect, to comply with subparagraph (i):
 - (A) 10 business days have not elapsed without full particulars of the failure having been provided to ASIC in writing (to the extent that the trustee or AEP knows those particulars or would have known them if it had undertaken reasonable enquiries); and
 - (B) 30 business days have not elapsed from ASIC receiving those particulars from the trustee or AEP without ASIC having notified the trustee or AEP in writing that the trustee may continue to rely on this instrument; and

(c) if the trustee or AEP becomes aware that, if the trustee held an AFS licence that contained the following conditions:

- (i) a condition to the effect of condition 13 of ASIC Pro Forma [PF 209] Australian financial services licence conditions (**PF 209**) as published at the date of this instrument; and
- (ii) conditions to the effect of those parts of condition 28 of PF 209 (other than condition 28(a) and conditions 28(d)(iii), (iv) and (v)) that relate to a report by an auditor relating to condition 13; and
- (iii) a condition that the trustee must lodge with ASIC the report by an auditor that would be required by those parts of condition 28 of PF 209 within 15 months of the time the trustee first relies on this instrument and then within each period of 13 months thereafter and relating to a period that commences:
 - (A) at the date of that first reliance; or
 - (B) immediately after the end of the period to which the last previous report lodged under this requirement relates,

and ends not more than 3 months before the date of lodgment of the report,

as if:

- (iv) references to a responsible officer in condition 13 of PF 209 were to an officer; and
- (v) references to the licensee's annual audit report under condition 28 of the licence in condition 13 of PF 209 were to the report lodged under subparagraph 4(c)(iii) of this instrument; and
- (vi) references to conditions of the licence in condition 28 of PF 209 were to the condition mentioned in subparagraph 4(c)(i) of this instrument,

it would be in breach, other than in an immaterial respect, of any of those conditions; and

- (vii) 10 business days have not elapsed without the matter being notified to ASIC in writing; and
- (viii) 30 business days have not elapsed from ASIC receiving the notice from the trustee or AEP without ASIC having notified the trustee in writing that the trustee may continue to rely on this instrument.

Exclusion from reliance

5. The exemption in paragraph 3 does not apply to a person who has been notified in writing by ASIC that the person is excluded from relying on this instrument.

Interpretation

6. In this instrument:

custodial or depository service has the meaning given by section 766E of the Act.

exempt liability means, in relation to a wholesale real property scheme, a liability arising from any act or omission relating to a wholesale real property financial service for which the trustee of the scheme may be indemnified from the trust property.

incidental property, in relation to a wholesale real property scheme, means cash, deposits or current accounts with an Australian ADI or interests in a cash management trust that are held for no more than three months pending expenditure or distribution to members.

general insurance products has the meaning given by section 761A of the Act.

relevant financial conditions, in relation to an AFS licence, means conditions to the effect of conditions 13 (base level financial requirements), 21 (financial requirements for holding client money or property), 22 (financial requirements for licensee transacting with clients) and 28 (audit opinion on financial requirements) of PF 209 (as published at the date of this instrument).

representative has the meaning given by section 910A of the Act.

wholesale client has the meaning given by section 761G of the Act.

trust property of a wholesale real property scheme means:

(a) contributions of money or money's worth to the scheme; and

- (b) money borrowed or raised by the trustee for the purposes of the scheme; and
- (c) property acquired, directly or indirectly, with, or with the proceeds of, contributions or money referred to in paragraph(a) or (b); and
- (d) income and property derived, directly or indirectly, from contributions, money or property referred to in paragraph (a), (b) or (c).

wholesale real property scheme means a managed investment scheme to which all of the following apply:

- (a) the scheme is not registered, and is not required to be registered, because of subsection 601ED(2) of the Act; and
- (b) all of the trust property (other than incidental property and general insurance products) consists of real property.

Australian Securities and Investments Commission Corporations Act 2001 - Paragraphs 911A(2)(l), 992B(1)(a) and 1020F(1)(a) -Exemptions

Disclosure relief

- 1. Under paragraph 1020F(1)(a) of the *Corporations Act 2001 (the Act)* the Australian Securities and Investments Commission (*ASIC*) exempts Crown Castle Australia Holdings Pty Ltd A.C.N. 086 370 274 (*the Issuer*) from Part 7.9 where the Issuer:
 - (a) makes an eligible offer; or
 - (b) offers to arrange for the issue of financial products under an eligible offer; or
 - (c) issues a financial product under an eligible offer,

on the conditions set out in the Schedule and for so long as the conditions are met.

Licensing relief

2. Under paragraph 911A(2)(1) ASIC exempts the Issuer from the requirement to hold an Australian financial services licence for the provision of a financial service consisting of general advice reasonably given in connection with an eligible offer made in the circumstances covered by paragraph 1 of this instrument (including any general advice given in the offer document) where the offer document for the eligible offer includes a statement to the effect that any advice given by the Issuer in connection with the eligible offer is general advice only, and that employees should consider obtaining their own financial product advice from an independent person who is licensed by ASIC to give such advice.

Hawking relief

3. Under paragraph 992B(1)(a) ASIC exempts the Issuer from sections 992A and 992AA in relation to eligible offers made in the course of, or because of, unsolicited meetings or telephone calls reasonably held or made in connection with the eligible offer.

Schedule

The following conditions apply:

- 4. the Issuer making the eligible offer must:
 - (a) include that eligible offer in an offer document;
 - (b) take reasonable steps to ensure that any eligible employee to whom the offer is made is given a copy of the offer document; and

- (c) provide to ASIC a copy of the offer document (which need not contain details of the offer particular to the employee, such as the identity or entitlement of the employee) not later than 7 days after the first provision of that material to an employee;
- 5. the Issuer must ensure that the eligible offer is substantially on the terms set out in the offer document;
- 6. the Issuer must ensure that the eligible offer is not made to or accepted by more than 20 eligible employees in each calendar year;
- 7. the Issuer must prepare and provide to every eligible employee who has accepted an eligible offer a Quarterly Business Report within 14 days of the end of each quarter until the Redemption Date; and
- 8. the Issuer must commission an independent and suitably qualified valuer to prepare a Valuation Report:
 - (a) as at 31 December of each calendar year and the Issuer must prepare and provide a summary of the Valuation Report to every eligible employee who has accepted an eligible offer on or before 21 February of each calendar year until the Redemption Date; and
 - (b) as at 30 days prior to the Redemption Date and the Issuer must prepare and provide a summary of the Valuation Report to every eligible employee who has accepted an eligible offer at least 14 days prior to the Redemption Date.

Interpretation

In this instrument:

eligible employee means a person who is at the time of an eligible offer, a full or part-time employee or director of the Issuer or of an associate body corporate of the Issuer and whose yearly remuneration salary is \$100,000 or more;

eligible offer means an offer for the issue of units made under the Plan and extended only to eligible employees;

financial product advice has the meaning given by section 766B;

general advice has the meaning given by section 766B;

offer has a meaning affected by section 1010C;

offer document means a document in writing that sets out an offer under the Plan that includes or is accompanied by:

(a) a copy of the Rules of the Plan under which the offer is made;

- (b) a copy of or a document substantially on the terms set out in the LTI valuation methodology and draft letter to participants on the proposed grant of units under the new scheme that was provided to ASIC on 7 April 2010; and
- (c) a description that includes worked examples of how the Redemption Price will be calculated;

Plan means an employee incentive scheme that is known as at the date of this instrument as the Director and Employee Long Term Incentive Scheme;

Quarterly Business Report means a document in writing that includes information about the Issuer's cash flows, revenues, expenses and profits or losses for a particular quarter and the Issuer's assets, liabilities and shares on issue as at the end of a particular quarter;

Redemption Date has the same meaning as given in the Rules of the Plan;

Redemption Price has the same meaning as given in the Rules of the Plan;

Rules of the Plan means the written terms of the Plan that are substantially the same as the terms set out in the Director and Employee Long Term Incentive Scheme provided to ASIC on 9 March 2010; and

Valuation Report means a document in writing that contains an estimate of the value of the Issuer and the assumptions, inputs, methodology, calculations and any other material information that is used to estimate the value of the Issuer. The Valuation Report must state that the estimate of the value of the Issuer is fair and reasonable in the opinion of the valuer.

This instrument takes effect on gazettal.

Australian Securities and Investments Commission Corporations Act 2001 — Paragraphs 911A(2)(l) and 1020F(1)(a)— Exemptions

- 1. Under paragraph 1020F(1)(a) of the *Corporations Act 2001* (the *Act*), the Australian Securities and Investments Commission (*ASIC*) exempts Elkington Bishop Molineaux Insurance Brokers Pty Limited ACN 009 179 640 (the *Issuer*) from Part 7.9 of the Act where the Issuer:
 - (a) makes an eligible offer; or
 - (b) issues a financial product under an eligible offer,

on the conditions set out in the Schedule and for so long as the conditions are met.

- 2. Under paragraph 911A(2)(1) of the Act, ASIC exempts the Issuer from the requirement to hold an Australian financial services licence for the provision of a financial service consisting of:
 - (a) general advice reasonably given in connection with an eligible offer made in the circumstances covered by paragraph 1 of this instrument (including any general advice given in the offer document) where the offer document for the offer includes a statement to the effect that any advice given by the Issuer in connection with the offer is general advice only, and that employees should consider obtaining their own financial product advice from an independent person who is licensed by ASIC to give such advice; and
 - (b) dealing in a financial product in connection with an eligible offer made in the circumstances covered by paragraph 1 of this instrument.

Schedule

The Issuer must:

- (a) ensure that the eligible offer is substantially on the terms set out in the Rules of the Plan as at the date of this instrument;
- (b) include the offer in an offer document;
- (c) take reasonable steps to ensure that any eligible employee to whom the offer is made is given a copy of the offer document;
- (d) ensure that an eligible offer is not made to and accepted by more than 20 eligible employees; and
- (e) comply with any undertaking required to be made in the offer document by reason of this instrument.

Note: where a document must be provided in writing it may be provided by electronic means. See s5C of the Act and s25 of the Acts Interpretation Act 1901.

Interpretation

In this instrument:

- 1. *Eligible employee* means a person who is, at the time of an eligible offer, a full or part-time employee and a senior manager of the Issuer;.
- 2. *Eligible offer* means an offer of a shadow equity payment to an eligible employee for nil monetary consideration.
- 3. *Financial product advice* has the meaning given by section 766B of the Act.
- 4. *General advice* has the meaning given by section 766B of the Act.
- 5. *Earned Income Report* has the meaning given in the Rules of the Plan.
- 6. Offer has a meaning affected by section 1010C of the Act.
- 7. *Offer document* means a document setting out an offer under the Plan that:
 - (a) includes or is accompanied by a copy of the Rules of the Plan;
 - (b) details the events upon which a shadow equity payment will be payable to an eligible employee and date of payment;
 - (c) outlines how the cash payment under a shadow equity payment will be calculated;
 - (d) details the conditions of the shadow equity payment; and
 - (e) includes an undertaking that the Issuer will take all reasonable steps to ensure an eligible employee that accepts an eligible offer is provided with the Earned Income Report each month until the date of payment of the shadow equity payment.
- 8. *Plan* means an employee incentive scheme that is known as at the date of this instrument as the Elkington Bishop Molineaux Insurance Brokers Pty Ltd Shadow Equity Plan where the scheme is:
 - (a) extended only to eligible employees; and
 - (b) governed by the Rules of the Plan.
- 9. *Rules of the Plan* means the written terms of the Plan that are substantially the same as the written terms provided to ASIC on 15 September 2009.
- 10. **Senior manager** means a person (other than a director or secretary of the Issuer) who:

- (a) makes, or participates in making, decisions that affect the part of the business of the Issuer in which the person undertakes their employment activities as at the date of the eligible offer; and
- (b) has the capacity to affect significantly the financial standing of the part of the business of the Issuer in which the person undertakes their employment activities as at the date of the eligible offer
- 11. **Shadow equity payment** means a cash payment to an eligible employee in accordance the Rules of the Plan which is calculated by reference to the income of the part of the business of the Issuer in which the eligible employee undertakes their employment activities as at the date of the eligible offer.

Under paragraph 911A(2)(l) of the *Corporations Act 2001* (the *Act*) the Australian Securities and Investments Commission (*ASIC*) exempts the person referred to in Schedule A from the requirement to hold an Australian financial services licence in the case referred to in Schedule B.

Schedule A

KKR Capital Markets LLC (the body) where all of the following apply:

- (a) the body is a registered broker dealer that is a member of the Securities Investor Protection Corporation established under the Securities Investor Protection Act of 1970 of the US, and
 - (i) is a member of the Financial Industry Regulatory Authority (FINRA); and
 - (ii) the FINRA is the body's examining authority; and
- (aa) the body is a body corporate incorporated in the State of Delaware in the US; and
- (b) the body:
 - (i) is registered under Division 2 of Part 5B.2 of the Act; or
 - (ii) has not failed for more than the last 10 business days to have an Agent; and
- (c) the body's primary business is the provision of financial services; and
- (d) neither the body nor its Agent has been notified by ASIC that the body is excluded from relying on this instrument; and
- (e) if the body becomes aware or should reasonably have become aware of matters that give it reason to believe that it has failed, other than in an immaterial respect, to comply with a requirement set out in Schedule C:
 - (i) 15 business days have not passed since the body became so aware or should reasonably have become so aware without the body providing full particulars of the failure to ASIC (to the extent that the body knows those particulars or would have known them if it had undertaken reasonable enquiries); and
 - (ii) 30 business days have not passed from ASIC receiving those particulars from the body without ASIC notifying the body that it may continue to rely on this instrument; and
- (f) the body has not notified ASIC that it will not rely on this instrument.

Schedule B

Where:

- 1. The body provides any of the following financial services (the *financial services*) in this jurisdiction to wholesale clients:
 - (a) providing financial product advice;
 - (b) dealing in a financial product;
 - (c) making a market for a financial product; or
 - (d) providing a custodial or depository service;

in respect of any of the following financial products:

- (e) derivatives;
- (f) foreign exchange contracts;
- (g) securities;
- (h) debentures, stocks or bonds issued by a government; or
- (i) interests in a managed investment scheme that is not required to be registered under Chapter 5C of the Act; and
- 2 the body has provided ASIC with:
 - (a) evidence that paragraph (a) of Schedule A is satisfied that ASIC has stated in writing is adequate; and
 - (b) a notice that it will provide financial services in this jurisdiction in reliance on this instrument; and
 - (c) a deed of the body for the benefit of and enforceable by ASIC and other persons referred to in subsection 659B(1) of the Act that applies notwithstanding that the body may have ceased to rely, or never have relied, on this instrument, which deed provides that:
 - (i) the deed is irrevocable except with the prior written consent of ASIC; and
 - (ii) the body submits to the non-exclusive jurisdiction of the Australian courts in legal proceedings conducted by ASIC (including under section 50 of the *Australian Securities and Investments Commission Act 2001* (the *ASIC Act*)) and, in relation to proceedings relating to a financial services law, by any person referred to in subsection 659B(1) of the Act and whether brought in the name of ASIC or the Crown or otherwise; and
 - (iii) the body covenants to comply with any order of an Australian court in respect of any matter relating to the provision of the financial services; and
 - (iv) if the body is not registered under Division 2 of Part 5B.2 of the Act, service of process on the body in relation to legal proceedings conducted by ASIC (including under section 50 of the ASIC Act) and, in relation to proceedings relating to a

- financial services law, by any person referred to in subsection 659B(1) of the Act and whether brought in the name of ASIC or the Crown or otherwise can be effected by service on the Agent; and
- (v) the body covenants that, on written request of either the SEC or ASIC, it will give or vary written consent and take all other practicable steps to enable and assist the SEC to disclose to ASIC and ASIC to disclose to the SEC any information or document that the SEC or ASIC has that relates to the body; and
- (d) written consents to the disclosure by the SEC to ASIC and ASIC to the SEC of any information or document that the SEC or ASIC has that relates to the body. The consents must be in such form (if any) as ASIC specifies in writing.

Schedule C

- 1. The body must provide each of the financial services in this jurisdiction in a manner which would comply, so far as is possible, with the US regulatory requirements if the financial service were provided in the US in like circumstances.
- 2. The body must:
 - (a) notify ASIC, as soon as practicable and in such form if any as ASIC may from time to time specify in writing, of the details of:
 - (i) each significant change to, including the termination of, the registration as a registered broker dealer applying to the body relevant to the financial services the body provides or intends to provide in this jurisdiction; and

 - (b) under section 12(2)(c) in relation to the affairs of Mesa

one or more of the following exist:

- (c) Mr Xie is associated with Auvex
- (d) Mr Xie is associated with Mr Premjit Roy and Mr Roy controls Auvex or
- (e) Mr Xie is associated with Mr Roy and companies that together own or control more than 20% of Auvex are owned or controlled by Mr Xie or Mr Roy or by persons associated with Mr Xie and/or Mr Roy.
