**Australian Securities and Investments Commission
Corporations Act 2001 — Paragraphs 911A(2)(l), 992B(1)(a) and 1020F(1)(a) —
Exemptions**

Enabling legislation

1. The Australian Securities and Investments Commission (*ASIC*) makes this instrument under paragraphs 911A(2)(l), 992B(1)(a) and 1020F(1)(a) of the *Corporations Act 2001* (the *Act*).

Title

2. This instrument is ASIC Instrument [10-0323].

Commencement

3. This instrument commences on the date of its gazettal.

Exemptions

4. Incard Pty Ltd ACN 132 641 653 (*Incard*), who provides financial services in relation to a Combined Facility, does not have to comply with subsection 911A(1), section 992A and Part 7.9 of the Act in relation to those financial services.
5. The exemptions in paragraph 4 are not available to Incard if it does not comply with the conditions in paragraph 6 or 7.

Conditions

6. Incard must take reasonable steps to ensure all of the following are satisfied:
 - (a) before or at the time the Combined Facility is offered to a person as a retail client, the person is given a written document (the *disclosure document*) which sets out the terms and conditions of the Combined Facility and separately sets out in a prominent manner:
 - (i) information about whether any of the terms and conditions of the facility may be unilaterally varied by the issuers and a statement of how a person (the *client*) who holds the Combined Facility may get information about the new terms and conditions;
 - (ii) information about whether there is a date (the *expiry date*) after which the Combined Facility cannot be used for the making of non-cash payments (regardless of whether there is an amount standing to the credit of the facility at the end of the relevant day) and information about where the expiry date may be found out;

- (iii) information about the procedures for dealing with any unauthorised or mistaken transactions relating to the Combined Facility or the loss or theft of the device (if any) referred to in subparagraph (c)(i);
 - (iv) fees or charges for acquiring and using the Combined Facility and where any such fees or charges are subject to change during the life of the Combined Facility, a statement of how the client may get information about the new fees or charges;
 - (v) the name and contact details of Incard and ANZ Banking Group Limited ACN 005 357 522 (*ANZ*), as the joint issuers of the Combined Facility;
 - (vi) information about the different roles of Incard and ANZ, as the joint issuers of the Combined Facility;
 - (vii) information about the internal dispute resolution processes relevant to each facility component of the Combined Facility and how they can be accessed by a client;
- (b) the disclosure document is worded and presented in a clear, concise and effective manner;
- (c) where the Combined Facility is subject to an expiry date:
- (i) if the client is provided with a physical device to use the Combined Facility — the expiry date is prominently set out on the device in a manner that makes it clear that it is an expiry date;
 - (ii) otherwise — the expiry date is set out in the disclosure document or in a written statement that is attached to the disclosure document;
- (d) a convenient means is available, that involves no charge by the issuers or their associates, for the client to do all of the following:
- (i) check the amount standing to the credit of the Combined Facility;
 - (ii) if subparagraph (c)(ii) applies — check any relevant expiry date that applies to the Combined Facility;
 - (iii) obtain at reasonable intervals a record of the past 10 transactions (or such transactions that have occurred) under the Combined Facility;
- (e) if the terms and conditions of the Combined Facility are unilaterally varied, or the fees or charges for using the Combined Facility are changed during the life of the Combined Facility:
-

- (i) information about the variation or change is made available to the client in accordance with the statement in subparagraph 6(a)(i) or 6(a)(iv);
 - (ii) the new terms and conditions or fees and charges are made available to the client on request at each place of business where the Combined Facility may be acquired; and
 - (iii) if the issuers make available information about the Combined Facility on an Internet website — information about the variation or change, and the new terms and conditions or fees and charges are made available on the website in a manner reasonably likely to come to the attention of persons seeking information about the Combined Facility;
- (f) if a Combined Facility is issued to a person as a retail client, the issuers maintain adequate internal dispute resolution processes in accordance with the Australian Standard on Complaints Handling (AS ISO 10002-2006) as at 5 April 2006;
7. Incard gives ASIC notice in writing when the Combined Facility ceases to be a low value non-cash payment facility.

Interpretation

8. In this instrument:

Combined Facility means a facility comprised of two component facilities, a low value non-cash payment facility and a loyalty scheme.

debit card has the meaning given by subsection 12DL(5) of the *Australian Securities and Investments Commission Act 2001*.

device includes a certificate, voucher, token, card, coin or other object by which a person may use a low value non-cash payment facility.

facility has a meaning affected by section 762C of the Act.

issuer has the meaning given by subsection 761E(4) of the Act.

low value non-cash payment facility means a facility through which, or through the acquisition of which, a person makes non-cash payments and in relation to which the following are satisfied:

- (a) the total amount available for the making of non-cash payments under all facilities of the same class held by any person at any one time does not exceed \$1,000;

- (b) the total amount available for making non-cash payments under all facilities of the same class does not exceed \$10,000,000 at any time;
- (c) the facility is a debit card that can be used to make payments through the Mastercard payment system; and
- (d) the facility is issued by ANZ.

loyalty scheme means a facility through which, or through the acquisition of which, a person makes non-cash payments in relation to which all of the following apply:

- (a) the facility is issued as part of a scheme the sole or main purpose of which is to promote the purchase of goods from, or the use of the services of, the issuer of the facility or another person;
- (b) a person who holds the facility is allocated credits (however described and whether or not a monetary value is expressly attributed to the credits) as a result of the purchase of goods from, or the use of the services of, the issuer of the facility or the other person;
- (c) the credits allocated under the facility can be used to make a payment or part payment for goods or services or to obtain some other benefit; and
- (d) the facility is issued by Incard.

makes non-cash payments has the meaning given by section 763D of the Act.

offer has a meaning affected by subsection 1010C(2) of the Act.

retail client has the meaning given by section 761G of the Act.

**Australian Securities and Investments Commission
Corporations Act 2001 – Paragraph 741(1)(a) – Exemption**

Under paragraph 741(1)(a) of the *Corporations Act 2001* (the *Act*), the Australian Securities and Investments Commission exempts the person specified in Schedule A from subsection 734(2) of the Act in the case specified in Schedule B.

Schedule A

Australian Property Custodian Holdings Ltd ACN 095 474 436 (*APCH*) in its capacity as the responsible entity of The Prime Retirement and Aged Care Property Trust ARSN 097 514 746 (*Prime Trust*).

Schedule B

1. APCH sends a notice of general meeting and explanatory material to members of Prime Trust by no later than 30 September 2010 that includes proposed resolutions that permit the following:

- (a) that an interest in Prime Trust be stapled to a share in Prime Retirement and Aged Care Management Limited ACN 141 678 668 ("NewCo") so that under the terms on which the interest is to be traded, an interest in Prime Trust must be transferred together with a share in NewCo (a *Stapled Security*); and
- (b) that APCH will offer to issue an interest in Prime Trust as part of an offer by APCH and Newco to issue Stapled Securities,

provided that such notice need only include the resolutions that permit the actions referred to in subparagraph (1)(b) if the board of APCH has resolved to conduct such an offer prior to sending the notice.

2. APCH makes one or more announcements to ASX Limited ACN 008 624 691 by no later than 30 September 2010 in relation to either or both of the following:

- (a) an offer of shares in NewCo to members of Prime Trust; or
- (b) an offer of Stapled Securities.

**Australian Securities and Investments Commission
Corporations Act 2001 – Paragraphs 911A(2)(l), 926A(2)(a), 951B(1)(a),
992B(1)(a) and 1020F(1)(a) - Exemptions**

Licensing relief

1. Under paragraph 911A(2)(l) of the *Corporations Act 2001 (the Act)*, the Australian Securities and Investments Commission (*ASIC*) exempts Lloyds TSB Bank plc (a public limited company incorporated in the United Kingdom on 20 April 1865) (*Lloyds TSB*) from the requirement to hold an Australian financial services licence for the provision of a financial service in the case referred to in Schedule A.
2. Under paragraph 926A(2)(a) of the Act, ASIC exempts Lloyds TSB from Divisions 3, 6 and 10 of Part 7.6 of the Act to the extent that those Divisions apply in relation to the provision of a financial service that is covered by the exemption in paragraph 1 of this instrument.

Disclosure and conduct relief

3. Under paragraphs 951B(1)(a), 992B(1)(a) and 1020F(1)(a) of the Act, ASIC exempts Lloyds TSB from:
 - (a) Divisions 1, 2, 3 and 4 of Part 7.7 of the Act; and
 - (b) Divisions 2, 3, 4, 4A, 5, 6 and 7 of Part 7.8 of the Act; and
 - (c) Divisions 2, 3, 4 and 5 of Part 7.9 of the Act,to the extent that those Divisions apply in relation to the provision of a financial service that is covered by the exemption in paragraph 1 of this instrument.

Schedule A

Where Lloyds TSB provides a financial service to a retail client and each of the following circumstances is met:

1. Lloyds TSB provides the financial service from premises that are not in this jurisdiction; and
2. the retail client is in this jurisdiction; and
3. the financial service relates to a financial product:
 - (a) issued by Lloyds TSB following an application by, or inquiry from, the retail client; or

- (b) issued by Lloyds TSB and acquired by the retail client when the retail client was not in this jurisdiction; or
 - (c) that supplements a financial product mentioned in paragraphs (a) or (b); or
 - (d) that is of the same kind as, and is issued in substitution for, a financial product mentioned in paragraphs (a) or (b); and
4. Lloyds TSB did not actively solicit the retail client or any other retail clients in this jurisdiction in relation to the financial products mentioned in paragraphs (3)(a) to (d).

Note: Paragraph 4 does not preclude Lloyds TSB from contacting the retail client in relation to the financial products mentioned in paragraphs 3(a) to (d) after they have been acquired by the retail client.

In this instrument:

retail client has the meaning given in section 761G of the Act.

Enabling legislation

1. The Australian Securities and Investments Commission (*ASIC*) makes this instrument under subsection 601QA(1) of the *Corporations Act 2001* (the *Act*).

Title

2. This instrument is ASIC Instrument 10-0365.

Exemption

3. ASIC exempts Becton Investment Management Limited ACN 090 939 192 (the *Responsible Entity*) in its capacity as the responsible entity of

- (a) Becton Diversified Property Fund ARSN 117 509 921;
- (b) Becton Office Fund ARSN 106 453 196;
- (c) Becton Retail Fund ARSN 107 250 420; and
- (d) Becton Industrial Fund ARSN 099 680 252

(each, a *Scheme*),

from paragraph 601FC(1)(d) of the Act in relation to allowing a member of the Scheme to withdraw in accordance with section 601KEA of the Act as inserted by this instrument.

Declaration

4. ASIC declares that Chapter 5C of the Act applies to the Responsible Entity in its capacity as the responsible entity of the Scheme in the case specified in the Schedule as if Part 5C.6 of the Act were modified or varied as follows:

- (1A) In this section, an *operator* means a person who is a member of the Scheme in its capacity as responsible entity or custodian of a registered scheme, trustee of a trust, trustee or custodian of a superannuation entity within the meaning of the *Superannuation Industry (Supervision) Act 1993*, trustee of a self-managed superannuation fund within the meaning of the *Superannuation Industry (Supervision) Act 1993* or provider or acquirer in relation to a custodial arrangement as defined in section 1012IA.
- (2) The responsible entity must not allow a hardship withdrawal unless the responsible entity is satisfied that:
- (a) following that withdrawal the scheme property would include sufficient liquid assets for the day to day operation of the scheme; and
 - (b) satisfying the hardship withdrawal request:
 - (i) would not result in more than 4 hardship withdrawals for any member, instructor or beneficiary (as applicable) in any calendar year; and
 - (ii) would not result in the total amount of withdrawals for any member, instructor or beneficiary (as applicable) in any calendar year exceeding \$100,000; and
 - (c) any amount paid would not exceed the specific amount the subject of a hardship withdrawal request in respect of the hardship of the member, instructor or beneficiary (as applicable); and
 - (d) where paragraph (1)(b) applies—any amount paid on withdrawal to an operator will be paid to the instructor after deduction of any fees and charges payable to the operator; and

Note: In making any payment to an instructor, an operator must comply with any obligations under the terms of the relevant trust or arrangement under which it acts and other applicable laws. For example, the responsible entity of a registered scheme must comply with Part 5C.6 as modified by any relief applicable to that scheme and the trustee of a superannuation entity or self managed superannuation fund must comply with requirements under the *Superannuation Industry (Supervision) Act 1993*.

(e) where paragraph (1)(c) applies—any amount paid on withdrawal to an executor or administrator of the estate will be paid to the beneficiary after deduction of any fees and charges payable to the executor or administrator.

(3) If a constitution includes a provision permitting the responsible entity to exercise a discretion in relation to a hardship withdrawal the responsible entity must comply with subsections (4) to (6).

Exercise of discretion must be reasonable

(4) The responsible entity or its nominee must act reasonably in exercising a discretion covered by subsection (3).

Note: The responsible entity is also subject to its general duties under section 601FC including the duty to act in the best interests of the members of the scheme.

Documentation of exercise of discretion

(5) The responsible entity must ensure that the records which it keeps under section 988A document how and why a decision to permit or refuse a hardship withdrawal was made.

Access to and retention of documents

(6) The responsible entity must retain the documents covered by subsection (5) for 7 years after they cease to be current.”

Schedule

Where a decision by the Responsible Entity to allow withdrawal from the Scheme is based on the following criteria and conditions:

	<u>Hardship Withdrawal Criteria</u>	<u>Condition</u>
