**Australian Securities and Investments Commission
Corporations Act 2001 – Paragraph 1020F(1)(c) – Declaration**

Under paragraph 1020F(1)(c) of the *Corporations Act 2001* (the *Act*), the Australian Securities and Investments Commission (*ASIC*) declares that Division 2 of Part 7.9 of the Act applies to the person specified in Schedule A in the case referred to in the Schedule B as if the following provisions were modified or varied by:

1. omitting "." at the end of paragraph 1013H(c) and replacing it with "; or"; and
2. inserting a new paragraph 1013H(d) as follows:

"(d) an application of a kind referred to in paragraph (b) will be made to the operator of that market no later than 7 days of the date of the issue of the product";
3. omitting "." at the end of subsection 1016D(1)(b) and replacing it with "; or";
4. inserting a new paragraph 1016D(1)(c) as follows:

"(c) an application for quotation of the product has been made to the operator of that market no later than 7 days of the date of the issue of the product";
5. omitting paragraphs 1016D(2)(a) and (b);
6. inserting new paragraphs 1016D(2)(a) and (b) as follows:

"(a) an application for quotation of the product has not been made to the operator of that market for the taking of such action as is necessary to enable financial products of that kind to be traded on that market within 7 days of the relevant date or the date of issue of the product; or

(b) the product is not able to be traded on that market at the end of 3 months after the relevant date or the date of issue of the product";

7. inserting after the words "(see subsection (4))" in subparagraph 1016E(1)(b)(i) "or no later than 7 days after the date of the issue of the product"; and
8. inserting after the words "the relevant date" in subparagraph 1016E(1)(b)(ii) "or the date of issue of the product".

Russell Investment Management Ltd ACN 068 338 974 (the **Responsible Entity**) in its capacity as the responsible entity of the Russell High Dividend Australian Shares ETF ARSN 142 405 721 (the **Scheme**)

Schedule B

Where the Responsible Entity offers interests in the Scheme under a Product Disclosure Statement lodged with ASIC that discloses the full particulars of the issue of the financial product including:

**Australian Securities and Investments Commission
Corporations Act 2001 – Paragraph 601QA(1)(a) – Exemption**

Under paragraph 601QA(1)(a) of the *Corporations Act 2001* (the *Act*), the Australian Securities and Investments Commission (*ASIC*) hereby exempts the person referred to in Schedule A from paragraph 601FC(1)(d) of the Act in the case specified in Schedule B on the conditions set out in Schedule C and for so long as they are met.

Schedule A

Russell Investment Management Ltd ACN 068 338 974 (the *Responsible Entity*) in its capacity as the responsible entity of the Russell High Dividend Australian Shares ETF ARSN 142 405 721 (the *Scheme*).

Schedule B

Where:

1. only an Authorised Participant that is an Australian Resident is permitted to redeem units in the Scheme; or
2. the Responsible Entity is required under the Tax Act to withhold tax from a member because that member redeemed units in the Scheme; or
3. a member is restricted from receiving the Withdrawal Securities.

Schedule C

1. The Product Disclosure Statement for the Scheme lodged with ASIC discloses full particulars of the differential treatment that will apply to members:
 - (a) redeeming units from the Scheme in relation to withholding tax under the Tax Act; and
 - (b) who are not Australian Residents in respect of their inability to redeem units in the Scheme; and
 - (c) who are restricted from receiving the Withdrawal Securities.

2. Units in the ETF class of the Scheme remain admitted to Trading Status on the financial market operated by ASX Limited ACN 008 624 691.

Interpretation

 - (A) have been an Australian resident for the purposes of the Tax Act continuously from the beginning of the relevant financial year until that time; and
 - (B) will continue to be an Australian resident for the purposes of the Tax Act at all times from that time until the end of the relevant financial year; or
 - (ii) the Responsible Entity reasonably determines that the person or entity:
 - (A) is an Australian resident for the purposes of the Tax Act continuously from the beginning of the relevant financial year until that time; and
 - (B) will continue to be an Australian resident for the purposes of the Tax Act at all times from that time until the end of the relevant financial year;
- (b) the Responsible Entity, or any person who keeps records on behalf of the Responsible Entity, does not hold any records with an address for the person or entity which is outside Australia; and
- (c) the person or entity has not authorised the Responsible Entity to pay any amounts to the person or entity to a place or an account located outside Australia.

Authorised Participant means a Trading Participant as such term is defined in the ASX Market Rules who has entered into an authorised participant agreement with the Responsible Entity or such other person as the Responsible Entity determines.

ETF has the same meaning as defined in the ASX Market Rules as at the date of this instrument.



**Australian Securities and Investments Commission
Corporations Act 2001 – Subsections 655A(1) and 673(1) – Declarations**

1. Under paragraph 655A(1)(b) of the *Corporations Act 2001* (the *Act*), the Australian Securities and Investments Commission (*ASIC*) hereby declares that Chapter 6 of the Act applies to the person referred to in Schedule A in the case referred to in Schedule B as if section 609 of the Act were modified or varied by inserting after subsection 609(6) the following subsections:

"(6A) If a holder of an interest in an ETF:

 - (a) has a relevant interest in a security arising from the facility offered by the responsible entity of the ETF to redeem interests in the ETF; and
 - (b) has no power to control voting or disposal of the security other than if the interest in the ETF is redeemed,

that particular relevant interest in the security shall be disregarded until the interest in the ETF is redeemed.

(6B) If a holder or former holder of an interest in an ETF has a relevant interest in, a security because subsection (6A) ceases to apply, the holder or former holder is taken to acquire the security at that time, by a transaction in relation to the security.

(6C) For the purposes of subsections (6A) and (6B):

 - (a) *ETF* has the same meaning as defined in the ASX Market Rules as at the date of this instrument.
 - (b) "*a holder of an interest in an ETF*" means a person who has a relevant interest in an ETF."
 2. Under section 673(1)(b) of the Act, ASIC declares that Chapter 6C of the Act applies to the person described in Schedule A in the case referred to in Schedule B as if section 671B of the Act were modified or varied by inserting after subsection 671B(7) the following subsection:

"(7A) For the purposes of this section and of the definition of "substantial holding" in section 9, disregard any relevant interest in securities which is disregarded for the purposes of Chapter 6 because of subsection 609(6A) to (6C)."

Schedule A

A person who has a relevant interest in or voting power in relation to the underlying securities held by a Russell ETF.

Schedule B

The calculation of the relevant interest in, or voting power in relation to, the securities of the persons described in Schedule A where:


1. the responsible entity of the Russell ETF has a principal investment strategy of investing in the constituent securities of the Russell Australia High Dividend Index in proportion to those securities' relative weightings in the index;



**Australian Securities and Investments Commission
Corporations Act 2001 — Paragraphs 601QA(1)(a), 911A(2)(l)
and 1020F(1)(a) — Exemption**

Under paragraphs 601QA(1)(a), 911A(2)(l) and 1020F(1)(a) of the *Corporations Act 2001* (the *Act*) the Australian Securities and Investments Commission (*ASIC*) exempts:

1. An Issuer who operates a managed investment scheme by reason of operating a Sale Facility or Related Purchase Facility does not have to comply with:
 - (a) section 601ED of the Act in relation to the facility; and
 - (b) Divisions 2 to 5 of Part 7.9 of the Act in relation to an interest in the facility; and
 - (c) the requirement to hold an Australian financial services licence for the provision of the following financial services:
 - (i) dealing in an interest in the facility; and
 - (ii) the provision of general advice in relation to an interest in the facility.
2. To avoid doubt, an Issuer who invites a holder of a financial product of the Issuer to make an offer to sell the financial product through a Sale Facility does not have to comply with Division 5A of Part 7.9 of the Act.
3. An Issuer does not have to comply with paragraph 601FC(1)(d) of the Act to the extent that it would prevent the issuer from making a Sale Facility or a Related Purchase Facility available to a holder of a financial product which have an aggregate value of less than a specified amount.

Where relief applies

4. The exemptions in paragraphs 1, 2 and 3 apply in relation to a Sale Facility or Related Purchase Facility that satisfies all of the following:
 - (a) the financial products that may be sold or purchased (as applicable) through the facility are shares or interests in a managed investment scheme that are admitted to quotation on a licensed market or approved foreign market;
 - (b) under the terms of the Sale Facility:
 - (i) the financial products (the *relevant financial products*) of participating holders to be sold through the facility are pooled; and
 - (ii) a broker sells the relevant financial products in the ordinary course of trading on the relevant market; and
 - (iii) the proceeds of the sale net of expenses (to the extent (if any) that they are not met by the Issuer) are distributed to participating holders; and
 - (iv) each participating holder is paid their proportion of the proceeds of sale as soon as practicable and, in any event, within 8 weeks after the date on

which the Issuer received the participating holder's election to participate in the facility;

(c) where the facility is a Related Purchase Facility—under the terms of the facility:

- (i) the money of the participating holders to be used to purchase financial products through the facility is pooled; and
- (ii) a broker purchases the financial products in the ordinary course of trading on the relevant market; and
- (iii) the broker may deduct from the money referred to in subparagraph (i) expenses of purchasing the financial products (to the extent (if any) that they are not met by the issuer); and
- (iv) each participating holder is allocated their proportion of the financial products purchased; and
- (v) each participating holder has transferred to them the financial products allocated to them as soon as practicable and, in any event, within 8 weeks after the date on which the issuer received the participating holder's election to participate in the facility; and
- (vi) each participating holder may purchase financial products through the facility (aggregated with financial products of the same class that were purchased through any previous facility) for consideration totalling no more than \$5,000 in any consecutive 12 month period.

Conditions of the relief

5. An Issuer relying on the exemptions in subparagraphs 1(a) or (b) or paragraph 2 must:

(a) give or send to each holder of financial products of the Issuer who has been invited to participate in the facility, a document which complies with paragraph 6 by:

- (i) giving the document to the holder personally; or
- (ii) sending the document:

(A) by post to the address for the holder in the register of members or an alternative address (if any) nominated by the holder; or

(B) to the fax number or electronic address (if any) nominated by the holder; and

(b) take reasonable steps to ensure the facility is not operated during any period where a control transaction has been publicly proposed and has not ended.

- (c) take reasonable steps to ensure that where a Related Purchase Facility is made available in conjunction with a Sale Facility, a participating holder can only participate in either, but not both, of the facilities.

6. The document:

- (a) must contain the following statements and information:

- (i) a statement that the facility is open until the expiry date set out in the document, which cannot be more than 12 months after the date of the document; and
- (ii) information about the minimum and maximum number (if any) of financial products a participating holder can sell or purchase through the facility; and
- (iii) a statement that the market price of financial products is subject to change from time to time; and
- (iv) information about how to obtain up-to-date information on the market price of the financial product; and
- (v) information about any expenses relating to the sale or purchase of financial products that will be paid by the participating holders; and
- (vi) information about:
 - (A) for a Sale Facility – how the proceeds of sale for financial products sold through the facility will be allocated between participating holders; and
 - (B) for a Related Purchase Facility – how the financial products purchased through the facility will be allocated between participating holders; and
- (vii) a statement that:
 - (A) for a Sale Facility – the amount of money received by a participating holder for a financial product that is sold through the facility may be more or less than the actual price that is received by the broker for that financial product; and
 - (B) for a Related Purchase Facility – the amount of money that is paid by a participating holder for a financial product that is acquired through the facility may be more or less than the actual consideration that is paid by the broker for that financial product
- (viii) information about any other significant characteristics or features of the facility or of the rights and obligations of holders who elect to participate in the facility; and
- (ix) information about any alternatives that the holder may have to participating in the facility; and

- (b) must be worded and presented in a clear, concise and effective manner; and
- (c) may be given in printed or electronic form and, if given in electronic form, must, as far as practicable, be given in a way that will allow the holder to print or save a copy of it; and
- (d) may be made up of 2 or more separate documents that are given at the same time and by the same means.

Exclusion from reliance

7. An Issuer is excluded from relying on paragraph 1(c) of this instrument if it becomes aware of matters that give it reason to believe that it has failed in a material respect to comply with a condition of this instrument and does not give full particulars of the failure to ASIC in writing within 15 business days after becoming so aware.

Interpretation

8. In this instrument:

- (o) Tokyo Stock Exchange; and

(p) Toronto Stock Exchange.

broker means a participant of a licensed market or approved foreign market with whom the Issuer has entered arrangements for the operation of the Sale Facility or Related Purchase Facility.

control transaction means a transaction or proposed transaction that affects the control, or potential control, of:

- (a) where the financial products are shares—the Issuer; or
- (b) where the financial products are interests in a managed investment scheme—the managed investment scheme to which those interests relate.

facility has a meaning affected by section 762C of the Act.

holder has the meaning given by section 761A of the Act.

Issuer means

- (a) Australand Holdings Limited ACN 008 443 696 (**AHL**)
- (b) Australand Property Limited ACN 105 462 137 as responsible entity of Australand Property Trust ARSN 106 680 424 (**APT**)
- (c) Australand Investments Limited ACN 086 673 092 (**AIL**) as responsible entity of Australand Property Trust No. 4 ARSN 108 254 413 (**APT 4**)
- (d) AIL as responsible entity of Australand Property Trust No. 5 ARSN 108 254 771 (**APT 5**)

licensed market has the meaning given by section 761A of the Act.

participating holder means a person who:

- (a) holds a financial product in the same class of financial products as those to which the facility relates; and
- (b) has elected to participate in the facility.

register of members means:

- (a) in relation to a company or registered scheme—the register of members required to be set up and maintained under section 169 of the Act; and
- (b) in relation to a foreign company—the register of members (however described) required to be kept under the laws of its place of origin.

Related Purchase Facility means a facility made available in conjunction with the Sale Facility through which participating holders holding no more than 2,000 Stapled Securities at the time the facility is made available, can purchase Stapled Securities.


Sale Facility means a facility through which participating holders holding no more than 2,000 Stapled Securities at the time the facility is made available, can sell Stapled Securities.

Stapled Security means shares in AHL and interests in APT, APT 4 and APT 5, and under the terms of trade these may only be traded together.

9. If a share or interest must under the terms on which it is traded only be transferred together with one or more other shares or interests or other financial products:
- (a) the share or interest is taken to be quoted on a licensed financial market;
 - (b) a reference in this instrument to:
 - (i) a financial product is taken to be to a reference to a stapled security; and
 - (ii) an issuer is taken to be a reference to any issuer of a financial product which comprises part of a stapled security.

Corporations Act 2001 — Paragraphs 601QA(1)(a), 911A(2)(l), 926A(2)(a), 926A(2)(c)
and 1020F(1)(a) — Revocation, Declaration and Exemption**

Revocation

Under paragraphs 601QA(1)(a), 911A(2)(l) and 1020F(1)(a) of the *Corporations Act 2001* (the *Act*) the Australian Securities and Investments Commission (*ASIC*) revokes ASIC Instrument [10-0330] dated 3 May 2010 and signed by Francis Fung.

Declaration

Under paragraph 926A(2)(c) of the Act, ASIC declares that Part 7.6 of the Act (other than Divisions 4 and 8) applies in relation to the Issuer as if paragraph 911B(1)(e) were omitted and the following paragraph substituted:

“(e) if the principal (rather than the provider) provided the service, the principal would not need an Australian financial services licence because:

- (i) the provision of the service would be exempt under subsection 911A(2); or
- (ii) the principal would be exempt from subsection 911A(1) in relation to the service as a result of an exemption under subsection 926A(2)(a).”

Exemption

Under paragraphs 601QA(1)(a), 926A(2)(a) and 1020F(1)(a) of the Act, ASIC exempts:

1. An Issuer who operates a managed investment scheme by reason of operating a Sale Facility or Related Purchase Facility does not have to comply with:
 - (a) section 601ED of the Act in relation to the facility; and
 - (b) Divisions 2 to 5 of Part 7.9 of the Act in relation to an interest in the facility; and
 - (c) the requirement to hold an Australian financial services licence for the provision of the following financial services:
 - (i) dealing in an interest in the facility; and
 - (ii) the provision of general advice in relation to an interest in the facility.
2. To avoid doubt, an Issuer who:
 - (a) invites a holder of a financial product of the Issuer to make an offer to sell the financial product through a Sale Facility; or
 - (b) invites a holder of a financial product of the Issuer to make an offer to purchase additional financial products through a Related Purchase Facility.does not have to comply with Division 5A of Part 7.9 of the Act.
3. An Issuer does not have to comply with paragraph 601FC(1)(d) of the Act to the extent that it would prevent the issuer from making a Sale Facility or a Related Purchase Facility available to a holder of a financial product which have an aggregate value of less than a specified amount.

Where relief applies

4. The exemptions in paragraphs 1, 2 and 3 apply in relation to a Sale Facility or Related Purchase Facility that satisfies all of the following:
- (a) the financial products that may be sold or purchased (as applicable) through the facility are shares or interests in a managed investment scheme that are admitted to quotation on a licensed market or approved foreign market;
 - (b) under the terms of the Sale Facility:
 - (i) the financial products (the *relevant financial products*) of participating holders to be sold through the facility are pooled; and
 - (ii) a broker sells the relevant financial products in the ordinary course of trading on the relevant market; and
 - (iii) the proceeds of the sale net of expenses (to the extent (if any) that they are not met by the Issuer) are distributed to participating holders; and
 - (iv) each participating holder is paid their proportion of the proceeds of sale as soon as practicable and, in any event, within 8 weeks after the date on which the Issuer received the participating holder's election to participate in the facility;
 - (c) where the facility is a Related Purchase Facility—under the terms of the facility:
 - (i) the money of the participating holders to be used to purchase financial products through the facility is pooled; and
 - (ii) a broker purchases the financial products in the ordinary course of trading on the relevant market; and
 - (iii) the broker may deduct from the money referred to in subparagraph (i) expenses of purchasing the financial products (to the extent (if any) that they are not met by the issuer); and
 - (iv) each participating holder is allocated their proportion of the financial products purchased; and
 - (v) each participating holder has transferred to them the financial products allocated to them as soon as practicable and, in any event, within 8 weeks after the date on which the issuer received the participating holder's election to participate in the facility; and
 - (vi) each participating holder may purchase financial products through the facility (aggregated with financial products of the same class that were purchased through any previous facility) for consideration totalling no more than \$5,000 in any consecutive 12 month period.

Conditions of the relief

5. An Issuer relying on the exemptions in subparagraphs 1(a) or (b) or paragraph 2 must:

6. The document:

- (ix) information about any alternatives that the holder may have to participating in the facility; and
- (b) must be worded and presented in a clear, concise and effective manner; and
- (c) may be given in printed or electronic form and, if given in electronic form, must, as far as practicable, be given in a way that will allow the holder to print or save a copy of it; and
- (d) may be made up of 2 or more separate documents that are given at the same time and by the same means.

Exclusion from reliance

7. An Issuer is excluded from relying on paragraph 1(c) of this instrument if it becomes aware of matters that give it reason to believe that it has failed in a material respect to comply with a condition of this instrument and does not give full particulars of the failure to ASIC in writing within 15 business days after becoming so aware.

- (a) where the financial products are shares—the Issuer; or
- (b) where the financial products are interests in a managed investment scheme—the managed investment scheme to which those interests relate.

facility has a meaning affected by section 762C of the Act.

holder has the meaning given by section 761A of the Act.



from paragraph 601FC(1)(d) of the Act in relation to allowing Colonial to pay some or all of the net proceeds of the winding up of each Scheme to members in the case specified in Schedule A on the conditions specified in Schedule B.

Variation

4. ASIC varies ASIC Instrument number 09-00769 by:
 - (a) in the definition of "CFS Scheme" under the heading "Interpretation" – deleting "Colonial First State Mortgage Income Fund – Entry Fee Option ARSN 088 902 783;" and the preceding bullet point;

Schedule B

1. Colonial must not allow a hardship payment to be made unless Colonial is satisfied that:
 - (a) following that payment, the scheme property would include sufficient liquid assets to enable Colonial to satisfy its obligations under the constitution of the Scheme in relation to the winding up of the Scheme; and

- (b) satisfying the request for a hardship payment:
- (i) would not result in more than 4 hardship payments for any member, instructor or beneficiary (as applicable) in any calendar year; and
 - (ii) would not result in the total amount of hardship payments for any member, instructor or beneficiary (as applicable) in any calendar year exceeding \$100,000; and

2. If a constitution includes a provision permitting the responsible entity to exercise a discretion in relation to a hardship payment, Colonial must comply with paragraphs (3) to (5).
 3. Colonial or its nominee must act reasonably in exercising a discretion covered by paragraph (2).
 4. The responsible entity must ensure that the records which it keeps under section 988A document how and why a decision to permit or refuse a request for a hardship payment.

Exemption

2. Patersons Securities Limited ACN 008 896 311 (*Patersons*) or an authorised representative of Patersons, each a *providing entity*, does not have to comply with section 946C of the Act to the extent that it requires the providing entity to give a person (the *client*) a Statement of Advice any earlier than 21 days after providing personal advice (the *further advice*) to the client relating to securities admitted to quotation on a financial market operated by ASX Limited ACN 008 624 691.

Where relief applies

3. The exemption in paragraph 2 may only be relied on where:
 - (a) the client was a client of RBS Morgans Limited ACN 010 669 726 (*RBS Morgans*), or an authorised representative of RBS Morgans, on 30 April 2010; and
 - (b) the further advice is provided before 1 July 2010; and
 - (c) where either of the following apply:
 - (i) where:
 - (A) RBS Morgans, or an authorised representative of RBS Morgans, has before 1 May 2010, given the client a Statement of Advice that sets out the client's relevant personal circumstances in relation to the advice (the *previous advice*) set out in that Statement; and
 - (B) the client's relevant personal circumstances in relation to the further advice (determined having regard to the client's objectives, financial situation and needs as known to the providing entity at the time of providing the further advice) are not significantly different from the client's relevant

personal circumstances in relation to the previous advice;
and

- (C) so far as the basis on which advice is given relates to other matters – the basis on which the further advice is given is not significantly different from the basis on which the previous advice was given;

(ii) where:

- (A) the client had a relationship with RBS Morgans, or a person acting on behalf of RBS Morgans, before 10 March 2004; and
 - (B) RBS Morgans, or a person acting on behalf of RBS Morgans, gave the client advice (the *earlier advice*) of a kind that if it were given after 10 March 2004 would be considered to be personal advice; and
 - (C) the client's relevant personal circumstances in relation to the further advice are not significantly different from the client's investment objectives, financial situation and particular needs that were determined for the earlier advice; and
 - (D) so far as the basis on which advice is given relates to other matters – the basis on which the further advice is given is not significantly different from the basis on which the earlier advice was given; and
- (d) the providing entity as soon as practicable, but no later than 5 days, after the further advice is provided, gives the client a statement in writing that the client may not receive a Statement of Advice in relation to the further advice until 21 days after the further advice is provided.

Condition

4. The providing entity must take all reasonable steps to give the client a Statement of Advice in relation to the further advice as soon as practicable after the further advice is provided.


