**Australian Securities and Investments Commission  
Corporations Act 2001 – Subsection 741(1) – Exemption & Declaration**

1. Under paragraph 741(1)(a) of the *Corporations Act 2001* (the *Act*) the Australian Securities and Investments Commission (*ASIC*) hereby exempts the person specified in Schedule A, in the case referred to in Schedule B, from compliance with Parts 6D.2 and 6D.3 of the Act.
  2. Under paragraph 741(1)(b) of the Act, ASIC hereby declares that Chapter 6D of the Act applies to the persons specified in Schedule C in the case referred to in Schedule D, as if section 707 were modified or varied by omitting subsections 707(2), (3), (4), (5) and (6) and substituting:
    - “(5) An offer of a body's securities for sale within 12 months after their sale by a person who controlled the body at the time of the sale needs disclosure to investors under this Part if:
      - (a) at the time of the sale by the controller either:
        - (i) the securities were not quoted; or
        - (ii) although the securities were quoted, they were not offered for sale in the ordinary course of trading on a relevant financial market on which they were quoted; and
      - (b) the controller sold the securities without disclosure to investors under this Part; and
      - (c) the controller sold the securities with the purpose of the person to whom they were sold:
        - (i) selling or transferring the securities; or
        - (ii) granting, issuing or transferring interests in, or options or warrants over the securities;
- and section 708 does not say otherwise.
- (6) Unless the contrary is proved, a person who controls a body is taken to sell securities with the purpose referred to in paragraph (5)(c) if any of the securities are subsequently sold, or offered for sale, within 12 months after their sale by the controller.”

    - (vii) settlement of a contract resulting from acceptance of the Invitation

*(Contract)* will not occur until Saleco has entered into a binding contract pursuant to an application for SMEC Shares under the IPO Prospectus for the sale or disposal of SMEC Shares to which the Contract relates, and a Contract will be rescinded if Saleco has not entered into a binding contract pursuant to an application for Shares under the IPO Prospectus for the sale or disposal of SMEC Shares to which the Contract relates within 3 months after the lodgment of the IPO Prospectus.

### Schedule C

1. SMEC and Saleco do all things necessary to ensure that the Invitation includes the following information:
  - (a) the indicative price range of SMEC Shares under contracts formed pursuant to applications for SMEC Shares made under the IPO Prospectus;
  - (b) the terms and conditions of the Invitation;
  - (c) Eligible Shareholders will be able to accept the Invitation at any time after receipt of the Invitation until 10 May 2010;
  - (d) Eligible Shareholders who accept the Invitation may withdraw their acceptance of the Invitation (either in its entirety or by reducing the number of SMEC shares to be sold or disposed of) within 14 days after the date of lodgment of the IPO Prospectus with ASIC;
  - (e) that Eligible Shareholders may be able to sell or dispose of their SMEC Shares following completion of the IPO at a price which is higher than the price which they would receive if they were to accept the Invitation;
  - (f) that the IPO Prospectus may contain information in addition to that already provided to Eligible Shareholders relevant to the decision whether to retain or sell SMEC Shares;
  - (g) the maximum number of SMEC Shares which Saleco will acquire pursuant to the Invitation and if this number depends on circumstances, how this maximum number will be determined;
  - (h) that, if the number of SMEC Shares in respect of which Eligible Shareholders accept the Invitation exceeds the maximum number referred to in paragraph (f), acceptances of the Invitation may be scaled back, and the basis on which acceptances of the Invitation would be scaled back;



- (1AB) Subsection (1AA) does not apply to a person if, at 9.30am on the fifth business day after the date on which shares are issued or transferred (as the case may be) under the disclosure document, the person has voting power of more than 5% in the company.”
