**Australian Securities and Investments Commission
Corporations Act 2001 — Paragraph 655A(1)(a) — Exemption**

Under paragraph 655A(1)(a) of the *Corporations Act 2001 (Act)*, the Australian Securities and Investments Commission (*ASIC*) exempts the persons specified in Schedule A (each, a *Broker*) in the case specified in Schedule B, to the extent and on the conditions set out below.

The Broker is exempt from section 606 of the Act in relation to the acquisition mentioned in Schedule B, on the following conditions:

- (a) the Broker reduces its voting power in TEN Network Holdings Limited ACN 081 327 068 (*Company*) to less than 20% within 14 days after that acquisition;
- (b) while the Broker's voting power in the Company is greater than 20% as a result of that acquisition, it does not exercise any voting rights attaching to the Shares in excess of 20% without ASIC's consent; and
- (c) in selling any Shares acquired under the relief, the Broker uses its best endeavours to obtain as wide a placement as practicable, for the highest practicable price.



Corporations Act 2001 — Subsection 741(1) — Declaration**

Under subsection 741(1) of the *Corporations Act 2001 (Act)*, the Australian Securities and Investments Commission (*ASIC*) hereby declares that Chapter 6D of the Act applies to the persons specified in Schedule A in the case specified in Schedule B as if:

1. subsection 707(5) of the Act were modified or varied by inserting the words “or 708A” after the words “section 708”;
2. section 708A of the Act were modified or varied by:
 - (a) after subsection (1) adding the following subsection:

“(1A) this section also applies to an offer (the *sale offer*) of a body’s securities (the *relevant securities*) for sale by a person if:

 - (a) but for subsection (5), disclosure to investors under this Part would be required by subsection 707(5) for the sale offer; and
 - (b) a determination under subsection (2) was not in force in relation to the body at the time when the relevant securities were sold.”
 - (b) in paragraph (5)(a) omitting the word “issued” and substituting the words “sold by the person who controlled the body (the *controller*)”;
 - (c) in paragraph (5)(e) omitting the words “a notice that complies with subsection (6)” and substituting the words “notices that comply with subsections (6) and (6A)”;
 - (d) omitting paragraphs (6)(a) and (6)(b) and substituting the following paragraphs:

“(a) is given by the body within 5 business days after the day on which the relevant securities were sold by the controller; and

(b) states that the controller sold the relevant securities without disclosure to investors under this Part; and”;
 - (e) after subsection (6) adding the following subsection:

“(6A) A notice complies with this subsection if the notice:

 - (a) is given by the controller within 5 business days after the day on which the relevant securities were sold by the controller; and

 - (c) sets out any information known by the controller that is excluded information as at the date of the notice (see subsections (7) and (8)).”;

 - (g) in paragraph (9)(a) omitting the word “the” and substituting the word “a”;
 - (h) in paragraph (9)(b) omitting the words “are issued” and substituting the words “are sold by the controller”;

- (i) after subsection (9) adding:
- “(9A) The controller contravenes this subsection if:
- (a) a notice given under subsection (5) is defective; and
 - (b) the controller becomes aware of the defect in the notice within 12 months after the relevant securities are sold by the controller and does not notify the body.”;

(j) in subsection (10) omitting the word “, the” and adding the words “and subsection (9A), a” after the words “subsection (9)”;

3. paragraph 713(6)(ab) of the Act were modified or varied by omitting the word “708A(9)” and substituting the words “, or subsection 708A(9) or (9A)”;

4. subsection 727(5) of the Act were modified or varied by omitting paragraph (5)(b) and substituting the following paragraph:

“(b) a notice given under that subsection purported to comply with subsection 708AA(7), subsection 708A(6) or 708A(6A), but did not actually comply with subsection 708AA(7), subsection 708A(6) or 708A(6A), as appropriate;”.



Exemption and Declaration**

1. Under paragraph 601QA(1)(a) of the *Corporations Act 2001 (Act)* the Australian Securities and Investments Commission (*ASIC*) exempts the person specified in Schedule A from compliance with paragraph 601FC(1)(d) of the Act in the case specified in Schedule B on the conditions specified in Schedule C for so long as the conditions are met.



Under paragraph 601QA(1)(b) of the *Corporations Act 2001* (the *Act*) the Australian Securities and Investments Commission (*ASIC*) declares that, until 31 December 2009, Chapter 5C of the Act applies to the person specified in Schedule A in the case set out in Schedule B as if section 601FL of the Act were modified or varied as follows:

1. omit from subsection (1) all the text after the word “it” and substitute:

“must either:

- (a) call a members’ meeting to explain its reason for wanting to retire and to enable the members to vote on a resolution (which must be an extraordinary resolution if the scheme is not listed) to choose a company to be the new responsible entity; or
- (b) propose a related body corporate to be the new responsible entity in accordance with subsection (1A).”;

2. insert after subsection (1) the following subsection:

“(1A) The requirements for proposing a related body corporate (the *proposed responsible entity*) to be the new responsible entity are as follows:

- (a) The responsible entity must give members notice of a proposal to choose the proposed responsible entity, to be the scheme’s new responsible entity.
- (b) The notice to members must:
 - (i) set out:
 - (A) the responsible entity’s reasons for wanting to retire; and
 - (B) such information as can reasonably be expected to be material to a member in forming a view as to the choice of the proposed responsible entity; and

- (C) information about the proposed timing of the retirement of the responsible entity and the manner in which that retirement will occur; and
 - (D) how members can access on the responsible entity's web site current information about the proposed timing of the retirement of the responsible entity and the manner in which that retirement will occur; and
- (ii) state prominently that if:
- (A) members who together hold at least 5% of the total value of the interests held by members; or
 - (B) 100 members,
- who would be entitled to vote if the proposal were put as a proposed resolution to a meeting of members under paragraph (1)(a), ask for a vote on the choice of the proposed responsible entity by giving written notice received by the responsible entity within 21 days from the date the notice is sent, the responsible entity will either arrange a postal vote or convene a meeting to vote on a resolution for the choice of the proposed responsible entity; and
- (iii) be accompanied by a form which can be ticked to ask for a vote; and
 - (iv) state prominently a reply paid address of the responsible entity to which the form may be sent.
- (c) The responsible entity must prominently disclose on its web site current information about the proposed timing of the retirement of the responsible entity and the manner in which that retirement will occur.
- (d) If sufficient members ask for a vote in accordance with the notice, the responsible entity must arrange for a postal vote or, if the responsible entity chooses, convene a meeting in accordance with Part 2G.4 to vote on the choice of the proposed responsible entity as soon as possible.

- (e) If there is a postal vote:
 - (i) a voting paper must be sent to each member stating a reply paid address of the responsible entity to which the voting paper may be sent; and
 - (ii) the responsible entity must notify the members in, or in a document accompanying, the voting paper that:
 - (A) the proposed responsible entity will be chosen as the new responsible entity if at least 50% of the total votes that may be cast by members that would be eligible to vote at a meeting under paragraph (1)(a) are cast in favour of the choice; and
 - (B) only votes received by the responsible entity within 28 days after the issue of the voting paper will be counted.
- (f) If a meeting is convened the resolution to choose the new responsible entity must be an extraordinary resolution if the scheme is not listed."; and

3. inserting after subsection (2), the following subsections:

“(2A) If a postal vote is arranged under paragraph (1A)(d) and at least 50% of the total votes that may be cast by members that would be eligible to vote at a meeting under paragraph (1)(a) are cast in favour of the proposed responsible entity, that entity is taken for the purposes of subsection (2) to have been chosen by a resolution of members on the last day on which postal votes may be received in order to be counted.

(2B) If:

- (a) a related body corporate is proposed to be the new responsible entity in accordance with subsection (1A); and
- (b) sufficient members do not ask for a vote to choose the entity in accordance with the notice referred to in paragraph (1A)(b); and

- (c) the entity has consented in writing to becoming the scheme's responsible entity,

then:

- (d) as soon as practicable and in any event within 30 business days after the end of the period in which a member may ask for such a vote, the current responsible entity must lodge a notice with ASIC asking it to alter the record of the scheme's registration to name the proposed responsible entity as the scheme's responsible entity; and
- (e) the notice must be accompanied by a certificate from the current responsible entity that it reasonably considers that the appointment of the proposed responsible entity would be in the best interests of members with a summary of the responsible entity's reasons as to why this is the case; and
- (f) unless ASIC reasonably believes that the appointment of the proposed responsible entity would not be in the best interests of members, ASIC must comply with the notice as soon as practicable after the notice and summary are lodged."

 - “(c) act in the best interests of the members (having regard to both their interests as holders of interests in the scheme and their interests as holders of shares in a company, where the interests or shares are components of a stapled security) and, if there is a conflict between the members’ interests and the interests of the responsible entity, give priority to the members’ interests; and”;
2. omit paragraph 601FC(1)(e) and substitute:
 - “(e) not make use of information acquired through being the responsible entity in order to:
 - (i) gain an improper advantage for itself or another person; or

 - (b) the constitution provides that the responsible entity may allocate a proportion of the issue price of the stapled securities to the interests;
 - (c) the stapled securities are issued at a price, or in accordance with a formula or method that is to be used to calculate the issue price of stapled securities, which is set out in the scheme’s constitution;
 - (d) the responsible entity allocates a proportion of the issue price of the stapled securities to the interests in accordance with the constitution.”; and
7. after subsection 208(2) of the Act as notionally inserted into Chapter 5C of the Act by section 601LC, insert:
 - “(2A) Member approval is not required for the giving of a benefit and the benefit need not be given within 15 months if:
 - (a) the benefit either:
 - (i) is given out of the scheme property of a registered scheme; or
 - (ii) could endanger the scheme property; and

- (b) each interest in the scheme is a component part of a stapled security, together with each of the shares in a company (*stapled company*); and
- (c) the benefit is given by:
 - (i) the responsible entity of the scheme; or
 - (ii) an entity that the responsible entity controls; or
 - (iii) an agent of, or person engaged by, the responsible entity; and
- (d) the benefit is given to:
 - (i) the stapled company or a wholly owned entity of the stapled company; or
 - (ii) a wholly owned entity of the scheme; or
 - (iii) a company or scheme of which all of the shares or interests (as applicable) are held by the scheme or the stapled company, or jointly by the scheme and the stapled company.

(2B) For the purposes of this section:

- (a) an entity is wholly owned by another entity if all of the shares or interests (as applicable) in the first-mentioned entity are held by or by a nominee for (in the case of the second-mentioned entity being a company), or form part of the trust property of (in the case of the second-mentioned entity being a trust), the second-mentioned entity or a wholly owned entity of it; and
- (b) a reference to the giving of a benefit to an entity which is a trust is a reference to the giving of a benefit to the trustee of the trust so as to form part of the trust property of the trust or for the benefit of the trust beneficiaries.”; and

“601PD For the purposes of Chapter 5C of the Act:

stapled security means an interest in a registered scheme and a share in a company where:

- (a) under the terms on which each of those interests or shares are to be traded, they must be transferred together; and




