Australian Securities and Investments Commission Corporations Act 2001 — Paragraphs 741(1)(a), 911A(2)(l), 992B(1)(a) 1020F(1)(a) and 1020F(1)(b) — Exemptions

- 1. Under paragraph 741(1)(a) of the *Corporations Act 2001 (Act)* the Australian Securities and Investments Commission (*ASIC*) exempts the Issuer from Parts 6D.2 and 6D.3 (except section 736) where the Issuer:
 - (a) makes a Warrant Offer;
 - (b) offers to arrange for the issue of financial products under a Warrant Offer;
 - (c) issues a financial product under a Warrant Offer,

that does not involve a contribution plan and that does not involve the Issuer or any related body corporate of the Issuer offering any eligible employee a loan or similar financial assistance for the purposes of or in connection with, the acquisition of Warrants, on the conditions set out in Schedule A and for so long as the conditions are met.

- 2. Under paragraph 1020F(1)(a), ASIC exempts a related body corporate of the Issuer from Part 7.9 where the related body corporate:
 - (a) makes a Warrant Appreciation Right Offer; or
 - (b) offers to arrange for the issue of financial products under a Warrant Appreciation Right Offer; or
 - (c) issues a financial product under a Warrant Appreciation Right Offer,

on the conditions set out in Schedule B and for so long as the conditions are met.

- 3. Under paragraphs 741(1)(a) and 1020F(1)(a), ASIC exempts the Financial Institution and a related body corporate of the Issuer from Parts 6D.2, 6D.3 (except section 736) and 7.9 where the Financial Institution or the related body corporate of the Issuer:
 - (a) makes an Option Offer; or
 - (b) offers to arrange for the issue of financial products under an Option Offer; or
 - (c) issues a financial product under an Option Offer,

on the conditions set out in Schedule C and for so long as the conditions are met.

- 4. Under paragraph 1020F(1)(b), ASIC exempts a financial product that is the subject of a Warrant Offer covered by paragraph 1 from Part 7.9 where:
 - (a) a recommendation is made (by a person other than the Issuer) that a person to whom a Warrant Offer has been made, acquire the financial product as a retail client; and
 - (b) the person who made the recommendation is not aware, and ought not reasonably to be aware, that any of the conditions set out in Schedule A have not been met.
- 5. Under paragraph 1020F(1)(b), ASIC exempts a financial product that is the subject of a Warrant Appreciation Right Offer covered by paragraph 2 from Part 7.9 where:
 - (a) a recommendation is made (by a person other than the Issuer) that a person to whom a Warrant Appreciation Right Offer has been made, acquire the financial product as a retail client; and
 - (b) the person who made the recommendation is not aware, and ought not reasonably to be aware, that any of the conditions set out in Schedule B have not been met.
- 6. Under paragraph 1020F(1)(b), ASIC exempts a financial product that is the subject of an Option Offer covered by paragraph 3 from Part 7.9 where:
 - (a) a recommendation is made (by a person other than the Issuer) that a person to whom an Option Offer has been made, acquire the financial product as a retail client; and
 - (b) the person who made the recommendation is not aware, and ought not reasonably to be aware, that any of the conditions set out in Schedule C have not been met.
- 7. Under paragraph 911A(2)(1), ASIC exempts:
 - (a) the Issuer and any related body corporate of the Issuer from the requirement to hold an Australian financial services licence for the provision of general advice reasonably given in connection with:
 - (i) a Warrant Offer covered by paragraph 1;
 - (ii) a Warrant Appreciation Right Offer covered by paragraph 2; or
 - (iii) an Option Offer covered by paragraph 3,

where, respectively:

- (iv) the Warrant Offer Document;
- (v) the Warrant Appreciation Right Offer Document; or
- (vi) the Option Offer Document,

includes a statement to the effect that any advice given by the Issuer or any related body corporate of the Issuer in connection with a Warrant Offer, Warrant Appreciation Right Offer or Option Offer, as applicable, is general advice only, and that employees should consider obtaining their own financial product advice from an independent person who is licensed by ASIC to give such advice; and

- (b) any related body corporate of the Issuer from the requirement to hold an Australian financial services licence in relation to the following dealing services:
 - (i) arranging to issue or issuing a financial product in connection with a Warrant Offer covered by paragraph 1;
 - (ii) arranging to issue or issuing a financial product in connection with a Warrant Appreciation Right Offer covered by paragraph 2; and
 - (iii) arranging to issue or issuing a financial product in connection with an Option Offer covered by paragraph 3.
- 8. Under paragraph 992B(1)(a), ASIC exempts the Issuer and any related body corporate of the Issuer from sections 992A and 992AA, in relation to a Warrant Offer covered by paragraph 1, a Warrant Appreciation Right Offer covered by paragraph 2 or an Option Offer covered by paragraph 3, made in the course of, or because of, unsolicited meetings or telephone calls reasonably held or made in connection with the Warrant Offer, Warrant Appreciation Right Offer or the Option Offer.

Schedule A

The following conditions apply:

- 1. the Issuer must ensure that the Warrant Offer is substantially on the terms set out in the Rules of the MIP.
- 2. the Issuer must:
 - (a) include the Warrant Offer in a Warrant Offer Document;
 - (b) take reasonable steps to ensure that any eligible employee to whom the Warrant Offer is made is given a copy of the Warrant Offer Document; and

- (c) provide to ASIC a copy of the Warrant Offer Document (which need not contain details of the offer particular to the employee such as the identity or entitlement of the employee) and of each accompanying document not later than 7 days after the first provision of that material to an employee.
- 3. the Issuer must cause a related body corporate which has a registered office in this jurisdiction to comply with any undertaking required to be made in the Warrant Offer Document by reason of this instrument.
- 4. the Issuer must take reasonable steps to ensure that the number of Shares to be received on exercise of an Warrant when aggregated with:
 - (a) the number of Shares in the same class which would be issued were each outstanding offer with respect to Warrants under an employee share scheme to be accepted or exercised; and
 - (b) the number of Shares in the same class issued during the previous 5 years pursuant to the MIP or any other employee share scheme extended only to eligible employees of the Issuer,

but disregarding any offer made, option acquired or Share issued by way of or as a result of:

- (a) an offer to a person situated at the time of receipt of the offer outside this jurisdiction; or
- (b) an offer that was an excluded offer or invitation within the meaning of the Corporations Law as in force before the commencement of Schedule 1 to the *Corporate Law Economic Reform Program Act* 1999; or
- (c) an offer that did not need disclosure to investors because of section 708; or
- (d) an offer that did not require the giving of a Product Disclosure Statement because of section 1012D; or
- (e) an offer made under a disclosure document or Product Disclosure Statement,

does not exceed 5% of the total number of issued Shares in that class as at the time of the offer.

- 5. the Issuer must keep at the registered office of a related body corporate in this jurisdiction and make available to ASIC, upon request, a register of those eligible employees who received a Warrant Offer in this jurisdiction and enter in the register:
 - (a) the name address of each eligible employee;
 - (b) the extent of the holding of each eligible employee;

- (c) the date at which the name of each eligible employee was entered in the register; and
- (d) the date at which any eligible employee's participation ceased.
- 6. except as may be required by the laws of Switzerland, the Issuer must not modify or vary the Rules of the MIP in any material respect which would adversely affect the rights and interests of an eligible employee unless it notifies ASIC and ASIC notifies the related body corporate of the Issuer in writing that it does not object to the modification or variation.
- 7. the Issuer must take all reasonable steps to ensure that the Rules of the MIP are complied with.
- 8. the Issuer must take all reasonable steps to ensure that the MIP at all times complies with the laws of Switzerland.

Note: where a document must be provided in writing it may be provided by electronic means. See s5C of the Act and section 25 of the Acts Interpretation Act 1901.

Schedule B

The following conditions apply:

- 1. the related body corporate of Issuer must ensure that the Warrant Appreciation Right Offer is substantially on the terms set out in the Rules of the MIP.
- 2. the related body corporate of the Issuer must:
 - (a) include the Warrant Appreciation Right Offer in a Warrant Appreciation Right Offer Document; and

- 5. the related body corporate of the Issuer must take all reasonable steps to ensure that the Rules of the MIP are complied with.

but disregarding any offer made, option acquired or Share issued by way of or as a result of:

- (a) an offer to a person situated at the time of receipt of the offer outside this jurisdiction; or
- (b) an offer that was an excluded offer or invitation within the meaning of the Corporations Law as in force before the commencement of Schedule 1 to the *Corporate Law Economic Reform Program Act* 1999; or
- (c) an offer that did not need disclosure to investors because of section 708; or
- (d) an offer that did not require the giving of a Product Disclosure Statement because of section 1012D; or
- (e) an offer made under a disclosure document or Product Disclosure Statement,

- 7. the related body corporate of the Issuer must take all reasonable steps to ensure that the Rules of the MIP are complied with.
- 8. the related body corporate of the Issuer must take all reasonable steps to ensure that the MIP at all times complies with the laws of Switzerland.

Interpretation

In this instrument:

- 1. except where otherwise stated, references to provisions are to provisions of the Act.
- 2. the employee incentive scheme shall not be regarded as extended to a person other than an eligible employee only because such an employee may renounce an offer of financial products made to them under the employee incentive scheme in favour of their nominee.
- 3. Australian dollar equivalent in relation to a price, means a price calculated by reference to the relevant exchange rate published by an Australian bank no earlier than the business day before the day to which price relates.
- 4. *current market price* means in relation to a Share, the price published on the SIX Swiss Exchange as the final price for the previous day on which the Share was traded on the SIX Swiss Exchange.
- 5. *eligible employee* means a person who is at the time of a Warrant Offer, Option Offer or Warrant Appreciation Right Offer, a full or part-time employee or director of the Issuer or of a related body corporate of the Issuer.
- 6. Financial Institution means UBS AG, a Swiss financial institution.
- 7. *financial product advice* has the meaning given by section 766B.
- 8. **general advice** has the meaning given by section 766B.
- 9. **Issuer** means ABB Limited, a company incorporated under the laws of Switzerland and registered in the Commercial Register of Zurich.
- 10. offer has a meaning affected by sections 700, 702 and 1010C.
- 11. **MIP** means the management incentive program extended only to eligible employees that is known at the date of this instrument as the ABB Management Incentive Program.
- 12. *Option* means an option to acquire, by way of issue or transfer, a Share in accordance with the terms and conditions of grant (as defined in the Rules of the MIP).
- 13. *Option Offer* means an offer of an Option where:
 - (a) each Option is offered for no more than nominal consideration; and
 - (b) the Share to which the Option relates is in the same class as fully-paid common stock in the Issuer that has been quoted on the SIX Swiss Exchange throughout the 12 month period immediately before the offer without suspension for more than a total of 2 trading days during that period.

- 14. *Option Offer Document* means a document setting out an Option Offer under the MIP that:
 - (a) includes or is accompanied by a copy, or a summary, of the Rules of the MIP;
 - (b) if a summary (rather than a copy) of the Rules of the MIP is given includes an undertaking that during the period (the offer period) in which an eligible employee may exercise the Options, a related body corporate which has a registered office in this jurisdiction will, within a reasonable period of the employee so requesting, provide the employee without charge with a copy of the Rules of the MIP;
 - (c) specifies in respect of the Shares subject to the Options:
 - (i) the acquisition price in Australian dollars;
 - (ii) where the acquisition price is specified in a foreign currency, the Australian dollar equivalent of that price at the date of the Option Offer; or
 - (iii) where the acquisition price is to be worked out in the future under a formula, the Australian dollar or Australian dollar equivalent of that price were that formula applied at the date of the Option Offer; and
 - (d) includes an undertaking, and an explanation of the way in which, a related body corporate of the Issuer which has a registered office in this jurisdiction will, during the offer period, within a reasonable period of the employee requesting, make available to the employee:
 - (i) the current market price (or, where that price is denominated in a foreign currency, the Australian dollar equivalent of that price) of Shares in the same class as those subject to the Options; and
 - (ii) where subparagraph (c)(ii) or (iii) applies, the information referred to in that paragraph as updated to that date.
- 15. related body corporate has the meaning given by section 50.
- 16. **Rules of the MIP** means the written terms of the MIP that are substantially the same as the terms set out in the 'Information Memorandum' and 'General Terms and Conditions of the Warrants' provided to ASIC on 3 September 2009.
- 17. **Share** means an ordinary share in the Issuer.
- 18. **Warrant** means a financial product issued by the Financial Institution in accordance with the General Terms and Conditions of the Warrants and listed on the SIX Swiss Exchange.

- 19. **Warrant Appreciation Right** means a right to receive a cash payment determined in accordance with the Rules of the MIP on the vesting date provided the vesting conditions have been satisfied.
- 20. *Warrant Appreciation Right Offer* means an offer of a Warrant Appreciation Right.
- 21. *Warrant Appreciation Right Offer Document* means a document setting out a Warrant Appreciation Right Offer under the MIP that:
 - (a) includes or is accompanied by a copy, or a summary, of the Rules of the MIP;
 - (b) if a summary (rather than a copy) of the Rules of the MIP is given includes an undertaking that during the period (the *offer period*) in which an eligible employee may exercise the Warrant Appreciation Rights, a related body corporate which has a registered office in this jurisdiction will, within a reasonable period of the employee so requesting, provide the employee without charge with a copy of the Rules of the MIP;
 - (c) specifies in respect of the Warrant Appreciation Rights:
 - (i) how the cash consideration payable under the Warrant Appreciation Right will be calculated; and
 - (ii) the vesting date and vesting conditions of the Warrant Appreciation Right; and
 - (iii) either:
 - (A) the acquisition price in Australian dollars; or
 - (B) where the acquisition price is specified in a foreign currency, the Australian dollar equivalent of that price at the date of the Warrant Appreciation Rights Offer; or
 - (C) where the acquisition price is to be worked out in the future under a formula, the Australian dollar or Australian dollar equivalent of that price were that formula applied at the date of the Warrant Appreciation Rights Offer; and
 - (d) includes an undertaking, and an explanation of the way in which, a related body corporate of the Issuer which has a registered office in this jurisdiction will, during the offer period, within a reasonable period of the employee requesting, make available to the employee:
 - (i) the current market price (or, where that price is denominated in a foreign currency, the Australian dollar

- equivalent of that price) of Shares in the same class as those to which the Warrant Appreciation Rights relate; and
- (ii) where subparagraph (iii)(B) or (C) applies, the information referred to in that paragraph as updated to that date.
- 22. *Warrant Offer* means an offer of a Warrant where:
 - (a) each Warrant is offered for no more than nominal consideration; and
 - (b) the Shares to which the Warrant relates are in the same class as fully-paid common stock in the Issuer that has been quoted on the SIX Swiss Exchange throughout the 12 month period immediately before the offer without suspension for more than a total of 2 trading days during that period.
- 23. *Warrant Offer Document* means a document setting out a Warrant Offer under the MIP that:
 - (a) includes or is accompanied by a copy, or a summary, of the Rules of the MIP;
 - (b) if a summary (rather than a copy) of the Rules of the MIP is given includes an undertaking that during the period (the *offer period*) in which an eligible employee may exercise the Warrants, a related body corporate which has a registered office in this jurisdiction will, within a reasonable period of the employee so requesting, provide the employee without charge with a copy of the Rules of the MIP;

 - (i) the current market price (or, where that price is denominated in a foreign currency, the Australian dollar equivalent of that price) of Shares in the same class as those to which the Warrants relate; and

Australian Securities and Investments Commission Corporations Act 2001 - Subsection 601QA(1) – Exemption and Declaration

Enabling legislation

1. The Australian Securities and Investments Commission (ASIC) makes this instrument under subsection 601QA(1) of the Corporations Act 2001 (the Act).

Title

2. This instrument is ASIC Instrument 09-01024.

Exemption

3. ASIC exempts Challenger Managed Investments Limited ACN 002 835 592 (the *Responsible Entity*) in its capacity as the responsible entity of the Challenger High Yield Fund ARSN 099 212 647 (*the Fund*) from paragraph 601FC(1)(d) of the Act in relation to allowing a member of the Fund to withdraw in accordance with section 601KEA of the Act as inserted by this instrument.

Declaration

- 4. ASIC declares that Chapter 5C of the Act applies to the Responsible Entity in its capacity as the responsible entity of the Fund in the case specified in the Schedule as if Part 5C.6 of the Act were modified or varied as follows:
 - (a) after subsection 601KA(3) insert:
 - "(3AA) Subsection (3) does not apply to a withdrawal in accordance with section 601KEA."; and
 - (b) after subsection 601KE insert:

"601KEA Hardship withdrawals

Power to allow withdrawal in case of member hardship

- (1) Subject to this section, the responsible entity of a registered scheme may allow a member to withdraw (*hardship withdrawal*) from the scheme in accordance with a provision of the scheme's constitution that provides for the member to have a right to withdraw when the responsible entity is satisfied that:
 - (a) the member has experienced hardship or is likely to experience hardship if the member is not allowed to withdraw; or

- (b) where the member is an operator—a person (*instructor*) who has asked the operator to exercise a right to withdraw has experienced hardship or is likely to experience hardship if the operator is not allowed to withdraw; or
- (c) where the member is dead—a beneficiary of the estate has experienced hardship or is likely to experience hardship if the executor or administrator of the estate is not allowed to withdraw.
- (1A) In this section, an *operator* means a person who is a member of the scheme in its capacity as responsible entity or custodian of a registered scheme, trustee of a trust, trustee or custodian of a superannuation entity within the meaning of the *Superannuation Industry (Supervision) Act 1993*, trustee of a self-managed superannuation fund within the meaning of the *Superannuation Industry (Supervision) Act 1993* or provider or acquirer in relation to a custodial arrangement as defined in section 1012IA.
- (2) The responsible entity must not allow a hardship withdrawal unless the responsible entity is satisfied that:
 - (a) following that withdrawal the scheme property would include sufficient liquid assets for the day to day operation of the scheme; and
 - (b) satisfying the hardship withdrawal request:
 - (i) would not result in more than 4 hardship withdrawals for any member, instructor or beneficiary (as applicable) in any calendar year; and
 - (ii) would not result in the total amount of hardship withdrawals for any member, instructor or beneficiary (as applicable) in any calendar year exceeding \$100,000; and
 - (c) any amount paid would not exceed the specific amount the subject of a hardship withdrawal request in respect of the hardship of the member, instructor or beneficiary (as applicable); and
 - (d) where paragraph (1)(b) applies—any amount paid on withdrawal to an operator will be paid to the instructor after deduction of any fees and charges payable to the operator; and

Note: In making any payment to an instructor, an operator must comply with any obligations under the terms of the relevant trust or arrangement under which it acts and other applicable laws. For example, the responsible entity of a registered scheme must comply with Part 5C.6 as modified by any relief applicable to that scheme and the trustee of a superannuation entity or self managed superannuation fund must comply with requirements under the Superannuation Industry (Supervision) Act 1993.

- (e) where paragraph (1)(c) applies—any amount paid on withdrawal to an executor or administrator of the estate will be paid to the beneficiary after deduction of any fees and charges payable to the executor or administrator.
- (3) If a constitution includes a provision permitting the responsible entity to exercise a discretion in relation to a hardship withdrawal the responsible entity must comply with subsections (4) to (6).

Exercise of discretion must be reasonable

(4) The responsible entity or its nominee must act reasonably in exercising a discretion covered by subsection (3).

Note: The responsible entity is also subject to its general duties under section 60IFC including the duty to act in the best interests of the members of the scheme.

Documentation of exercise of discretion

(5) The responsible entity must ensure that the records which it keeps under section 988A document how and why a decision to permit or refuse a hardship withdrawal was made.
