**Australian Securities and Investments Commission
Corporations Act 2001 – Paragraph 655A(1)(b) - Exemption**

Under paragraph 655A(1)(b) of the *Corporations Act 2001* (Act) the Australian Securities and Investments Commission (ASIC) exempts the person specified in Schedule A from section 606 of the Act in respect of the acquisition specified in Schedule B on the conditions specified in Schedule C.

Schedule C

1. The Joint Bidders must use their best endeavours to have PBA engage an independent expert to prepare a report on whether, in the expert's opinion, the Joint Bid is fair and reasonable to PBA shareholders not associated with the Joint Bidders.
2. The Joint Bid must contain a defeating condition that, during or at the end of the Joint Bid offer period, Bidco has received valid acceptances for not less than 50.1% of the bid class securities that Bidco offers to acquire under the Joint Bid, not being issued voting shares in which the Joint Bidders and their respective associates have a relevant interest in at the beginning of the Joint Bid offer period, and the bidder's statement in respect of the Joint Bid states that the defeating condition will not be waived.
3. The Joint Bidders must each accept any rival takeover bid for all bid class securities (**Rival Bid**) in respect of all the issued shares in PBA in which they have a relevant interest within 7 days from the date that all of the following conditions are satisfied in respect of a Rival Bid:
 - (i) the consideration offered under the Rival Bid is more than (or becomes more than) 105% of the value of the consideration offered under the Joint Bid (as assessed by ASIC and notified to the Joint Bidders if the consideration offered under the Rival Bid is other than cash or is a combination of cash and other-than-cash consideration);
 - (ii) the Rival Bid is or has become unconditional except for prescribed occurrence conditions (being events or circumstances referred to in subsections 652C(1) or (2) of the Act); and
 - (iii) the Rival Bid offer period starts before the end of the Joint Bid offer period;unless prior to the expiration of the 7 day period referred to above, the Joint Bid is varied so that the value of the consideration offered under the Joint Bid is at least equal to the value of the consideration offered under the Rival Bid.
4. The Joint Bidders must immediately terminate the Agreement and all other relevant arrangements between the Joint Bidders and their respective associates in relation to the Joint Bid, if the Joint Bid does not proceed, or fails because of a defeating condition that has neither been satisfied nor waived.
