**Australian Securities and Investments Commission
Corporations Act 2001 – Paragraph 741(1)(a) –
Exemption**

Enabling provisions

1. The Australian Securities and Investments Commission (*ASIC*) makes this instrument under paragraph 741(1)(a) of the *Corporations Act 2001* (the *Act*).

Title

2. This instrument is ASIC Instrument 09-00595.

Exemption

3. National Australia Bank Limited ACN 004 044 937 (*issuer*) does not have to comply with Part 6D.2 or 6D.3 of the Act (other than sections 736 and 738) for an offer of shares for issue, made on or about 3 August 2009, under a purchase plan.

Where relief applies

4. The exemption in paragraph 3 applies to a written offer for the issue of shares where the following requirements are met at the time that the offer is made:
 - (a) the shares are in a class (the *class*) which:
 - (i) is quoted on the financial market operated by ASX; and
 - (ii) is not suspended from trading and was not suspended from trading on that market for more than a total of 5 days during the shorter of the period during which the class was quoted, and the period of 12 months before the day on which the offer is made;
 - (b) a determination under subsection 708AA(3) or 708A(2) of the Act is not in force in relation to the issuer;
 - (c) no exemption under section 111AS or 111AT of the Act covered the issuer, or any person as director or auditor of the issuer, at any time in the shorter of the period during which the class was quoted, and the period of 12 months before the day on which the offer is made;
 - (d) no order under section 340 or 341 of the Act (other than an excluded order) covered the issuer, or any person as director or auditor of the issuer, at any time in the shorter of the period during which the class was quoted, and the period of 12 months before the day on which the offer is made;

- (e) the written offer document contains the following information:
 - (i) the method used to calculate the issue price and the time when this price will be determined; and
 - (ii) a statement describing the relationship between the issue price and the market price; and
 - (iii) disclosure of the risk that the market price may change between the date of the offer and the date when the shares are issued to an applicant under the purchase plan, and the effect this would have on the price or value of the shares which the applicant would receive; and
- (f) the issuer has either:
 - (i) not more than 30 days before the offer, given a notice to ASX that complies with subsection 708A(6) of the Act in relation to an issue of shares in the class made otherwise than under a purchase plan; or
 - (ii) within the 24 hour period before the offer, given a notice to ASX that:
 - (A) states that the issuer will make offers to issue shares under a purchase plan without disclosure to investors under Part 6D.2 of the Act; and
 - (B) states that the notice is being given in accordance with this instrument; and
 - (C) states that, as at the date of the notice, the issuer has complied with the provisions of Chapter 2M of the Act as they apply to the issuer and section 674 of the Act; and
 - (D) sets out any information that is excluded information as at the date of the notice (in accordance with the requirements of subsections 708A(7) and (8) of the Act as if the notice were a notice under paragraph 708A(5)(e) of the Act).

Conditions

- 5. Subject to paragraph 6, the issuer must not issue shares to a registered holder under the purchase plan unless the holder has, on application for the shares, provided the issuer with a certification to the effect that the total of the application price for the following does not exceed \$15,000:
 - (a) the shares the subject of the application; and
 - (b) any other shares in the class issued to the holder under the purchase plan or any similar arrangement in the 12 months before the application; and
 - (c) any other shares in the class which the holder has instructed a custodian to acquire on their behalf under the purchase plan; and

- (d) any other shares in the class issued to a custodian in the 12 months before the application as a result of an instruction given by the holder to the custodian to apply for shares on their behalf under an arrangement similar to the purchase plan.
6. If the purchase plan involves custodian offers, the issuer must not issue shares to a custodian with a total application price exceeding \$15,000 in any 12 month period unless on application for the shares, the custodian certifies the following in writing to the issuer:
- (a) that the custodian holds shares in the class on behalf of one or more other persons (each a *participating beneficiary*) on the date referred to in paragraph (a) of the definition of *purchase plan* who have subsequently instructed the custodian to apply for shares on their behalf under the purchase plan;
 - (b) the number of participating beneficiaries;
 - (c) the name and address of each participating beneficiary;
 - (d) in respect of each participating beneficiary, the number of shares in the class that the custodian holds on their behalf;
 - (e) in respect of each participating beneficiary, the number or the dollar amount of shares they instructed the custodian to apply for on their behalf;
 - (f) there are no participating beneficiaries in respect of which the total of the application price for the following exceeds \$15,000:
 - (i) the shares applied for by the custodian on their behalf under the purchase plan; and
 - (ii) any other shares in the class issued to the custodian in the 12 months before the application as a result of an instruction given by them to the custodian to apply for shares on their behalf under an arrangement similar to the purchase plan.
7. The issuer must not issue shares under the purchase plan unless the issuer is reasonably satisfied that the total of the application price for the following will not exceed \$15,000 in relation to any person as a result of issuing the shares:
- (a) the shares issued to the person under the purchase plan; and
 - (b) any other shares in the class issued to the person under an arrangement similar to the purchase plan in the 12 months before the date of issue under the purchase plan; and
 - (c) any other shares in the class issued to a custodian as a result of an instruction given by the person to the custodian to apply for shares on their behalf under the purchase plan; and
 - (d) any other shares in the class issued to a custodian in the 12 months before the date of issue under the purchase plan as a result of an instruction given by the person to the custodian to apply for shares on their behalf under an arrangement similar to the purchase plan,

except to the extent that the person is issued with shares as a custodian under a custodian offer.

8. If:
- (a) a notice given under subsubparagraph 4(f)(ii) is defective; and
 - (b) the issuer becomes aware of the defect in the notice within 12 months after the shares are issued under the offer,

the issuer must, within a reasonable time after becoming aware of the defect, give ASX a notice that sets out the information necessary to correct the defect.

Interpretation

9. For the purposes of this instrument:

- (a) *ASX* means ASX Limited ACN 008 624 691.

custodial or depositary service has the meaning given by section 766E of the Act.

custodian means a registered holder:

- (a) that holds an Australian financial services licence that:
 - (i) covers the provision of a custodial or depositary service; or
 - (ii) includes a condition requiring the holder to comply with the requirements of ASIC Class Order [CO 02/294]; or
- (b) that is exempt under:
 - (i) paragraph 7.6.01(1)(k) of the *Corporations Regulations 2001*; or
 - (ii) ASIC Class Order [CO 05/1270] to the extent that it relates to ASIC Class Order [CO 03/184],

from the requirement to hold an Australian financial services licence for the provision of a custodial or depositary service.

custodian offer means an offer to a registered holder to the extent that it is of the kind referred to in paragraph (b) of the definition of *purchase plan*.

excluded order means ASIC Class Orders [CO 98/100], [CO 98/101], [CO 98/104], [CO 98/1418], [CO 98/2395], [CO 99/90], [CO 00/2449], [CO 05/642], [CO 05/644] and [CO 06/441].

purchase plan means an arrangement under which:


- (a) an offer is made to each registered holder of shares in the class on a date determined by the issuer, and whose address (as recorded in the register of members) is in a place in which, in the reasonable opinion of the issuer, it is lawful and practical for the issuer to offer and issue shares to that person;
- (b) an offer may enable a registered holder who is a custodian to acquire shares on behalf of a person (the *beneficiary*) on whose behalf the custodian is holding shares in the class;
- (c) each offer is made on:
 - (i) the same terms and conditions:
 - (A) to the extent it is an offer to a registered holder to acquire shares on their own behalf; and
 - (B) to the extent (if any) it is an offer to a registered holder to acquire shares as a custodian on behalf of a beneficiary; and
 - (ii) a non-renounceable basis;
- (d) if offers of the kind referred to in subparagraph (c)(i)(B) are made—the terms and conditions on which a registered holder may acquire shares on their own behalf or as a custodian on behalf of a beneficiary are as nearly as practicable the same;
- (e) the issue price is less than the market price during a specified period in the 30 days before either the date of the offer or the date of the issue; and
- (f) the total application price for the shares acquired by a person on their own behalf and by a custodian on behalf of the person in any 12 month period does not exceed \$15,000.

registered holder means a person recorded in the register of members of a body as a member of the body.

- (b) if 2 or more persons are recorded in the register of members as jointly holding shares in the body they are taken to be a single registered holder and a certification given by any of them for the purposes of paragraph 5 is taken to be a certification given by all of them.
- (c) if a custodian holds shares jointly on behalf of 2 or more persons:
 - (i) the \$15,000 limit applies jointly in relation to those persons as if the custodian held the shares on behalf of a single person; and
 - (ii) the custodian is taken to have been instructed to apply for shares on behalf of those persons if:
 - (A) the custodian has received such an instruction in accordance with the terms on which the shares are held; or

- (B) where the terms on which the shares are held do not cover the giving of instructions of this kind—the custodian has received such an instruction from any of those persons.
- (d) references to an issuer offering shares include the issuer inviting applications for the issue of the shares.
- (e) a notice is *defective* if the notice:
- (i) does not comply with sub-subsubparagraph 4(f)(ii)(D); or
 - (ii) is false in a material particular; or
 - (iii) has omitted from it a matter or thing the omission of which renders the notice misleading in a material respect.
- (f) an arrangement covered by ASIC Class Orders [CO 02/831] or [CO 02/832] is taken to be similar to a purchase plan.
- (g) an arrangement is not to be taken not to be similar to a purchase plan merely because:
- (i) only one of them involves custodian offers; or
 - (ii) they involve different maximum levels of applications by registered holders.

**Australia Securities and Investments Commission
Corporations Act 2001 – Subsection 655A(1) – Revocation, Exemption and Declaration**

Under paragraph 655A(1)(a) of the *Corporations Act 2001 (Act)*, the Australian Securities and Investments Commission (*ASIC*) revokes ASIC instrument [07/0661] dated 2 August 2007.

And under paragraph 655A(1)(a) of the Act, ASIC exempts until 30 July 2011 the persons specified in Schedule A from section 606 of the Act in the case specified in Schedule B on the conditions specified in Schedule C.

And under paragraph 655A(1)(b) of the Act, ASIC declares that, until 30 July 2011, Chapter 6 of the Act applies to the persons specified in Schedule A in the case specified in Schedule D as if item 9 of section 611 of the Act were modified to disregard relevant interests acquired and increases in voting power exempted from section 606 of the Act by the operation of the exemption in this instrument.

Schedule A

Colonial First State Investments Limited ACN 002 348 352 (*CFS*) and CFS's related bodies corporate (*CBA Group*).

Schedule B

Acquisitions of relevant interests in voting shares or voting interests, or increases in voting power, where such acquisitions or increases occur in the following circumstances:

1. One or more entity in the CBA Group manage an index fund (individually, a *CBA Index Fund*) over one or a combination of the:
 - (a) S&P/ ASX 100;
 - (b) S&P/ ASX 200; or
 - (c) S&P/ ASX 300indices (or their successors).
2. The voting shares or voting interests are held by or for the benefit of the CBA Index Fund;
3. The CBA Index Fund has an objective of maintaining a tracking error of less than 0.5% per annum, and such objective is stated in the investment mandate or offer documents for the relevant fund.

Schedule C

1. The CBA Index Fund maintains systems and processes giving a reasonable assurance that a portfolio tracking error of less than 0.5% per annum for the CBA Index Fund will be maintained.
2. A CBA Index Fund's relevant interest in voting shares or interests is never more than 5% over the company or scheme's index weighting in a relevant index.

3. On or about 30 August 2009, 28 February 2010, 30 August 2010 and 28 February 2011, CFS provides ASIC a written report by an independent third party (agreed to in writing by ASIC), concerning a review by the independent third party, completed no earlier than 14 days before the report is provided to ASIC, as to the systems and processes of each CBA Index Fund for compliance with paragraphs 1 and 2 of this Schedule C.
4. No entity in the CBA Group exercises a right to vote attached to voting shares or interests held by a CBA Index Fund unless and to the extent that voting rights are exercised in accordance with specific instructions received from a client of the relevant CBA Index Fund, where such instructions are permitted by the relevant CBA Index Fund mandate and the client is not an associate of an entity in CBA Group and an entity in the CBA Group does not have the power to exercise, or control the exercise of, the direction.
5. On or about 1 July 2011 CFS provides ASIC with a written report on the practical operation of this exemption, including without limitation where a CBA Index Fund acquires a relevant interest in voting shares or voting interests or increases its voting power in a body or listed registered scheme which would contravene s606 but for the relief in this instrument, details of:
 - (a) the relevant voting shares or voting interests;
 - (b) the maximum relevant interest in the voting securities or voting interests and the maximum voting power in the body or listed registered scheme acquired; and
 - (c) the period during which the CBA Index Fund relied on the relief in this instrument in relation to the relevant voting shares or voting interests.

Schedule D

For the purpose of paragraph (b) of item 9 of section 611 of the Act, the calculation of relevant interests in, or voting power in relation to, shares or interests in the circumstances set out in Schedule B.

**Australian Securities and Investments Commission
Corporations Act 2001 — Paragraphs 911A(2)(l), 992B(1)(a) and 1020F(1)(a) —
Exemptions**

Enabling legislation

The Australian Securities and Investments Commission (*ASIC*) grants the exemptions set out in paragraph 3 under paragraphs 911A(2)(l), 992B(1)(a) and 1020F(1)(a) of the *Corporations Act 2001* (the *Act*).

Commencement

2. This instrument commences on the date of its gazettal.

Exemptions

3. ASIC exempts the persons specified in Schedule A, who provide financial services in relation to a low value non-cash payment facility to be known as the Coles In Store Salary Sacrifice Plan (the *Plan*), from subsection 911A(1), section 992A and Part 7.9 of the Act, in relation to those financial services and so long as the Conditions set out in Schedule B are met.

Schedule A

The *Coles Group*, consisting of:

- (a) Coles Group Limited ACN 004 089 936 (the *Issuer*); and
- (b) its wholly owned subsidiaries:

Schedule B

Conditions

4. Where the Coles Group takes advantage of any of the exemptions in paragraph 3, the Coles Group must take reasonable steps to ensure all of the following are satisfied:
- (a) before or at the time the Plan is offered to an eligible employee, the Coles Group must give a written document (the *disclosure document*) to the eligible employee, which sets out the terms and conditions of the Plan and separately sets out in a prominent manner:
 - (i) information about whether any of the terms and conditions of the Plan may be unilaterally varied by the Issuer and a statement of how the eligible employee may get information about the new terms and conditions;
 - (ii) information about whether there is a date (the *expiry date*) after which the Plan cannot be used for the making of non-cash payments (regardless of whether there is an amount standing to the credit of the Plan at the end of the relevant day) and information about where the expiry date may be found out;
 - (iii) information about the procedures for dealing with any unauthorised or mistaken transactions relating to the Plan or the loss or theft of the Device; and
 - (iv) fees or charges for acquiring and using the Plan and where any such fees or charges are subject to change during the life of the Plan, a statement of how the eligible employee may get information about the new fees or charges;
 - (b) the disclosure document is worded and presented in a clear, concise and effective manner;
 - (c) the expiry date is prominently set out on the device in a manner that makes it clear that it is an expiry date;
 - (d) a convenient means is available, that involves no charge by the Coles Group, for the eligible employee to do all of the following:
 - (i) check the amount standing to the credit of the Plan; and
 - (ii) obtain at reasonable intervals a record of the past 10 transactions (or such transactions that have occurred) under the Plan;

- (e) if the terms and conditions of the Plan are unilaterally varied, or the fees or charges for using the Plan are changed during the life of the Plan:
- (i) a statement setting out the effect of the variation or change is displayed in a clear and prominent notice at each place of business where the Device may be used in an area that is accessible to the public;
 - (ii) information about the variation or change is made available to the eligible employee in accordance with the statement in subparagraph 4(a)(i) or 4(a)(iv);
 - (iii) the new terms and conditions or fees and charges are made available to the eligible employee on request at each place of business where the Device may be used; and
 - (iv) if the Coles Group makes available information about the Plan on an Internet website — the statement in subparagraph 4(e)(i), information about the variation or change, and the new terms and conditions or fees and charges are made available on the website in a manner reasonably likely to come to the attention of persons seeking information about the Plan, and
- (f) the Coles Group must maintain adequate internal dispute resolution processes that are:
- i) in accordance with the Australian Standard on Complaints Handling (AS ISO 10002-2006) as at 5 April 2006; and
 - ii) clearly set out in the disclosure document.
5. The Coles Group must give ASIC notice in writing within 5 business days of when the Plan is no longer a low value non-cash payment facility.

Interpretation

7. In this instrument:

Device means the card to be known as the Benefit Card, by which an eligible employee and one immediate family member may use to make payments under the Plan.

eligible employee means a person who is:

- (a) a permanent full-time or part-time employee of the Coles Group at the time of applying for the Plan;
- (b) an Australian resident for taxation purposes;
- (c) a permanent full-time or part-time employee of the Coles Group at the time salary deductions are made; and
- (d) paid via the Coles Group payroll system.

issuer has the meaning given by subsection 761E(4) of the Act.


low value non-cash payment facility means a facility through which, or through the acquisition of which, a person makes non-cash payments and in relation to which the following are satisfied:

- (a) the total amount available for the making of non-cash payments under all Devices held by an eligible employee at any one time does not exceed \$1,000;
- (b) the Device is used only by eligible employees of the Coles Group and one immediate family member;
- (c) the Device is used only in supermarket stores operated by the Coles Group under the business names Coles, Bi-Lo and Pick'n'Pay; and
- (d) the Plan is not a component of another financial product.

makes non-cash payments has the meaning given by section 763D of the Act.

offer has a meaning affected by subsection 1010C(2) of the Act.
