

1. This instrument commences on 4 August 2010.

Declaration

2. Under paragraphs 655A(1)(b), 673(1)(b) and 1020F(1)(c) of the *Corporations Act 2001 (Act)*, the Australian Securities and Investments Commission (*ASIC*) revokes ASIC Instrument number [03/0594] dated 24 June 2003 as varied by ASIC Instrument number [09/748] dated 10 September 2009.
3. Under paragraph 655A (1)(b) and 673(1)(b) of the Act, ASIC declares that Chapters 6 and 6C of the Act apply to the persons named in Schedule A in the case referred to in Schedule B as if:
 - (i) section 609 of the Act were modified or varied by inserting the following subsection after subsection (13), as notionally inserted by ASIC Class Order [CO 03/634] as in force on the date of this instrument and as amended from time to time by a disallowable legislative instrument within the meaning of the *Legislative Instruments Act 2003*:

“(14) A person (the trustee) does not have a relevant interest in securities as the trustee of a trust established pursuant to a trust deed (the trust deed) under which instalment receipts are issued or made available for the purpose of satisfying rights or obligations of the holder of instalment receipts despite:

 - (1) (a) the trustee having any of the following discretions under the terms of the trust deed relating to the instalment receipts:
 - (i) discretions where the holder of the instalment receipts becomes insolvent or breaches a term of the receipts; or
 - (ii) discretions in relation to bonus issues, rights issues, returns of capital, security splits, security consolidations or other reconstructions of capital affecting the securities; or
 - (iii) discretions in relation to a takeover bid for or a scheme of arrangement but not in relation to voting or disposal of the securities; or
 - (iv) discretions in relation to the appointment of custodians or sub-custodians to procure safe custody of the securities; or
 - (b) the holder of the instalment receipt not having a presently enforceable or unconditional right of the kind referred to in subsection 608(8);

where:

- (c) the trustee holds the securities on trust for the benefit of the holder of the instalment receipt; and
 - (d) if the trustee exercises any of the discretions referred to in paragraph (a), it does so on ordinary commercial terms or in an ordinary commercial manner as the case requires.
- (2) An unpaid vendor of a security does not have a relevant interest in that security where the security is held in trust under the terms of an instalment receipt pursuant to which the unpaid vendor has no power to control the voting or disposal of the security (other than to enforce the terms of the trust or where the holder of the instalment receipt defaults) unless and until the instalment receipt is cancelled.
- (3) If a person has a relevant interest in a security because subsection (2) ceases to apply, the person is taken to acquire a relevant interest in the security at that time, by a transaction in relation to that security.”



 - (a) a sale agent appointed by the Nominee sells the Scrip Consideration on ASX or via a bookbuild and remits the proceeds of sale, less any reasonable applicable brokerage, stamp duty and other selling costs, taxes and charges, to the Nominee; and
 - (b) the Nominee promptly pays to Bidder the net proceeds of sale under subparagraph (3)(a); and

- (c) in respect of an Overseas Unitholder, the Bidder promptly pays to the Overseas Unitholder that Overseas Unitholder's entitlement to the net proceeds of sale under subparagraph (3)(a); and
 - (d) in respect of an Overseas WIR Holder, the Bidder promptly pays to the Overseas WIR Holder that Overseas WIR Holder's entitlement to the proceeds of sale referred to in subparagraph (3)(a), net of any instalment debt repayment in relation to the relevant WOT IR; and
4. the explanatory memorandum (*Explanatory Memorandum*) and notice of Meeting distributed to WOT Investors prior to, and in respect of, the Meeting clearly sets out the matters described in paragraphs (2) and (3); and
 5. WFML reasonably believes that having regard to the rights and interests of all members of the Scheme it would be in the best interests of all members of the Scheme, and not unfair to Overseas Investors, to treat Overseas Investors as set out in paragraph (3); and
 6. as at the close of trading on the last Trading Day before the date of the Explanatory Memorandum the interests of the Overseas Investors comprise no more than 0.84% of all interests on issue in the Trust.

Mirvac means Mirvac Limited (ACN 003 280 699) and Mirvac Funds Limited (ACN 002 561 640) as responsible entity of the Mirvac Property Trust (ARSN 086 780 645).

Mirvac Stapled Security means a fully paid interest in Mirvac Property Trust (ARSN 086 780 645) stapled to a fully paid ordinary share in Mirvac Limited (ACN 003 280 699), which must, on the terms on which they are traded, only be transferred together.

 - (c) as soon as practicable and in any event within 2 business days after the single member has given its written consent, the responsible entity must lodge a notice with ASIC asking it to alter the record of the scheme's registration to name the proposed responsible entity as the scheme's responsible entity; and
 - (d) if the current responsible entity does not lodge the notice required by paragraph (c), the proposed responsible entity may lodge that notice; and
 - (e) ASIC must comply with the notice when it is lodged."



1020F(1)(a) and 1020F(1)(b) — Exemptions**

1. Under paragraphs 741(1)(a) and 1020F(1)(a) of the *Corporations Act 2001* (the **Act**), the Australian Securities and Investments Commission (**ASIC**) exempts Seven Group Holdings Limited ACN 142 003 469 (the **Issuer**) from:
 - (a) Parts 6D.2 and 6D.3 (except section 736), and Part 7.9 where the Issuer:
 - (i) makes an eligible offer; or
 - (ii) offers to arrange for the issue of financial products under an eligible offer or
 - (iii) issues a financial product under an eligible offer,that does not involve a contribution plan, on the conditions set out in the Schedule and for so long as the conditions are met; and
 - (b) a person (other than the Issuer) from Part 7.9 where the person makes a recommendation to acquire financial products under an eligible offer that does not involve a contribution plan, except where the person is aware, or ought reasonably to be aware, that any of the conditions set out in the Schedule have not been met.
2. Under paragraph 911A(2)(l) of the Act, ASIC exempts:
 - (a) the Issuer who is exempt from Part 6D.2 or Part 7.9 because of paragraph 1 of this instrument; and
 - (b) any associate of the Issuerfrom the requirement to hold an Australian financial services licence for the provision of the following financial services:
 - (c) general advice reasonably given in connection with an eligible offer (including any general advice given in the offer document) where the offer document for the offer includes a statement to the effect that any advice given by the Issuer or related body corporate of the Issuer in connection with the offer is general advice only, and that employees should consider obtaining their own financial product advice from an independent person who is licensed by ASIC to give such advice; and
 - (d) dealing in a financial product in connection with an eligible offer where any acquisition by purchase or disposal of the product occurs either:
 - (i) through a person who holds an Australian financial services licence authorising the holder to deal in financial products; or
 - (ii) outside this jurisdiction and through a person who is licensed or otherwise authorised to deal in financial products in the relevant place; and


