**Australian Securities and Investments Commission
Corporations Act 2001 — Paragraphs 992B(1)(a), 1020F(1)(a) and
1020F(1)(b) — Revocation and Exemptions**

Revocation

1. Under paragraphs 992B(1)(a), 1020F(1)(a) and 1020F(1)(b) of the *Corporations Act 2001 (the Act)*, the Australian Securities and Investments Commission (*ASIC*) revokes ASIC Instrument [10-0429] dated 7 June 2010 and signed by Cathy Chan.

Exemptions

2. Under paragraph 1020F(1)(a) of the Act, ASIC exempts ING Investment Management Holdings, N.V. and its related bodies corporate (each, an *Issuer*) from Part 7.9 of the Act where the Issuer:
 - (a) makes an eligible offer; or
 - (b) offers to arrange for the issue of financial products under an eligible offer; or
 - (c) issues a financial product under an eligible offer,on the conditions set out in the Schedule and for so long as the conditions are met.
3. Under paragraph 1020F(1)(b) of the Act, ASIC exempts a financial product that is the subject of an eligible offer from Part 7.9 of the Act where:
 - (a) a recommendation is made (by a person other than the Issuer) that a person to whom an eligible offer has been made acquire the financial product as a retail client; and
 - (b) the person who made the recommendation is not aware, and ought not reasonably to be aware, that any of the conditions set out in the Schedule have not been met.
4. Under paragraph 992B(1)(a) of the Act, ASIC exempts the Issuer from section 992A of the Act in relation to eligible offers made in the circumstances covered by paragraph 2 of this instrument made in the course of, or because of, unsolicited meetings or telephone calls reasonably held or made in connection with the eligible offer.

Schedule

The following conditions apply:

1. the Issuer must ensure that the eligible offer is substantially on the terms set out in the Rules of the Plan as at the date of this instrument;
2. the Issuer must:
 - (a) include the offer in an offer document; and
 - (b) take reasonable steps to ensure that any eligible employee to whom the offer is made is given a copy of the offer document; and
 - (c) provide to ASIC a copy of the offer document (which need not contain details of the offer particular to the employee such as the identity or entitlement of the employee)

and of each accompanying document not later than 7 days after the first provision of that material to an employee;

3. the Issuer must ensure that the eligible offer is not offered to or accepted by more than 20 eligible employees who are retail clients under section 761G of the Act;
4. the Issuer must comply with any undertaking required to be made in the offer document by reason of this instrument; and
5. the Issuer must ensure that eligible employees are provided with reasonable access to:
 - (a) the documents under which the Eligible Fund Interests are offered; and
 - (b) information about the price of Eligible Fund Interests.

Interpretation

In this instrument:

1. the Plan shall not be regarded as extended to a person other than an eligible employee only because such an employee may renounce an offer of financial products made to them under the Plan in favour of their nominee;
 2. **current price** means, in relation to an Eligible Fund Interest, the price published as the final buy and sell prices for the previous day on which the Eligible Fund Interest was traded;
 3. **eligible employee** means a person who is, at the time of an eligible offer, a full or part-time employee or director of the Issuer;
 4. **Eligible Fund** means a company or managed investment scheme to which all of the following apply:
 - (a) the Issuer is responsible for making investment decisions with respect to the assets of the relevant company or managed investment scheme;
 - (b) under the terms upon which Eligible Fund Interests are issued:
 - (i) in the case of a company, its net asset value and share price (together, **Value and Share information**); and
 - (ii) in the case of a managed investment scheme, its net asset value and unit price (together, **Value and Unit information**);are generally calculated on a daily basis; and
 - (c) the most recently calculated Value and Share information or Value and Unit information will generally be made available to Participants on the next business day after such information has been calculated;
 5. **Eligible Fund Interest** means a share or interest in an Eligible Fund;
 6. **eligible offer** means an offer for the issue of an Investment Entitlement made under the Plan and extended only to eligible employees;
 7. **Investment Entitlement** as defined in and under the Plan, means an award which is offered on the following terms:

- (a) on the date of the offer, an eligible employee is notified that, upon accepting the offer, he or she may allocate a specified amount of money to notionally acquire Eligible Fund Interests in accordance with the Rules of the Plan at the current price on an investment date specified in the offer document or otherwise notified by the Issuer;
 - (b) all dividends or distributions (*Notional Distributions*) that would be payable in respect of the Eligible Fund Interests that the Participant would have received if he or she had held the Eligible Fund Interests between the date of the offer and a date stated in the offer document (the *Vesting Date*) will be included in the cash amount distributed to Participants on or after the Vesting Date; and
 - (c) on or after the Vesting Date, provided that the vesting conditions set out in the offer document have been satisfied or waived in accordance with the Rules of the Plan, the Participant will receive an amount of cash that is equal to the value, on the Vesting Date, of his or her deemed holding (calculated by reference to the current price of the Eligible Fund Interest on the Vesting Date) plus the Notional Distributions with respect to the Eligible Fund Interest, subject to any adjustments made in accordance with the Rules of the Plan; and
 - (d) the award is issued, and the cash distributed to Participants on or after the Vesting Date will be, for nil consideration;
8. *offer* has a meaning affected by section 1010C of the Act;
9. *offer document* means a document setting out an offer under the Plan that:
- (a) includes or is accompanied by a copy or a summary of the Rules of the Plan. If a summary of the Rules of the Plan is given, during the period (the *Offer Period*) in which an eligible employee may acquire the financial products offered, the Issuer undertakes to, within a reasonable period of the employee so requesting, provide the employee without charge with a copy of the Rules of the Plan;
 - (b) sets out how the cash consideration payable with respect to an Investment Entitlement will be calculated; and
 - (c) specifies the Vesting Date and vesting conditions of the Investment Entitlement;
10. *Participant* means a person who has accepted an eligible offer;
11. *Plan* means an employee incentive scheme that is:
- (a) extended only to eligible employees;
 - (b) governed by the Rules of the Plan; and
 - (c) known as at the date of this instrument as:
 - (i) the ING Investment Management Deferred Compensation Plan (*DCP*); or
 - (ii) the ING Investment Management Retention Participation Plan (*RPP*); and
12. *Rules of the Plan* means the written terms of the Plan that are substantially the same as the terms set out in the following documents provided to ASIC on 11 May 2010:
- (a) the Investment Rules of the DCP and the RPP; and
 - (b) in the case of:
 - (i) the DCP – the DCP Rules and DCP Agreement; and
