**Australian Securities and Investments Commission
Corporations Act 2001 – Paragraph 655A(1)(b) - Declaration**

Under paragraph 655A(1)(b) of the *Corporations Act 2001* (Cth) (*Act*), the Australian Securities and Investments Commission (*ASIC*) declares that Chapter 6 of the Act applies to the person named in Schedule A in the case referred to in Schedule B as if item 7 of section 611 of the Act were modified or varied by deleting paragraph (a) and replacing it with the following paragraph:




