



 - (A) the responsible entity’s reasons for wanting to retire; and
 - (B) such information as can reasonably be expected to be material to a member in forming a view as to the choice of the proposed responsible entity; and

- (C) information about the timing of the proposed retirement of the responsible entity and the manner in which that retirement will occur; and
 - (D) how members can access on the responsible entity's web site current information about the proposed timing of the retirement of the responsible entity and the manner in which that retirement will occur; and
 - (ii) state prominently that if:
 - (A) members who together hold at least 5% of the total value of the interests held by members; or
 - (B) 100 members,

who would be entitled to vote if the proposal were put as a proposed resolution to a meeting of members under paragraph (1)(a), ask for a vote on the choice of the proposed responsible entity by giving written notice received by the responsible entity within 21 days from the date the notice is sent, the responsible entity will either arrange a postal vote or convene a meeting to vote on a resolution for the choice of the proposed responsible entity; and
 - (iii) be accompanied by a form which can be ticked to ask for a vote; and
 - (iv) state prominently a reply paid address of the responsible entity to which the form may be sent.
- (c) The responsible entity must prominently disclose on its web site current information about the proposed timing of the retirement of the responsible entity and the manner in which that retirement will occur.
 - (d) If sufficient members ask for a vote in accordance with the notice, the responsible entity must arrange for a postal vote or, if the responsible entity chooses, convene a meeting in accordance with Part 2G.4 to vote on the choice of the proposed responsible entity as soon as possible.
 - (e) If there is a postal vote:

- (i) a voting paper must be sent to each member stating a reply paid address of the responsible entity to which the voting paper may be sent;
 - (ii) the responsible entity must notify the members in, or in a document accompanying, the voting paper that:
 - (A) the proposed responsible entity will be chosen as the new responsible entity if at least 50% of the total votes that may be cast by members that would be eligible to vote at a meeting under paragraph (1)(a) are cast in favour of the choice; and
 - (B) only votes received by the responsible entity within 28 days after the issue of the voting paper will be counted.
 - (f) If a meeting is convened the resolution to choose the new responsible entity must be an extraordinary resolution if the scheme is not listed.”; and
- 3. insert after subsection (2), the following subsections:
 - “(2A) If a postal vote is arranged under paragraph (1A)(d) and at least 50% of the total votes that may be cast by members that would be eligible to vote at a meeting under paragraph (1)(a) are cast in favour of the proposed responsible entity, that entity is taken for the purposes of subsection (2) to have been chosen by a resolution of members on the last day on which postal votes may be received in order to be counted.
 - (2B) If:
 - (a) a related body corporate is proposed to be the new responsible entity in accordance with subsection (1A); and
 - (b) sufficient members do not ask for a vote to choose the entity in accordance with the notice referred to in paragraph (1A)(b); and
 - (c) the entity has consented in writing to becoming the scheme’s responsible entity,then:

- (c) any registrable superannuation entity registered by the Australian Prudential Regulation Authority.

Investor directed portfolio service means an arrangement under which an Australian financial services licensee acquires and holds financial products on behalf of another person and implements investment decisions on behalf of, or at the direction of, the other person.

Redemption Scheme means the following arrangements as described in the Explanatory Memorandum for each Fund:

- (a) the withdrawal facility for each Fund before 31 December 2010 under which:
 - (i) members may elect to withdraw their interests in the relevant Fund; and
 - (ii) Small Balance Members in each Fund may elect to withdraw all of their interests in the relevant Fund in priority to withdrawals of other members; and
- (b) subsequent withdrawal facilities for each Fund under which members may elect to withdraw their interests in the relevant Fund up to a maximum aggregate limit determined by CMIL from 1 January 2011; and
- (c) subsequent facilities under which Small Balance Members in each Fund may elect to withdraw all of their interests in the relevant Fund from 1 January 2011.

Registrable superannuation entity means a registrable superannuation entity as defined in section 10 of the *Superannuation Industry (Supervision) Act 1993 (Cth)*, as amended from time to time.


Small Balance means a number of interests in the relevant Fund equal to or less than the threshold determined by CMIL in respect of each of the Funds in the manner described in the Explanatory Memorandum for the relevant Fund.

The responsible entity of a registered scheme may allow a member to withdraw from the scheme:

- (a) where:

- (i) the registered scheme holds interests in another registered scheme (*underlying fund*);
- (ii) the responsible entity of the underlying fund makes a withdrawal offer, opportunity or facility under which interests in the underlying fund may be withdrawn (*underlying fund withdrawal offer*);

3. **approved foreign market** means NYSE Euronext Paris;
4. **Australian dollar equivalent** in relation to a price, means a price calculated by reference to the relevant exchange rate published by an Australian bank no earlier than the business day before the day to which the price relates;
5. **current market price** means in relation to a share, the price published by the Euronext Paris as the final price for the previous day on which the share was traded on that financial market;
6. **eligible employee** means, in relation to an issuer, a person who is at the time of an offer under an employee share scheme, a full or part-time employee or director of the issuer or of a related body corporate of the issuer;
7. **eligible offer** means an offer:
 - (a) to issue or transfer fully-paid shares in the issuer; or
 - (b) to issue a financial product that relates to fully-paid shares in the issuer, where the shares are in the same class as shares which have been quoted on an approved foreign market throughout the 12 month period immediately before the offer without suspension for more than a total of 2 trading days during that period and made under the employee share scheme, described as the Group Savings Plan, on terms not significantly different to those described in a letter to ASIC dated 12 August 2010 from Freehills on behalf of the issuer, extended only to eligible employees of the issuer;
8. **financial product advice** has the meaning given by section 766B;
9. **general advice** has the meaning given by section 766B;
10. **Group Savings Plan** means the Veolia Environnement International Group Savings Plan;
11. **issuer** means Veolia Environnement, a company registered in France;
12. **offer** has a meaning affected by sections 700, 702 and 1010C of the Act;

13. **offer document** means a document setting out an offer under an employee share scheme that:
- (a) includes or is accompanied by a copy or summary of the Rules under which the offer is made; and
 - (b) if a summary (rather than a copy) of the Rules is given - includes an undertaking that during the period (the offer period) during which an eligible employee domiciled in this jurisdiction may acquire the financial products offered, the issuer through Veolia Environnement will, within a reasonable period of the employee so requesting, provide the employee without charge with a copy of the Rules; and
 - (c) specifies in respect of the shares:
 - (i) the acquisition price in Australian dollars;
 - (ii) where the acquisition price is specified in a foreign currency, the Australian dollar equivalent of that price at the date of the offer; or
 - (iii) where the acquisition price is to be worked out in the future under a formula, the Australian dollar or Australian dollar equivalent of that price were that formula applied at the date of the offer; and
 - (d) includes an undertaking, and an explanation of the way in which, the issuer through Veolia Environnement will, during the offer period, within a reasonable period of the employee requesting, make available to the employee:
 - (i) the current market price (or, where that price is denominated in a foreign currency, the Australian dollar equivalent of that price) of shares in the same class as those offered; and
 - (ii) where subparagraph (c)(ii) or (iii), the information referred to in that paragraph as updated to that date; and
 - (e) discloses the conditions, obligations and risks associated with any loan or financial assistance offered by the issuer or a related body corporate of the issuer for the purpose of acquiring financial products under the Group Savings Plan; and
 - (f) states prominently that the eligible offer is an offer for participation in a foreign scheme that is subject to the regulation of the Relevant Agency and to the law of France and describes the legal and practical effect (if any) this may have on the rights and ability of an eligible employee domiciled in this jurisdiction to make any claim or enforce any right arising out of or in connection with the eligible offer;
14. **Rules** means the rules of the Group Savings Plan dated 5 July 2002, as amended from time to time;
15. **Veolia Environnement** means Veolia Environmental Services (Australia) Pty Ltd ACN 051 316 584.
