Australian Securities and Investments Commission
Corporations Act 2001 (Cth) – Paragraphs 911A(2)(a), 992B(1)(a), 1020F(1)(a)
and 1020F (1)(b)– Exemption

- 1 Under paragraph 1020F(1)(a) of the *Corporations Act 2001* (the *Act*), the Australian Securities and Investments Commission (*ASIC*) exempts the Issuer from Part 7.9 of the Act where the Issuer:
 - (a) makes an eligible offer; or
 - (b) offers to arrange for the issue of financial products under an eligible offer; or
 - (c) issues a financial product under an eligible offer,on the conditions set out in the Schedule and for so long as the conditions are met.
- 2 Under paragraph 1020F(1)(b) ASIC exempts a financial product that is the subject of an eligible offer from Part 7.9 where:
 - (a) a recommendation is made (by a person other than the Issuer) that a person to whom an eligible offer has been made acquire the financial product as a retail client; and
 - (b) the person who made the recommendation is not aware, and ought not reasonably be aware, that any of the conditions set out in the Schedule have not been met.
- 3 Under paragraph 911A(2)(a) of the Act, ASIC exempts the Issuer from the requirement to hold an Australian financial services licence for the provision of the following financial services:
 - (a) dealing in a financial product in connection with an eligible offer covered by the exemption in paragraph 1 of this instrument; and
 - (b) general advice reasonably given in connection with an eligible offer covered by the exemption in paragraph 1 of this instrument (including any general advice given in the offer document) where the offer document for an eligible offer includes a statement to the effect that any advice given by the Issuer in connection with an eligible offer is general advice only, and that employees should consider obtaining their own financial product advice from an independent person who is licensed by ASIC to give such advice.
- 4 Under paragraph 992B(1)(a) of the Act, ASIC exempts the Issuer from section 992A of the Act in relation to eligible offers covered by the exemption in paragraph 1 of this instrument made in the course of, or because of,

unsolicited meetings or telephone calls reasonably held or made in connection with the eligible offer.

Schedule

The following conditions apply:

- 1 the Issuer must ensure that the eligible offer is substantially on the terms set out in the Plan Rules.
- 2 the Issuer must:
 - (a) include the eligible offer in an offer document; and
 - (b) take reasonable steps to ensure that any eligible employee to whom an eligible offer is made is given a copy of the offer document; and
 - (c) provide to ASIC a copy of the offer document (which need not contain details of an eligible offer particular to the employee such as the identity or entitlement of the employee) and of each accompanying document not later than 7 days after the first provision of that material to an employee.
- 3 the Issuer must comply with any undertaking required to be made in the offer document by reason of this instrument.
- 4 the Issuer must take reasonable steps to ensure that the number of ordinary shares of the Issuer notionally underlying the Options the subject of the offer, when aggregated with:
 - (a) the number of ordinary shares of the Issuer notionally underlying all Options then outstanding; and
 - (b) the number of shares in the same class which would be issued were each outstanding offer with respect to shares, units of shares and options to acquire unissued shares, under an employee share scheme to be accepted or exercised; and
 - (c) the number of shares in the same class issued during the previous 5 years pursuant to the employee share scheme or any other employee share scheme extended only to eligible employees of the issuer; and
 - (d) the number of ordinary shares of the Issuer notionally underlying Options exercised during the previous 5 years,but disregarding any offer made, or option acquired or share or Option issued by way of or as a result of:
 - (e) an offer to a person situated at the time of receipt of the offer outside this jurisdiction; or

- (f) an offer that was an excluded offer or invitation within the meaning of the Corporation Law as in force before the commencement of Schedule 1 to the *Corporate Law Economic Reform Program Act 1999*; or
- (g) an offer that did not need disclosure to investors because of section 708; or
- (h) an offer that did not require the giving of a Product Disclosure Statement because of section 1012D; or
- (i) an offer made under a disclosure document or Product Disclosure Statement,

must not exceed 5% of the total number of issued shares in that class of the Issuer as at the time of the offer.

- 5 except as may be required by the laws of England and Wales, the Issuer must not modify or vary the Rules of any Plan in any material respect which would adversely affect the rights and interests of an eligible employee unless it notifies ASIC and ASIC notifies the Issuer in writing that it does not object to the modification or variation.
- 6 the Issuer must take all reasonable steps to ensure that the Rules of each Plan are complied with.
- 7 the Issuer must take all reasonable steps to ensure that each Plan at all times complies with the laws of England and Wales.

Note: where a document must be provided in writing it may be provided by electronic means. See s5C of the Act and s25 of the *Acts Interpretation Act 1901*.

Interpretation

In this instrument:

- 1 except where otherwise stated, references to provisions are to provisions of the Act.
- 2 the Plan or any other employee share scheme shall not be regarded as extended to a person other than an eligible employee only because such an employee may renounce an eligible offer of financial products made to them under the Plan in favour of their nominee.
- 3 ***associated body corporate*** of the Issuer means:
 - (a) a body corporate that is a related body corporate of the Issuer; or
 - (b) a body corporate that has voting power in the Issuer of not less than 20%; or

- (c) a body corporate that in which the Issuer has a voting power of not less than 20%.
- 4 **Australian dollar equivalent** – in relation to a price, means a price calculated by reference to the relevant exchange rate published by an Australian bank no earlier than the business day before the day to which the price relates.
- 5 **current market price** means, in relation to ordinary shares of the Issuer on any day, the middle market quotation for an ordinary share taken from the Daily Official List of the London Stock Exchange (the **LSE**) for the previous day on which the ordinary shares were traded on that financial market.
- 6 **eligible employee** means a person who is, at the time of an eligible offer, a full or part time employee or director of the Issuer or of an associated body corporate of the Issuer.
- 7 **eligible offer** means an offer made under the Plan for the issue of an Option for nil consideration.
- 8 **financial product advice** has the meaning given by section 766B of the Act.
- 9 **general advice** has the meaning given by section 766B of the Act.
- 10 **Issuer** means BG Group plc (Registered in England & Wales No. 3690065).
- 11 **offer** has a meaning affected by section 1010C of the Act.
- 12 **offer document** means a document setting out an eligible offer under the Plan that:
- (a) includes or is accompanied by a copy, or a summary, of the rules of the Plan; and
 - (b) if a summary (rather than a copy) of the rules of the Plan is given - includes an undertaking that during the period (the **offer period**) during which an eligible employee may acquire Options that are offered, the Issuer will, within a reasonable period of the employee so requesting, provide the employee without charge with a copy of the rules of the Plan; and
 - (c) specifies the circumstances in which an eligible employee may receive a cash amount in connection with the Option and how the cash amount will be calculated; and
 - (d) in respect of an eligible offer, specifies:
 - (i) how the cash consideration payable under the Option will be calculated;
 - (ii) the vesting date and vesting conditions of the Option; and
 - (iii) the conditions of exercise of the Option.

- 13 **Option** means a contractual right to receive a payment of a cash amount:
- (a) calculated by reference to the current market price at a specified time; and
 - (b) equal to the amount of dividends or distributions paid on ordinary shares of the Issuer,
- in accordance with the rules of the Plan, less any tax or other payment that the Issuer is required to withhold, where the conditions set out in the terms of the Options have been satisfied or waived in accordance with the rules of the Plan.
- 14 **Plan** means an employee incentive plan extended only to eligible employees of the Issuer referred to at the date of this instrument as the "[BG Group Bonus Deferral Plan]", or by whatever name it is known from time to time provided that the rules of the employee incentive plan are substantially the same the Plan Rules.
- 15 **Plan Rules** means the written terms of the Plan that are substantially in the terms set out in the draft "[BG Group Bonus Deferral Plan Rules]" provided to ASIC as an attachment to an email dated 17 September 2010.







3. omit paragraph 601FD(1)(c), 601FD(1)(d) and 601FD(1)(e) and substitute:
 - “(c) act in the best interests of members (having regard to their interests as holders of interests in the scheme and as holders of interests in other schemes, where interests in each of the schemes are components of a stapled security) and, if there is a conflict between the members’ interests and the interests of the responsible entity, give priority to the members’ interests; and
 - (d) not make use of information acquired through being an officer of the responsible entity in order to:

 - “(9A) the responsible entity may set the issue price of interests in the scheme that are components of stapled securities where all of the following apply:
 - (a) the constitution makes provision for the issue price of stapled securities;
 - (b) the constitution provides that the responsible entity may allocate a proportion of the issue price of the stapled securities to the interests;

- (c) the stapled securities are issued at a price, or in accordance with a formula or method that is to be used to calculate the issue price of stapled securities, which is set out in the scheme constitution;
 - (d) the responsible entity allocates a proportion of the issue price of the stapled securities to the interests in accordance with the constitution.”; and
- 7. insert after subsection 208(2) of the Act as notionally inserted by section 601LC:
 - “(2A) Member approval is not required for the giving of a financial benefit and the benefit need not be given within 15 months if:
 - (a) the benefit either:
 - (i) is given out of the scheme property of a registered scheme (the *Scheme*); or
 - (ii) could endanger the Scheme property; and
 - (b) all of the interests in the Scheme and all of the interests in one or more other registered schemes (the *Other Schemes*) are components of stapled securities; and
 - (c) the benefit is given by:
 - (i) the responsible entity of the Scheme; or
 - (ii) an entity that the responsible entity controls; or
 - (iii) an agent of, or person engaged by, the responsible entity; and
 - (d) the benefit is given to:
 - (i) an entity wholly owned, whether directly or indirectly, by the Scheme; or
 - (ii) the Other Schemes or an entity wholly owned, whether directly or indirectly, by the Other Schemes; or
 - (iii) an entity wholly owned, whether directly or indirectly, jointly by the Scheme and one or more of the Other Schemes.

- (a) an entity is wholly owned by another entity if all of the shares or interests (as applicable) in the first-mentioned entity are held by, or held by a nominee for (in the case of the second-mentioned entity being a company), or form part of the trust property of (in the case of the second-mentioned entity being a trust), the second-mentioned entity or a wholly owned entity of it; and
 - (b) a reference to the giving of a benefit to an entity which is a trust is a reference to the giving of a benefit to the trustee of the trust so as to form part of the trust property of the trust or for the benefit of the trust beneficiaries.”; and
8. insert after section 601PC:

“601PD For the purposes of sections 601FC, 601FD, 601FE and 601LC:

stapled security means two or more financial products including at least one interest in a registered scheme where:

- (a) under the terms on which each of the products are to be traded, they must be transferred together; and
- (b) there are no financial products in the same class as those financial products which may be transferred separately.”.
