## Australian Securities and Investments Commission Corporations Act 2001 – Paragraphs 601QA(1)(a), 911A(2)(l) and 1020F(1)(a) – Exemption

## **Enabling provisions**

1. The Australian Securities and Investments Commission (ASIC) makes this instrument under paragraphs 601QA(1)(a), 911A(2)(l) and 1020F(1)(a) of the Corporations Act 2001 (Act).

#### **Exemptions**

- 2. CSEAL and BIPL in its capacity as general partner for BIP does not have to comply with:
  - (a) section 601ED of the Act in relation to a Sale Facility; and
  - (b) Divisions 2 to 5 of Part 7.9 of the Act in relation to an interest in a Sale Facility; and
  - (c) the requirement to hold an Australian financial services licence for the provision of the following financial services:
    - (i) dealing in an interest in a Sale Facility or BIP Interests in connection with a Sale Facility; and
    - (ii) the provision of general advice in relation to an interest in a Sale Facility or BIP Interests in connection with a Sale Facility.
- 3. To avoid doubt, to the extent CSEAL or BIPL invites a holder of a Stapled Security to make an offer to sell BIP Interests through a Sale Facility or makes an offer to purchase BIP Interests through a Sale Facility, CSEAL or BIPL does not have to comply with Division 5A of Part 7.9 of the Act.

#### Where relief applies

- 4. The exemptions in paragraphs 2 and 3 apply in relation to a Sale Facility where that facility satisfies all of the following:
  - (a) under the terms of a Sale Facility:
    - (i) cash to be provided to participating holders under a Sale Facility is derived from:
      - (A) a cash contribution of US\$300 million from Brookfield Asset Management Limited or its wholly owned subsidiary; and

- (B) to the extent that the cash contribution is insufficient, the sale of BIP Interests in a manner that complies with subparagraph 6(a) of ASIC Class Order [CO 08/10], in accordance with the terms of a Sale Facility;
- (ii) the proceeds of the sale net of expenses (to the extent (if any) that they are not met by CSEAL or BIPL) are distributed to participating holders; and
- (iii) each participating holder is paid their proportion of the proceeds of sale, in accordance with the terms of a Sale Facility which applies to the Schemes and the Takeover respectively, as soon as practicable and, in any event, within 8 weeks after the final date for receiving elections to participate in the Liquidity Facility or within 8 weeks of the date that participating holders are deemed to participate in the Foreign Holders Facility, as the case may be.

## Conditions of the relief

- 5. In order to rely on the exemptions in paragraphs 2 or 3, CSEAL or BIPL must:
  - (a) at the time the Scheme Booklet is despatched to holders of a Stapled Security in relation to the Schemes, give or send to each holder of a Stapled Security who have been invited to participate in the Liquidity Facility for the Schemes, a document which complies with paragraph 6, by:
    - (i) giving the document to the holder personally; or
    - (ii) sending the document:
      - (A) by post to the address for the holder in the register of members of PIT and PIT2 or an alternative address (if any) nominated by the holder; or
      - (B) to the fax number or electronic address (if any) nominated by the holder; and
  - (b) take reasonable steps to ensure that the Liquidity Facility and Foreign Holders Facility is not operated during any period where a control transaction has been publicly proposed and has not ended; and
- 6. The document:
  - (a) must contain the following statements and information:

- (i) a statement that the Liquidity Facility is open until the expiry date set out in the document, which cannot be more than 12 months after the date of the document; and
- (ii) information about the minimum and maximum number (if any) of BIP Interests a participating holder can sell through the Liquidity Facility; and
- (iii) a statement that the market price of BIP Interests is subject to change from time to time; and
- (iv) a statement that a holder of BIP Interests may be able to sell or dispose of their BIP Interests following the BIP Interests being quoted on TSX and NYSE at a price higher or lower than the price they would receive if they were to sell or dispose of their BIP Interests through the Liquidity Facility; and
- (v) information about how to obtain up-to-date information on the market price of BIP Interests; and
- (vi) information about any expenses relating to the sale or purchase of BIP Interests that will be paid by the participating holders; and
- (vii) information about how the proceeds of sale for BIP Interests sold through the Liquidity Facility will be allocated between participating holders; and
- (viii) a statement that the amount of money received by a participating holder for BIP Interests that are sold through the Liquidity Facility may be more or less than the actual price that is received by the broker for those BIP Interests; and
- (ix) information about any other significant characteristics or features of the Liquidity Facility or of the rights and obligations of holders who elect to participate in the Liquidity Facility; and
- (x) information about any alternatives that the holder may have to participating in the Liquidity Facility; and
- (b) must be worded and presented in a clear, concise and effective manner; and
- (c) may be given in printed or electronic form and, if given in electronic form, must, as far as practicable, be given in a way that will allow the holder to print or save a copy of it; and

- (d) may be made up of 2 or more separate documents that are given at the same time and by the same means; and
- (e) may form part of another document including the Scheme Booklet in relation to the Schemes.

## **Exclusion from reliance**

7. CSEAL and BIPL are excluded from relying on subparagraph 2(c) of this instrument if it becomes aware of matters that give it reason to believe that it has failed in a material respect to comply with a condition of this instrument and does not give full particulars of the failure to ASIC in writing within 15 business days after becoming so aware.

#### Interpretation

In this instrument:

**Bidder's Statement** means the bidder's statement in relation to a takeover offer for all of the Stapled Securities (other than those held by BIP IV) to be made by BIPL dated on 27 September 2010.

**BIP** means Brookfield Infrastructure Partners L.P, a limited partnership formed under the laws of Bermuda.

BIP Interest means a limited partnership interests in BIP.

**BIP IV** means BIP Bermuda Holdings IV Limited, a company incorporated in Bermuda.

**BIPL** means Brookfield Infrastructure Partners Limited, a company incorporated in Bermuda, in its capacity as general partner of BIP.

CSEAL means Credit Suisse Equities (Australia) Limited ACN 068 232 708.

control transaction means a transaction or proposed transaction that affects the control or potential control of Prime Group excluding the Schemes and Takeover.

**Explanatory Memorandum** means a document which meets the content requirements of a prospectus that will be sent to holders of Stapled Securities on or about 5 October 2010.

facility has a meaning affected by section 762C of the Act.

holder has the meaning given by section 761A of the Act.

Foreign Holders Facility means a facility described in the Bidder's Statement or Explanatory Memorandum under which ineligible foreign holders of Stapled Securities accepting the Takeover or participating in the Schemes will receive cash in lieu of BIP Interests.

Liquidity Facility means a facility described in the Explanatory Memorandum to enable holders of Stapled Securities to elect to receive cash in lieu of all or some of the BIP Interests in which they would otherwise be entitled to receive in exchange for their Stapled Securities under the Schemes.

NYSE means the New York Stock Exchange.

participating holder means a person who holds Stapled Securities and has elected to participate in the Liquidity Facility or is deemed to participate in the Foreign Holders Facility.

PIHL means Prime Infrastructure Holdings Limited ACN 100 364 234

PIT means Prime Infrastructure Trust ARSN 100 375 479

PIT2 means Prime Infrastructure Trust 2 ARSN 108 288 204.

Prime Group means PIHL, PIT and PIT2

register of members means the register of members required to be set up and maintained under section 169 of the Act.

**Sale Facility** means either the Foreign Holders Facility or Liquidity Facility as described in the Bidder's Statement for the Takeover and the Explanatory Memorandum for the Schemes.

#### Stapled Security means:

- (a) an ordinary share in PIHL;
- (b) an interest in PIT; and
- (c) an interest in PIT2

which, under the terms on which each is to be traded, must only be transferred together.

**Schemes** means an arrangement (together with a scheme of arrangement in relation to PIHL under Part 5.1 of the Act) under which all the units in PIT and PIT2 not currently held by BIP IV will be acquired by BIP, where the acquisition is approved by resolutions passed at a meeting of members of PIT and PIT2:

# Australian Securities and Investments Commission Corporations Act 2001 – Paragraphs 911A(2)(l) and 1020F(1)(a) –Exemption

Under paragraph 911A(2)(l) of the Act, ASIC exempts the person specified in Schedule A from the requirement to hold an Australian financial services licence for the provision of financial services, in the case specified in Schedule C on the conditions specified in Schedule E for so long as they are met.
- 4. Under paragraph 1020F(1)(a) of the Act, ASIC exempts the person specified in Schedule A from compliance with Part 7.9 of the Act, other than Divisions 5 and 5A of Part 7.9, in the case specified in Schedule D on the conditions specified in Schedule E for so long as they are met.

- 10. provide answers to the questions, other than subsubparagraphs 2(a)(iii), (2)(b)(i), (2)(d)(i) and (2)(d)(iii), of Schedule F to ASIC Class Order [CO 02/303], as in force on the date of this instrument and as amended from time to time by a disallowable legislative instrument within the meaning of the *Legislative Instrument Act 2003*, sufficiently to enable a typical investor in the interests in the Scheme to make an informed decision whether to invest in an interest in the Scheme; and
- 11. a prominent statement to the effect that a person should consider whether to consult:
  - (a) an investment adviser who is either a financial services licensee or an authorised representative of a financial services licensee;
  - (b) a taxation adviser; and
  - (c) a lawyer,




