**Australian Securities and Investments Commission
Corporations Act 2001 - Paragraph 655A(1) –Declaration**

1. Under paragraph 655A(1) of the Corporations Act 2001 (*Act*), the Australian Securities and Investments Commission (*ASIC*) declares that Chapter 6 of the Act applies to the person specified in Schedule A in the case specified in Schedule B as if subsection 605(1) were modified by inserting the following words at the end of the subsection:

“Despite this subsection and subsection 617(1), takeover bids may be made in relation to (and compulsory acquisition rights operate on) multiple classes of securities where the securities are sufficiently similar that the holders have a community of interest.”

And subsection 619(1) were modified by inserting the following words at the end of the subsection:

“Where an off market bid is made for a bid class consisting of merged classes of securities, the offers made under the bid may be different provided that the offers are equitable between the merged classes having regard to the rights and obligations attaching to the classes.”

Apollo C-Class Option means an unquoted option granted pursuant to the Apollo Employee Share Option Plan at a Vesting Hurdle price of A\$0.40 to acquire, upon exercise, one new Apollo Share at an exercise price of A\$0.30.

Apollo D-Class Option means an unquoted option granted pursuant to the Apollo Employee Share Option Plan at a Vesting Hurdle price of A\$0.60 to acquire, upon exercise, one new Apollo Share at an exercise price of A\$0.30.

Apollo E-Class Option means an unquoted option granted pursuant to the Apollo Employee Share Option Plan at a Vesting Hurdle price of A\$0.80 to acquire, upon exercise, one new Apollo Share at an exercise price of A\$0.30.


Apollo G-Class Option means an unquoted option granted pursuant to the Apollo Employee Share Option Plan with a vesting date of 10 August 2011 to acquire, upon exercise, one new Apollo Share at an exercise price of A\$0.5909.

Apollo H-Class Option means an unquoted option granted pursuant to the Apollo Employee Share Option Plan with a vesting date of 10 August 2012 to acquire, upon exercise, one new Apollo Share at an exercise price of A\$0.5909.

Australian Securities and Investments Commission
Corporations Act 2001 (Cth) - Subsections 741(1)(a) and 1020F(1)(a) - Exemption

1. Pursuant to subsections 741(1)(a) and 1020F(1)(a) of the Corporations Act 2001 (Cth) (“**Act**”), the Australian Securities and Investments Commission (“**ASIC**”) exempts:
 - (a) the following persons:
 - (i) the Issuer; and
 - (ii) the Plan Trustee,from Parts 6D.2, 6D.3 (except section 736) and 7.9 where the person:
 - (iii) makes an eligible offer (“**Offer**”);
 - (iv) offers to arrange for the issue of financial products under an eligible offer; and
 - (v) issues a financial product under an eligible offer,that does not involve a contribution plan, on the conditions set out in the Schedule and for so long as the conditions are met; and
 - (b) a person (other than a person covered by paragraph (a)) from Part 7.9 of the Act where the person makes a recommendation to acquire financial products under an eligible offer that does not involve a contribution plan, except where the person is aware, or ought reasonably to be aware, that any of the conditions set out in the Schedule have not been met.
 2. Under paragraph 911A(2)(1) of the Act, ASIC exempts the Issuer from the requirement to hold an Australian financial services licence for the provision of a financial service consisting of general advice reasonably given in connection with an eligible offer covered by paragraph 1 of this instrument (including any general advice given in the offer document), where the offer document for the offer includes a statement to the effect that any advice given by the Issuer in connection with the offer is general advice only, and that employees should consider obtaining their own financial product advice from an independent person who is licensed by ASIC to

give that advice on the conditions set out in the Schedule and for so long as the conditions are met.

3. Under paragraph 911A(2)(1) of the Act, ASIC exempts the Plan Trustee from the requirement to hold an Australian financial services licence for the provision of the following financial services:
 - (a) the provision of a custodial or depositary service in connection with an eligible offer covered by paragraph 1 of this instrument where the provider of the service performs its duties in good faith and has sufficient resources to perform those duties;
 - (b) dealing in a financial product in the course of providing a custodial or depositary service covered by paragraph (c); and
 - (c) dealing in a financial product in connection with an eligible offer covered by paragraph 1 of this instrument,on the conditions set out in the Schedule and for so long as the conditions are met.
4. Under paragraphs 741(1)(a) and 992B(1)(a) ASIC exempts the Issuer from sections 736, 992A and 992AA of the Act in relation to eligible offers covered by paragraph 1 of this instrument made in the course of, or because of, unsolicited meetings or telephone calls reasonably held or made in connection with the offer on the conditions set out in the Schedule and for so long as the conditions are met.

Schedule

The following conditions apply:

1. the Issuer must:
 - (a) include that offer in an offer document; and
 - (b) take reasonable steps to ensure that any eligible employee to whom the offer is made is given a copy of the offer document; and
 - (c) provide to ASIC a copy of the offer document (which need not contain details of the offer particular to the employee such as the identity or entitlement of the employee) and of each accompanying document not later than 7 days after the first provision of that material to an employee; and
2. the Issuer must comply with any undertaking required to be made in the offer document by reason of this instrument; and
3. in the case where any Plan may involve the issue of shares (including as a result of the exercise of an option), the Issuer must take reasonable steps to ensure that the number of shares the subject of the offer or to be received on exercise of an option when aggregated with:

- (a) the number of shares in the same class which would be issued were each outstanding offer with respect to shares, units of shares and options to acquire unissued shares under the Plan to be accepted or exercised; and
- (b) the number of shares in the same class issued during the previous 5 years under the Plan or any other employee share scheme extended only to eligible employees of the Issuer,

but disregarding any offer made, or option acquired or share issued by way of or as a result of:

- (c) an offer to a person situated at the time of receipt of the offer outside this jurisdiction; or
- (d) an offer that was an excluded offer or invitation within the meaning of the Corporations Law as in force before the commencement of Schedule 1 to the *Corporate Law Economic Reform Program Act 1999*; or
- (e) an offer that did not need disclosure to investors because of section 708; or
- (f) an offer that did not require the giving of a Product Disclosure Statement because of section 1012D; or
- (g) an offer made under a disclosure document or Product Disclosure Statement,

does not exceed 5% of the total number of issued shares in that class of the Issuer as at the time of the offer; and

4. in the case where an offer of shares is made through a trust:

- (a) the Plan Trustee must hold the shares on trust for each person (a “**beneficiary**”) who acquires units of shares under an eligible offer; and
- (b) the Plan Trustee must cause proper written financial records to be maintained in respect of the activities of the Plan Trust and cause those records to be audited annually and made available for inspection by the beneficiaries at an office of the Plan Trustee or a place of business of the Issuer during normal business hours or such other time as is agreed with beneficiaries; and
- (c) the Plan Trustee must ensure that each share to which a unit held by a beneficiary relates is identified in the written financial records as being held on account of that beneficiary; and
- (d) the Plan Trustee must not levy any fees or charges for operating and administering the Plan Trust, either payable directly by the beneficiaries or out of the assets of the Plan Trust; and
- (e) except as expressly provided by the Plan Trust Deed, a beneficiary must have the capacity to authorise the Plan Trustee to sell at or above the current market price the shares to which he or she is entitled to under the deed; and

- (f) the Plan Trustee must provide a copy of the Plan Trust Deed to ASIC at the same time as a copy of the offer document is provided to ASIC in accordance with this instrument; and
- (g) the Issuer must ensure that the Plan Trust Deed contains covenants binding the Plan Trustee and their agents, if any, to the effect that a beneficiary possesses substantially the same rights in respect of the shares to which the units of shares they hold relate as if they were the legal owner of the shares, including the right to:
 - (i) direct the Plan Trustee how the voting rights attaching to the shares shall be exercised, either generally or in any particular case; and
 - (ii) receive the income deriving from the shares, including dividends declared by the Issuer in respect of those shares.

Note: where a document must be provided in writing it may be provided by electronic means. See s5C of the Act and s25 of the *Acts Interpretation Act 1901*.

Interpretation

In this instrument:

1. except where otherwise stated, references to provisions are to provisions of the Act;
2. the Plan or any other employee share scheme shall not be regarded as extended to a person other than an eligible employee only because such an employee may renounce an offer of financial products made to them under the scheme in favour of their nominee;
3. **associated body corporate** of the Issuer means:
 - (a) a body corporate that is a related body corporate of the Issuer; or
 - (b) a body corporate that has voting power in the Issuer of not less than 20%; or
 - (c) a body corporate in which the Issuer has voting power of not less than 20%;
4. **Australian dollar equivalent** in relation to a price, means a price calculated by reference to the relevant exchange rate published by an Australian bank no earlier than the business day before the day to which price relates;
5. **current market price** means, in relation to a share, the price published by the operator of the principal financial market on which the share is quoted as the final price for the previous day on which the share was traded on that financial market;
6. **eligible employee** means, in relation to the Issuer, a person who is, at the time of an eligible offer under the Plan, a full or part-time employee or director of the Issuer or of an associated body corporate of the Issuer;

7. *eligible offer* means an offer for issue or sale of:

- (a) fully-paid shares in the Issuer in the same class as shares which have been quoted on the financial market operated by the Australian Securities Exchange throughout the period since listing of the Company, ending immediately before the offer without suspension for more than a total of 2 trading days during that period; or
- (b) options for the issue or transfer of shares referred to in paragraph (a) where each of the options is offered for no more than nominal consideration; or
- (c) units of fully-paid shares referred to in paragraph (a),

made under the Plan extended only to eligible employees of the Issuer;

Note: the effect of paragraph (c) of the definition of “eligible offer” is that the First Exemption will only apply to offers made through a trust where the underlying financial products held by the Plan Trustee are fully-paid shares and not, for example, options or stapled securities.

8. *financial product advice* has the meaning given by section 766B;

9. *general advice* has the meaning given by section 766B; and

10. *Issuer* means QR National Limited (ACN 146 335 622);

11. *offer* has a meaning affected by sections 700, 702 and 1010C;


12. *offer document* means a document setting out an offer under a Plan that:

- (a) includes or is accompanied by a copy, or a summary, of the rules of the Plan; and
- (b) if a summary (rather than a copy) of the rules of the Plan is given - includes an undertaking that during the period (the “**offer period**”) during which an eligible employee may acquire the financial products offered or exercise options acquired under the Plan, the Issuer will, within a reasonable period of the employee so requesting, provide the employee without charge with a copy of the rules of the Plan; and
- (c) specifies in respect of the shares, shares subject to the options, or units of shares:
 - (i) the acquisition price in Australian dollars; or
 - (ii) where the acquisition price is specified in a foreign currency, the Australian dollar equivalent of that price at the date of the offer; or
 - (iii) where the acquisition price is to be worked out in the future under a formula, the Australian dollar or Australian dollar equivalent of that price were that formula applied at the date of the offer; and

- (d) includes an undertaking, and an explanation of the way in which, the Issuer will, during the offer period, within a reasonable period of the employee requesting, make available to the employee:
- (i) the current market price (or, where that price is denominated in a foreign currency, the Australian dollar equivalent of that price) of shares in the same class as those offered, subject to the options or to which the units relate; and
 - (ii) where subparagraph (c)(ii) or (iii) applies, the information referred to in that paragraph as updated to that date; and
- (e) discloses the conditions, obligations and risks associated with any loan or financial assistance offered by the Issuer or any associated body corporate of the Issuer for the purpose of acquiring financial products under the Plan; and
13. **Plan** means the following plans:
- (a) Omnibus Equity Plan (Rights and Options); and
 - (b) Employee Share Acquisition (Tax Exempt) Plan,
- as governed by the respective Plan Rules;
14. **Plan Rules** means the written terms of the Plans that are substantially in the terms set out in the Plan Rules provided to ASIC on 19 October 2010;
15. **Plan Trust** means a trust established by the Issuer under the Plan Trust Deed where the terms of the Plan Trust are substantially in the terms set out in the draft terms of the Plan Trust Deed;
16. **Plan Trustee** means the trustee of the Plan Trust appointed by the board of the Issuer from time to time, initially to be CPU Share Plans Pty Limited (ACN 081 600 875);
17. **Plan Trust Deed** means the trust deed in respect of the Plans as provided to ASIC on 19 October 2010; and
18. **unit** in relation to a share means a legal or equitable right or interest in the share.


