**Australian Securities and Investments Commission  
Corporations Act 2001 - Paragraphs 601QA(1)(a) and 1020F(1)(c) - Exemption  
and Declaration**

1. Under paragraph 601QA(1)(a) of the *Corporations Act 2001 (Act)*, the Australian Securities and Investments Commission (*ASIC*) exempts the person specified in Schedule A from paragraph 601FC(1)(d) of the Act to the extent that it requires the responsible entity of a registered scheme to treat members who hold interests in the same class equally in the case specified in Schedule B.
2. Under paragraph 1020F(1)(c) of the Act, ASIC declares that Part 7.9 of the Act applies in relation to the persons specified in Schedule A and in the case set out in Schedule B as if section 1019A of the Act were modified or varied as follows:
  - (a) in subsection (1) omitting “Subject to subsection (2),” and substituting “Subject to subsections (2) and (2A),”; and
  - (b) after subsection (2) inserting:

“(2A) This Division does not apply to the issue of interests in a registered scheme under a Part 5.1 arrangement or compromise.”

**Schedule A**

Spark Infrastructure RE Limited (ACN 114 940 984) (*RE*) in its capacity as the responsible entity of Spark Infrastructure Trust (ARSN 116 870 725) (*Trust*).

**Schedule B**

Where:

- (1) at meetings of Securityholders, convened in accordance with notices of meeting in substantially the form of the notices of meeting annexed to the Explanatory Memorandum (*Meetings*), the Securityholders approve the Restructure;
- (2) the Restructure is implemented on terms that allow the RE to determine that a Securityholder is an Ineligible Foreign Securityholder;
- (3) the RE determines that a Securityholder is an Ineligible Foreign Securityholder, so that:
  - (a) each ordinary share in Spark 1, ordinary share in Spark 2, Loan Note and interest in the Trust that an Ineligible Foreign Securityholder holds is transferred to a nominee appointed by the RE (*Nominee*) pursuant to the schemes of arrangement and amendments to the constitution of the Trust to implement the Restructure, so that the Nominee is entered in the register in respect of those shares, Loan Notes and interests in the Trust;

- (b) the new interests to be issued under the Restructure (which would otherwise have been issued to the Ineligible Foreign Securityholder) are issued to the Nominee;
- (c) the Nominee then sells the Repositioned Stapled Securities in one or more tranches through the ASX (including by special crossing) and remits the proceeds of sale (calculated on an averaged basis), less any reasonable applicable brokerage, stamp duty and other selling costs, taxes and charges, to the RE;
- (d) the RE promptly pays to the Ineligible Foreign Securityholder its share of the net proceeds of the sale;
- (4) the RE documents in writing that it reasonably believes that having regard to the rights and interests of all members of the Trust, it would be in the best interests of all members of the Trust, and not unfair to Ineligible Foreign Securityholders, to treat Ineligible Foreign Securityholders as set out in paragraph 3;
- (5) the notice of meeting and Explanatory Memorandum distributed to Securityholders in respect of the Meetings sets out the matters described in paragraphs 2 and 3 above; and
- (6) at the close of trading on the last Trading Day before the date of the notice of meeting and Explanatory Memorandum the RE estimated that the interests of the Ineligible Foreign Securityholders comprise in the order of 0.6% of all interests of Securityholders.

### Interpretation

In this instrument:

**ASX** means the financial market operated by ASX Limited ACN 008 624 691.

**Explanatory Memorandum** means the explanatory memorandum on substantially the same terms as the draft explanatory memorandum entitled "Notice of Meeting and Explanatory Memorandum" lodged with ASIC on 2 November 2010.

**Ineligible Foreign Securityholder** means a Securityholder who the RE determines will not be eligible to receive interests in the Trust in accordance with the Restructure, on the basis that:

- (a) it would be illegal under the laws of a jurisdiction to make an invitation or offer to the Securityholder or for the Securityholder to participate in the Restructure; or

(b) it would be unreasonable to make an invitation or offer to the Securityholder or for the Securityholder to participate in the Restructure having regard to each of the following:

- (i) the number of Securityholders in the foreign jurisdiction;
- (ii) the number and the value of the interests to be issued to the members in that jurisdiction; and
- (iii) the cost of complying with the legal requirements and the requirements of any relevant regulatory authority applicable to making an invitation or offer, or participation in the Restructure in that jurisdiction.

**Loan Note** means a loan note issued by the RE pursuant to the terms of the Note Trust Deed between the RE and Australian Executor Trustees Limited ACN 007 869 794 dated 9 November 2005 and as amended.

**Restructure** means the restructure on the terms and conditions disclosed in the Explanatory Memorandum.

**Repositioned Stapled Security** means an interest in the Trust and a Loan Note, where, under the terms on which they are to be traded, they must only be transferred together.

**Securityholder** means a holder of Stapled Securities.

**Stapled Security** means:

- (a) an ordinary share in Spark 1;
- (b) an ordinary share in Spark 2;
- (c) a CHESS depositary interest over an ordinary share in Spark International;
- (d) an interest in the Trust; and
- (e) a Loan Note,

where, under the terms on which they are to be traded, they must only be transferred together.

**Spark 1** means Spark Infrastructure Holdings No. 1 Limited ACN 116 940 786.

**Spark 2** means Spark Infrastructure Holdings No. 2 Limited ACN 116 940 795.





  - (a) Charter Hall Direct Property Fund ARSN 116 064 343; and
  - (b) NB Direct Property Trust ARSN 098 151 323;(each, a **Scheme**),  
  
from paragraph 601FC(1)(d) of the Act in relation to allowing a member of the Scheme to withdraw in accordance with section 601KEA of the Act as inserted by this instrument.

**Declaration**


