Australian Securities and Investments Commission Corporations Act 2001 — Paragraphs 926A(2)(b) and 951B(1)(b) — Exemption

Enabling provision

1. The Australian Securities and Investments Commission makes this instrument under paragraphs 926A(2)(b) and 951B(1)(b) of the *Corporations Act 2001* (the *Act*).

Title

2. This instrument is ASIC Class Order [CO 05/844].

Commencement

3. This instrument commences on the date it is executed.

Exemption

Which products are exempt

- 4. The basic deposit products (each an *eligible deposit product*) issued by Westpac Banking Corporation ACN 007 457 141 (*Westpac*) known as the following are exempt from Part 7.6 (other than Divisions 4 and 8) and Part 7.7 of the Act:
 - (a) Deeming Account;
 - (b) Basic Account;
 - (c) Westpac One Basic;
 - (d) Westpac One;
 - (e) Westpac One Premium;
 - (f) Classic;
 - (g) Classic Plus.
- 5. The exemption in paragraph 4 only applies:
 - to an eligible deposit product to the extent that a financial service is provided in relation to the product in accordance with paragraphs 6 to 11;
 and
 - (b) if the conditions set out in paragraph 12 are met.

Where exemption applies

- 6. The financial service is provided by a person (a *community representative*) who is:
 - (a) the chief executive officer of a council appointed under section 142 of the *Local Government Act* of the Northern Territory other than where the council is one of the following:
 - (i) Alice Springs Town Council;
 - (ii) Darwin City Council;
 - (iii) Katherine Town Council;
 - (iv) Litchfield Shire Council;
 - (v) Palmerston City Council;
 - (vi) Tennant Creek Town Council; or
 - (b) the chief executive officer of a community government within the meaning of the *Local Government (Community Government Areas) Act 2004* of Queensland; or
 - (c) the chief executive officer of the following councils appointed under the *Local Government Act 1993* of Queensland:
 - (i) Aurukun Shire Council;
 - (ii) Cook Shire Council;
 - (iii) Douglas Shire Council; or
 - (d) an officer or employee of the council or community government of which a person referred to in paragraphs (a) to (c) is the chief executive officer whose name appears on a register maintained by that officer for the purpose of this instrument.
- 7. The financial service consists of only either or both of the following:
 - (a) arranging for the issue of an eligible deposit product;
 - (b) the provision of financial product advice in relation to an eligible deposit product.
- 8. The financial service is only provided to a person (the *client*) by a community representative who the representative reasonably believes is ordinarily resident in or near the area (the *local government area*) for which the council or

community government of which the representative is an officer (including the chief executive officer) or employee is responsible.

- 9. Before arranging for the issue of an eligible deposit product to the client, the community representative gives the client information in writing that Westpac reasonably believes:
 - (a) a person would reasonably require for the purposes of making a decision whether to acquire the eligible deposit product; and
 - (b) is clear, concise and effective.
- No fees or charges (however described) are payable by, or on behalf of, the client in relation to the financial services.
- 11. The community representative does not receive any remuneration (whether by way of commission or otherwise) from any person in relation to any action by, or on behalf of, the client arising from the financial services.

Conditions of exemption

- 12. Westpac must take reasonable steps to:
 - (a) maintain a register which sets out the name, address, occupation and local government area of each community representative; and
 - (b) provide appropriate training materials to each community representative on how the representative is to provide the financial services covered by paragraph 7; and
 - (c) ensure that an eligible deposit product for which there is an account keeping fee is not issued to a client on the basis of an arrangement made by a community representative if the client is eligible to be issued with an eligible deposit product that is suitable for the client for which there is no account keeping fee.

Interpretation

13. In this instrument:

account keeping fee means in relation to a facility that is a basic deposit product, a fee (however described) that:

- (a) is charged periodically against the amount from time to time standing to the credit of the facility; and
- (b) does not relate to a particular transaction or a particular level of transactions carried out in relation to the facility.

basic deposit product has the meaning given by section 761A of the Act.

financial product advice has the meaning given by section 766B of the Act.

Australian Securities and Investments Commission Corporations Act 2001 — Paragraphs 601QA(1)(a), 741(1)(a), 911A(2)(l), 992B(1)(a) and 1020F(1)(a) — Exemption

First Exemption: disclosure relief

- 1. Under paragraphs 741(1)(a) and 1020F(1)(a) of the *Corporations Act 2001* (the "Act") the Australian Securities and Investments Commission ("ASIC") exempts:
 - (a) a person from Parts 6D.2, 6D.3 (except section 736) and 7.9 where the person:
 - (i) makes an eligible offer;
 - (ii) offers to arrange for the issue of financial products under an eligible offer;
 - (iii) issues a financial product under an eligible offer; or
 - (iv) offers to arrange for the acquisition of financial products under an eligible offer,

that does not involve a contribution plan, on the conditions set out in the Schedule and for so long as the conditions are met; and

(b) a person (other than a person covered by paragraph (a)) from Part 7.9 where the person makes a recommendation to acquire financial products under an eligible offer that does not involve a contribution plan, except where the person is aware, or ought reasonably to be aware, that any of the conditions set out in the Schedule have not been met.

Second Exemption: licensing and hawking relief

- 2. Under paragraph 911A(2)(I) ASIC exempts a person who is exempt from Part 6D.2 or Part 7.9 because of the First Exemption (other than because the person made a recommendation to acquire financial products), the Custodian and the Warrant issuer from the requirement to hold an Australian financial services licence for the provision of a financial service consisting of general advice reasonably given in connection with an offer referred to in the First Exemption (including any general advice given in the offer document) where the offer document for the offer includes a statement to the effect that any advice given by the person in connection with the offer is general advice only, and that the recipient of the offer should consider obtaining their own financial product advice from an independent person who is licensed by ASIC to give such advice.
- 3. Under paragraph 911A(2)(1) ASIC exempts:
 - (a) an issuer who is exempt from Part 6D.2 or Part 7.9 because of the First Exemption;
 - (b) any associate of the issuer;
 - (c) the Custodian;

(d) the Warrant issuer,

from the requirement to hold an Australian financial services licence for the provision of the following financial services:

- (e) the provision of a custodial or depositary service in connection with an eligible offer covered by the First Exemption where the provider of the service performs their duties in good faith and has sufficient resources to perform those duties; and
- (f) dealing in a financial product in the course of providing a custodial or depositary service covered by paragraph (e); and
- (g) dealing in a financial product in connection with an eligible offer covered by the First Exemption where any acquisition by purchase or disposal of the product (by the issuer, an associate or the Custodian) occurs either:
 - (i) through a person who holds an Australian financial services licence authorising the holder to deal in financial products or a dealers licence issued under the old Corporations Act authorising the holder to deal in securities; or
 - (ii) outside this jurisdiction and through a person who is licensed or otherwise authorised to deal in financial products in the relevant place.
- 4. Under paragraphs 741(1)(a) and 992B(1)(a) ASIC exempts a person who is exempt from Part 6D.2 or Part 7.9 because of the First Exemption, the Custodian and the Warrant issuer from sections 736, 992A and 992AA in relation to offers made in the course of, or because of, unsolicited meetings or telephone calls reasonably held or made in connection with the offer.

Schedule

The following conditions apply:

- 1. the person making the offer of shares and share appreciation rights under the Spring Leverage Plan must:
 - (a) include that offer in an offer document; and
 - (b) take reasonable steps to ensure that any eligible employee to whom the offer is made is given a copy of the offer document; and
 - (c) provide to ASIC a copy of the offer document (which need not contain details of the offer particular to the employee such as the identity or entitlement of the employee) and of each accompanying document not later than 7 days after the first provision of that material to an employee; and
- 2. the issuer must comply (or, in the case of an issuer which does not have a registered office in this jurisdiction, cause an associated body corporate which does so have a registered office to comply) with any undertaking required to be made in the offer document by reason of this instrument; and

- 3. in the case where the employee share scheme may involve the issue of shares (including as a result of the exercise of an option) the issuer must take reasonable steps to ensure that the number of shares the subject of the offer or to be received on exercise of an option when aggregated with:
 - (a) the number of shares in the same class which would be issued were each outstanding offer with respect to shares, units of shares and options to acquire unissued shares, under an employee share scheme to be accepted or exercised; and
 - (b) the number of shares in the same class issued during the previous 5 years pursuant to the employee share scheme or any other employee share scheme extended only to eligible employees of the issuer;

but disregarding any offer made, or option acquired or share issued by way of or as a result of:

- (c) an offer to a person situated at the time of receipt of the offer outside this jurisdiction; or
- (d) an offer that was an excluded offer or invitation within the meaning of the Corporations Law as in force before the commencement of Schedule 1 to the *Corporate Law Economic Reform Program Act 1999*; or
- (e) an offer that did not need disclosure to investors because of section 708; or
- (f) an offer that did not require the giving of a Product Disclosure Statement because of section 1012D; or
- (g) an offer made under a disclosure document or Product Disclosure Statement,

must not exceed 5% of the total number of issued shares in that class of the issuer as at the time of the offer; and

- 4. in the case where an offer of shares is made through a trust:
 - (a) the trustee must hold the shares on trust for each person (a "beneficiary") who acquires units of shares under an eligible offer; and
 - (b) the trustee must cause proper written financial records to be maintained in respect of the activities of the trust and cause those records to be audited annually and made available for inspection by the beneficiaries at an office of the trustee or a place of business of the issuer during normal business hours or such other time as is agreed with beneficiaries; and
 - (c)—the trustee must ensure that each share to which a unit held by a beneficiary relates is identified in the written financial records as being held on account of that beneficiary; and
 - (d) the trustee must not levy any fees or charges for operating and administering the trust, either payable directly by the beneficiaries or out of the assets of the trust; and

- (e) except as expressly provided by the trust deed, a beneficiary must have the capacity to authorise the trustee to sell at or above the current market price the shares to which he or she is entitled to under the deed; and
- the trustee must provide a copy of the trust deed to ASIC at the same time as a copy of the offer document is provided to ASIC in accordance with this instrument; and
- the issuer must ensure that the trust deed contains covenants binding the trustee and their agents, if any, to the effect that a beneficiary possesses substantially the same rights in respect of the shares to which the units of shares they hold relate as if they were the legal owner of the shares, including the right to:
 - direct the trustee how the voting rights attaching to the shares shall be exercised, either generally or in any particular case; and
 - receive the income deriving from the shares, including dividends declared by the issuer in respect of those shares.
- 5. With respect to the Spring Leverage Plan, the number of Participants in the scheme who are eligible employees must, at all times, not exceed 5% of the total number of employees in the relevant scheme;
- 6. The Custodian and the Warrant issuer offer the financial services referred to in paragraph 3 of the Second Exemption to the eligible employees solely for the purpose of the Spring Leverage Plan.
- 7. The issuer must keep at the registered office of an associated body corporate of the issuer in this jurisdiction and make available to ASIC, upon request, a register of those Participants who received an eligible offer in this jurisdiction and enter in the register:
 - (a) the name and address of each Participant;
 - (b) the extent of the holding of each Participant;
 - (c) the date at which the name of each Participant was entered in the register; and
 - (d) the date at which any Participant's participation ceased.
- 8. Except as may be required by the laws of France, the issuer must not modify or vary the Rules in any material respect which would adversely affect the rights and interests of Participants in the Spring Leverage Plan who received an offer in this jurisdiction unless ASIC notifies the issuer or any person acting for or on behalf of the issuer in writing that it does not object to the modification or variation.
- 9. The issuer must take all reasonable steps to ensure that the provisions of the Rules are complied with.

10. The issuer must take all reasonable steps to ensure that the Spring Leverage Plan at all times complies with the laws of France.

Note: where a document must be provided in writing it may be provided by electronic means. See s5C of the Act and s25 of the Acts *Interpretation Act 1901*.

Interpretation

In this instrument:

- except where otherwise stated, references to provisions are to provisions of the Act:
- an employee share scheme shall not be regarded as extended to a person other than an eligible employee only because such an employee may renounce an offer of financial products made to them under the scheme in favour of their nominee;
- 3. "approved foreign market" means:
 - (a) American Stock Exchange, Deutsche Borse, Euronext Amsterdam, Euronext Paris, Italian Exchange, Kuala Lumpur Stock Exchange (Main and Second Boards), London Stock Exchange, New York Stock Exchange, New Zealand Stock Exchange, Singapore Exchange, Stock Exchange of Hong Kong, Swiss Exchange, Tokyo Stock Exchange or Toronto Stock Exchange, provided that:
 - (i) unless otherwise expressly stated, if any such market involves more than one board, only the main board is an approved foreign market; and
 - (ii) such a market is not to be taken not to be an approved foreign market at a particular time only because it was known by another name at that time; or
 - (b) NASDAQ National Market;
- 4. "associated body corporate" of an issuer means:
 - (a) a body corporate that is a related body corporate of the issuer; or
 - (b) a body corporate that has voting power in the issuer of not less than 20%; or
 - (c) a body corporate in which the issuer has voting power of not less than 20%:
- 5. "Australian dollar equivalent" in relation to a price, means a price calculated by reference to the relevant exchange rate published by an Australian bank no earlier than the business day before the day to which price relates:
- "contribution plan" means a plan under which a participating eligible employee
 may save money by regular deductions from wages or salary (including through
 salary sacrifice arrangements) towards paying for shares offered for issue or sale

under an employee share scheme where the terms and conditions of the contribution plan include terms and conditions to the effect that:

- (a) all deductions from wages or salary made in connection with participation in the contribution plan must be authorised by the employee on the same form of application which is used in respect of the offer, or on a form which is included in or accompanies the offer document;
- (b) before transferring contributions to acquire shares, any contributions made by an employee as part of the contribution plan must be held by the issuer in trust for the employee in an account of an Australian ADI which is established and kept by the issuer only for the purpose of depositing contribution moneys and other money paid by employees for the shares on offer under the employee share scheme; and
- (c) the employee may elect to discontinue their participation in the contribution plan at any time and as soon as practicable after that election is made all money deposited with the Australian ADI in relation to that employee, including any accumulated interest, must be repaid to that employee;
- 7. "current market price" means in relation to a share, the price published by the operator of the principal financial market on which the share is quoted as the final price for the previous day on which the share was traded on that financial market:
- 8. "Custodian" means Credit Agricole Investor Services/Corporate Trust, a French financial institution;
- "eligible employee" means, in relation to an issuer, a person who is at the time of an offer under an employee share scheme, a full or part-time employee or director of the issuer or of an associated body corporate of the issuer;
- 10. "eligible offer" means an offer for issue or sale of:
 - (a) fully-paid shares in an issuer in the same class as shares which have been quoted on the financial market operated by Australian Stock Exchange Limited or an approved foreign market throughout the 12 month period immediately before the offer without suspension for more than a total of 2 trading days during that period; or
 - (b) options for the issue or transfer of shares referred to in paragraph (a) where each of the options is offered for no more than nominal consideration; or
 - (c) share appreciation rights where each of the rights is offered for no more than nominal consideration,

made under the Spring Leverage Plan extended only to eligible employees of the issuer, or

- (d) warrants made in connection with the Spring Leverage Plan extended only to the Warrant issuer or employers of the eligible employees of the issuer;
- 11. "financial product advice" has the meaning given by section 766B;
- 12. "general advice" has the meaning given by section 766B;
- 13. "issuer" means Suez S.A., a company registered with the Companies and Trade Registry of Paris;
- 14. "nominal consideration" means consideration of not more than 1 cent per option;
- 15. "offer" has a meaning affected by sections 700, 702 and 1010C;
- 16. "offer document" means a document setting out an offer of shares and share appreciate rights under the Spring Leverage Plan that:
 - (a) includes or is accompanied by a copy, or a summary, of the rules of the scheme under which the offer is made; and
 - (b) if a summary (rather than a copy) of the rules of the Plan is given—includes an undertaking that during the period (the "offer period") during which an eligible employee may acquire the financial products offered the issuer (or, in the case of an issuer which does not have a registered office in this jurisdiction, an associated body corporate of the issuer which does so have a registered office) will, within a reasonable period of the employee so requesting, provide the employee without charge with a copy of the rules of the Plan; and
 - (c) specifies in respect of the shares and share appreciation rights:
 - (i) the acquisition price in Australian dollars;
 - (ii) where the acquisition price is specified in a foreign currency, the Australian dollar equivalent of that price at the date of the offer; or
 - (iii) where the acquisition price is to be worked out in the future under a formula, the Australian dollar or Australian dollar equivalent of that price were that formula applied at the date of the offer; and
 - (d) includes an undertaking, and an explanation of the way in which, the issuer (or in the case of an issuer which does not have a registered office in this jurisdiction, an associated body corporate of the issuer which does so have a registered office) will, during the offer period, within a reasonable period of the employee requesting, make available to the employee:
 - (i) the current market price (or, where that price is denominated in a foreign currency, the Australian dollar equivalent of that price) of the shares in the same class as those offered; and
 - (ii) where subparagraph (c)(ii) or (iii) applies, the information referred to in that paragraph as updated to that date;

- 17. "old Corporations Act" has the meaning given by subsection 1410(1);
- 18. "Participant" means an eligible employee, who resides in Australia, to which an eligible offer is made and who accepts an eligible offer under the Spring Leverage Plan;
- 19. "Rules" means the terms and conditions of the Spring Leverage Plan contained in or accompanying the offer documents relating to the Spring Leverage Plan;
- 20. "Share appreciation right" means a right issued by the employer of a Participant for each share subscribed by the Participant under the Spring Leverage Plan;
- 21. "Spring Leverage Plan" means an employee incentive plan that is substantially in the form described in the documents entitled "Information Notice Spring Multiple 2005 (Australia)", "SAR Award" and "Terms and Conditions of the Warrants" provided to ASIC on 3 August 2005; and
- 23. "Warrant issuer" means Calyon S.A., a French financial institution.

Australian Securities and Investments Commission Corporations Act 2001 – Paragraph 741(1), 1020F(1)(a) and 1020F(1)(c) – Exemption and Declaration

- Under paragraph 1020F(1)(a) of the Corporations Act 2001 ("Act") the Australian Securities and Investments Commission ("ASIC") exempts the person specified in Schedule A in the case specified in Schedule B from section 1012B and subsection 1016A(2) of the Act in relation to the issue of an interest in a managed investment scheme referred to in Schedule C.
- Under paragraph 1020F(1)(c) of the Act, ASIC declares that Part 7.9 applies in relation to financial products specified in Schedule D as if section 1012C were modified or varied by omitting subsections 1012C(6) and (7) and substituting the following subsections:
 - "(6) This subsection covers the circumstances in which:
 - (a) the offer is made within 12 months after the issue of the financial product;
 - (b) the product was issued without a Product Disclosure Statement for the product being issued; and
 - (c) the issuer issued the product with the purpose of the person to whom it was issued selling or transferring the product, or granting, issuing or transferring interests in, or options or warrants over, the product.
 - (7) Unless the contrary is proved, financial products are taken to be issued with the purpose referred to in paragraph 6(c) if any of the financial products are subsequently sold, or offered for sale, within 12 months after their issue."
- 3. Under subsection 741(1) of the Act, ASIC declares that Chapter 6D applies to the person specified in Schedule E in the case specified in Schedule F as if section 707 were modified or varied by omitting subsections 707(3) and (4) and substituting the following subsections:
 - "(3) An offer of a body's securities for sale within 12 months after their issue needs disclosure to investors under this Part if the body issued the securities:
 - (a) without disclosure to investors under this Part; and
 - (b) with the purpose of the person to whom they were issued;
 - (i) selling or transferring them; or
 - (ii) granting, issuing or transferring interests in, or options or warrants over, them;

and section 708 does not say otherwise.

(4) Unless the contrary is proved, a body is taken to issue securities with the purpose referred to in paragraph 3(b) if any of the securities are subsequently sold, or offered for sale, within 12 months after their issue."

- "stapled security" means two or more financial products (at lease one of which is a share) which, under the terms on which each is traded, must be transferred together; and
- "unit" in relation to a share means a legal or equitable right or interest in the share.
