Lodgement period	14 days.
Lodgement fees	Nil.
Late fees	<p>Late fees will apply if you notify a change outside of the lodgement period.</p> <p>For information on fees refer to www.asic.gov.au/forms.</p> <p>A form is not considered lodged until it is received and accepted by ASIC as being in compliance with s1274(8) of the Corporations Act 2001. A receipt will not be issued unless requested.</p>

Additional information	<p>For the resignation of scheme auditor – the auditor must first obtain consent from ASIC to their resignation using Form 5132 <i>Application for consent from ASIC for resignation or removal of scheme auditor</i>.</p> <p>For removal of scheme auditor - the responsible entity of a registered scheme must first obtain consent from ASIC to remove the auditor of a scheme from office using Form 5132 <i>Application for consent from ASIC for resignation or removal of scheme auditor</i>.</p> <p>The resignation or removal will only take effect on the day, following ASIC's consent, when the following disclosure requirements are made by the responsible entity, for a registered scheme:</p> <ul style="list-style-type: none">• if the registered scheme is a disclosing entity, the responsible entity must give a continuous disclosure notice, that would not deal with other matters, to ASIC and any relevant market operator for the scheme (RG 26.74 and RG 26.75); and• if the registered scheme is <u>not</u> a disclosing entity, the responsible entity must give notice to the scheme's members (RG 26.76):<ul style="list-style-type: none">• by a public notice displayed prominently on the responsible entity's website where the notice can reasonably be readily located and accessed by members of the scheme;• by email; or• in writing. <p>In both instances, the notice must contain:</p> <ul style="list-style-type: none">• details of the outgoing auditor;• details of the proposed incoming auditor; and• the reason for the change in auditor.

If there is insufficient space in any section of the form, you may alternately submit annexures as part of this lodgement. To make any annexure conform to the regulations, you must

1. use A4 size paper of white or light pastel colour with a margin of at least 10mm on all sides
2. show the scheme name, ARSN and APFRN (if applicable)
3. number the pages consecutively
4. print or type in BLOCK letters in dark blue or black ink so that the document is clearly legible when photocopied
5. mark the annexure with an identifying letter or symbol eg a,b,c or 1,2,3 etc.
6. endorse the annexure with the words:
This annexure (mark) of (number) pages referred to in form (form number and title)
7. sign and date the annexure

The annexure must be signed by the same person(s) who signed the form.
