### THE COURT ORDERS BY CONSENT THAT:

1. The interlocutory application filed by the plaintiff for the appointment of a provisional liquidator to the defendant ("Application") be set down for hearing at 10.15am on 2 September 2019 on an estimate of one to two days.



- 2. By 4:00pm on 20 June 2019, any interested party who wishes to be heard in relation to the Application ("Interested Party"), file with the Court and serve on each party to the proceeding an application for leave to be heard.
- 3. By 4:00pm on 1 July 2019, the defendant file and serve on the plaintiff and on any Interested Party any affidavit material upon which it intends to rely at the hearing of the Application.
- 4. By 4:00pm on 7 July 2019, any Interested Party file with the Court and serve on the parties any affidavit material upon which it intends to rely at the hearing of the Application.
- 5. By 4:00pm on 22 July 2019, the plaintiff file and serve on the defendant and on any Interested Party any affidavit material upon which it intends to rely (if any) in reply.
- 6. By 4:00pm on 22 July 2019, the plaintiff file and serve on the defendant and on any Interested Party its outline of submissions.
- 7. By 4:00pm on 29 July 2019, the defendant file and serve on the plaintiff and on any Interested Party its outline of submissions.
- 8. By 4:00pm on 5 August 2019, any Interested Party file with the Court and serve on the parties any written submissions which they wish to make in relation to the Application.
- 9. By 4:00pm on 12 August 2019, the plaintiff file and serve on the defendant and on any Interested Party any submissions in reply.
- 10. On or before 9 August 2019, the plaintiff serve on the defendant and any Interested Party a list of any objections to evidence (and brief reasons for the objections).
- 11. On or before 9 August 2019, the defendant serve on the plaintiff and any Interested Party a list of any objections to evidence (and brief reasons for the objections).
- 12. On or before 9 August 2019, any Interested Party serve on the plaintiff and defendant a list of any objections (and brief reasons for the objections).
- 13. The parties and any Interested Party confer with a view to resolving any evidentiary objections and, on or before 23 August 2019, file a joint list of any evidentiary objections which remain unresolved.
- 14. On or before 23 August 2019, the plaintiff file and serve a copy of the Court Book in electronic form, which:



- a. is produced in a text-recognised PDF format;
- b. is paginated sequentially throughout;
- c. is divided into volumes such that each volume is contained within a single PDF file and the file name of each PDF file is the volume number; and
- d. each PDF file contains electronic bookmarks to each document in that file.
- 15. Liberty to apply.
- 16. Costs be reserved.
