The Australian Securities and Investments Commission (ASIC) makes this
instrument under paragraph 601QA(1)(a) of the Corporations Act 2001 (the Act).

Title

This instrument is ASIC Instrument 19-1138.

Commencement

3. This instrument commences on the date it is signed.

Exemption

4. Perennial Investment Management Limited (ACN 108 747 637) (Responsible Entity) in its capacity as responsible entity of the elnvest Cash Booster Fund (Managed Fund) (ARSN 631 537 883) (Fund), a Chi-X quoted managed fund, does not have to comply with paragraph 601FC(1)(d) of the Act to the extent that it would prevent the responsible entity from permitting only authorised participants to withdraw from the Fund.

Where the exemption applies

- 5. The exemption applies where all of the following are satisfied:
 - (a) there is a Product Disclosure Statement in relation to interests in the Fund that are investment products admitted to quotation by Chi-X that includes statements to the effect that:

- (iv) when interests in the Fund are suspended from trading on the Chi-X Market for more than 5 consecutive Business Days, members have a right to withdraw from the Fund and receive payment for their interests in money within a reasonable time of request unless any of the following apply:
 - (A) the Fund is being wound-up;
 - (B) the Fund is not liquid as defined in subsection 601KA(4) of the Act;
 - the Responsible Entity suspends withdrawals in accordance with the constitution;
- (b) the constitution of the Fund does not permit a withdrawal fee per interest in the Fund to be payable by a member who is not an authorised participant that is greater than the withdrawal fee per interest that would generally be payable by an authorised participant receiving redemption proceeds in cash while interests in the Fund are quoted when withdrawing the minimum parcel; and
- (c) ASIC has not notified the Responsible Entity in writing that it is excluded from reliance on the exemption.

- (a) has an agreement with the Responsible Entity of the Fund in relation to making applications to acquire and withdraw interests in the Fund; and
- (b) has notified the Responsible Entity in writing that the person expects they will be an Australian resident for tax purposes for the financial year of the Fund in which the notification is made and for each subsequent financial year, and has not subsequently notified the Responsible Entity to the contrary; and
- (c) is either a Trading Participant or has engaged a Trading Participant to act on its behalf to acquire and dispose of interests in the Fund.

Business Day has the same meaning as in the Chi-X Operating Rules.

Chi-X means Chi-X Australia Pty Limited (ACN 129 584 667).

Chi-X Market means the financial market operated by Chi-X under Australian Market Licence (Chi-X Australia Pty Ltd) 2011.

Chi-X Operating Rules means the operating rules of the Chi-X Market.

quoted managed fund has the same meaning as in the Chi-X Operating Rules.

investment product has the same meaning as in the Chi-X Operating Rules.

minimum parcel means the smallest number or value of interests in the Chi-X quoted managed fund that are generally permitted to be withdrawn from the Chi-X quoted managed fund by an authorised participant while interests in the Chi-X quoted managed fund are quoted.

Trading Participant has the same meaning as that given to 'participant' in the Chi-X Operating Rules.

 - (a) deleting Part 5C.6;
 - (b) deleting the words "if the right may be exercised while the scheme is liquid (as defined in section 601KA) —" in paragraph 601GA(4)(b);
 - (c) deleting "; and" and substituting "." in paragraph 601GA(4)(b); and
 - (d) deleting paragraph 601GA(4)(c).

Where this declaration applies

- 6. This declaration applies to any redemption of Stapled Securities made by Elanor on or before the commencement of trading on the financial market of ASX Limited (ACN 008 624 691) (ASX) at a price, and on other terms, determined by Elanor in accordance with the constitution of the Scheme and the constitution of the Other Scheme (Redemption), where:
 - (a) at least 21 days before any Redemption, Elanor gives written notice (Redemption Notice) to all holders of Stapled Securities of the following matters:
 - the redemption price for a Stapled Security under the Redemption and how the price was calculated;

- (ii) that the payment of the redemption price for all requests received under the Redemption will be funded by monies raised under the Offer;
- (iii) that holders of Stapled Securities may, within 6 days of receipt of the Redemption Notice, elect to redeem some or all of their Stapled Securities pursuant to the Redemption provided that they make their election to Elanor in accordance with the Redemption Notice;

Chapter 5C of the Act applies to Elanor Funds Management Limited ACN 125 903 031 in its capacity as the responsible entity of Elanor Commercial Property Fund I ARSN 636 623 099 (the *scheme*) and Elanor Commercial Property Fund II ARSN 636 623 517 (the *other scheme*) as if the following provisions of that Chapter were modified or varied:
 - (a) after section 601FE insert:

"601FEA Modification of duties: stapled securities

- This section applies to a registered scheme where the interests in the scheme and interests in another registered scheme are components of stapled securities.
- (2) For the purposes of paragraphs 601FC(1)(c) and 601FD(1)(c), an obligation to act in the best interests of members of the scheme is an obligation to act in the best interests of the members of the scheme having regard to their interests as members of both schemes.
- (3) For the purposes of paragraphs 601FC(1)(e), 601FD(1)(d) and 601FD(1)(e), and subsection 601FE(1), an obligation not to make use of information, or not make improper use of position, in order to cause detriment to the members of the scheme is an obligation not to do those things in order to cause detriment to the members of the scheme having regard to their membership of both schemes.";

- (b) after subsection 208(2) as notionally inserted by section 601LC, insert:
 - "(2A) Member approval is not required for the giving of a financial benefit and the benefit need not be given within 15 months if all the following conditions are satisfied:
 - (a) the benefit either:
 - is given out of the scheme property of a registered scheme; or
 - (ii) could endanger the scheme property;
 - (b) all of the interests in the scheme and all of the interests in another registered scheme are components of stapled securities;
 - (c) the benefit is given by:
 - (i) the responsible entity of the scheme; or
 - (ii) an entity that the responsible entity controls; or
 - (iii) an agent of, or person engaged by, the responsible entity;
 - (d) the benefit is given to:
 - an entity wholly owned, whether directly or indirectly, by the scheme; or
 - the other scheme or an entity that is wholly owned, whether directly or indirectly, by the other scheme;
 - (iii) an entity wholly owned, whether directly or indirectly, jointly by the scheme and the other scheme.
 - (2B) For the purposes of this section:
 - (a) an entity is wholly owned by another entity if all of the shares or interests (as applicable) in the first-mentioned entity are held by, or held by a nominee for (in the case of the second-mentioned entity being a company), or form part of the trust property of (in the case of the second-mentioned entity being a trust), the second-mentioned entity or a wholly owned entity of it; and

- (b) a reference to the giving of a benefit to an entity which is a trust is a reference to the giving of a benefit to the trustee of the trust so as to form part of the trust property of the trust or for the benefit of the trust beneficiaries."; and
- (c) insert after section 601PC:

"601PD Stapled securities

For the purposes of this Chapter:

stapled securities means two or more financial products including at least one interest in a registered scheme where:

- under the terms on which each of the products are to be traded, they must be transferred together; and
- (b) there are no financial products in the same class as those financial products which may be transferred separately.".

Where this declaration applies

This declaration applies where each interest in the scheme must, under the terms upon which it is to be traded, only be transferred with each interest in the other scheme.

 - (b) in subparagraph (i) omit "or" second occurring);
 - (c) in subparagraph (ii) omit "facility.", substituting "facility;";
 - (d) after subparagraph (ii) insert:
 - "(iii) in a recommendation situation the advice that constitutes the relevant conduct relates to an offer of managed investment products, under a plan for reinvestment of at least one of the following:
 - (A) distribution in respect of the managed investment products;
 - distributions in respect of other managed investment products which, under the terms on which they may be traded, must only be transferred together with the managed investment products;
 - (iv) in an issue situation the offer or issue that constitutes the relevant conduct is an offer or issue of managed investment products, under a plan for reinvestment of at least one of the following:
 - (A) distribution in respect of the managed investment products;

(B) distributions in respect of other managed investment products which, under the terms on which they may be traded, must only be transferred together with the managed investment products.".

5.  - (a) to Shareholders and their Nominees, communicating:
 - the fact that IPOCo is proposing to undertake the IPO;
 - information about the structure of the offer and the offer periods under the IPO;
 - the timetable of the IPO, and any proposed updates to the timetable;
 - (iv) information regarding the Shareholders' proposed escrow arrangements with respect to the Shares that they hold in IPOCo after the IPO;
 - matters that require shareholder approval in connection with the IPO;
 - (vi) a request for Shareholders to enter into a power of attorney appointing either Monleasing and each director of Monleasing or Credabl and each director of Credabl as their attorney regarding matters in connection with:

 - information about the timetable of the IPO, and any proposed updates to the timetable;

Trading Participant has the same meaning as that given to 'participant' in the Chi-X Operating Rules.

withdrawal fee per interest means, in relation the Fund, the fee that is payable in relation to a withdrawal from the Fund divided by the number of interests in the Fund to which the withdrawal relates.
