Exemptions

Enabling legislation

1. The Australian Securities and Investments Commission (ASIC) makes this instrument under paragraphs 601QA(1)(a), 911A(2)(l) and 1020F(1)(a) of the *Corporations Act 2001* (the Act).

Title

2. This instrument is ASIC Instrument 20-0101.

Commencement

3. This instrument commences on gazettal.

Exemptions

4. GrainCorp does not have to comply with:
 - (a) section 601ED of the Act in relation to the Sale Facility; and
 - (b) Divisions 2 to 5 of Part 7.9 of the Act in relation to an interest in the Sale Facility; and
 - (c) the requirements to hold an Australian financial services licence for the provision of the following financial services:
 - (1) dealing in an interest in the Sale Facility; and
 - (2) the provision of general advice in relation to an interest in the Sale Facility.
5. To avoid doubt, to the extent GrainCorp invites a person to make an offer to sell UMG Shares through the Sale Facility, GrainCorp does not have to comply with Division 5A of Part 7.9 of the Act.

Where exemptions apply

6. The exemptions in paragraphs 4 and 5 apply in relation to the Sale Facility only where that facility satisfies all of the following:
 - (a) the financial products that may be sold through the Sale Facility are UMG Shares that will be admitted to quotation on the licensed market operated by ASX;
 - (b) under the terms of the Sale Facility:
 - (1) the UMG Shares of Participating Holders to be sold through the facility are pooled; and

- (2) a broker sells UMG Shares in the ordinary course of trading on the licensed market operated by ASX; and
- (3) the proceeds of the sale net of expenses (to the extent (if any) that they are not met by GrainCorp) are distributed to Participating Holders; and
- (4) each Participating Holder is paid their proportion of the proceeds of sale as soon as practicable and, in any event, within 8 weeks after the date on which GrainCorp received the Participating Holder's election to participate in the facility.

Conditions for relief

7. In order to rely on the exemptions in subparagraphs 4(a) or (b) or paragraph 5, GrainCorp must include the following information in the Scheme Booklet:
 - (a) information about the minimum and maximum number (if any) of UMG Shares a Participating Holder can sell through the Sale Facility; and
 - (b) information about any expenses relating to the sale or purchase of UMG Shares that will be paid by the Participating Holders; and
 - (c) information about how the proceeds of sale of UMG Shares sold through the Sale Facility will be allocated between Participating Holders; and
 - (d) information about any other significant characteristics or features of the Sale Facility or of the rights and obligations of persons who elect to participate in the Sale Facility.

Exclusion from reliance

8. GrainCorp is excluded from relying on paragraph 4(c) of this instrument if it becomes aware of matters that give it reason to believe that it has failed in a material respect to comply with a condition of this instrument and does not give full particulars of failure to ASIC in writing within 15 business days after becoming so aware.

Interpretation

9. In this instrument:

ASX means ASX Limited ACN 008 624 691.

broker means a participant of the licensed market operated by ASX with whom, or with whose related body corporate, GrainCorp has entered arrangements for the operation of the Sale Facility.

facility has a meaning affected by section 762C of the Act.

GrainCorp means GrainCorp Limited ACN 057 186 035.

GrainCorp Scheme means a compromise or arrangement under Part 5.1 of the Act:

- (a) between GrainCorp and its shareholders; and
- (b) that is in the same form as set out in the explanatory memorandum registered by ASIC on or around 6 February 2020.

Ineligible Foreign Holder has the meaning in the Scheme Booklet.

licensed market has the meaning given by section 761A of the Act.

Participating Holder means a person who:

- (a) is entitled to a UMG Share should the GrainCorp Scheme be implemented; and
- (b) has elected to participate in the Sale Facility or is an Ineligible Foreign Holder.

Sale Facility means a facility operated by GrainCorp through which a Participating Holder can sell a UMG Share in accordance with the terms set out in the Scheme Booklet.

Scheme Booklet means the explanatory statement under section 411 of the Act sent to GrainCorp shareholders in connection with the proposed demerger of UMG from GrainCorp.

UMG means United Malt Group Limited ACN 140 174 189.

UMG Share means a fully paid ordinary share in the capital of UMG.

1. The Australian Securities and Investments Commission (*ASIC*) makes this instrument under subsection 340(1) of the *Corporations Act 2001* (the *Act*).

Title

2. This Order is ASIC Instrument 20-0106.

Commencement

3. This instrument commences on the day it is signed.

Order

4. Automotive Holdings Group Limited ACN 111 470 038 (*AHG* or *Company*) does not have to comply with any of the following obligations in Part 2M.3 of the Act in relation to the Company's financial year ending 31 December 2019 (the *Relevant Financial Year*):
 - (a) the requirement to prepare a financial report and a directors' report under paragraphs 292(1)(b) and (c) and paragraph 292(2)(b);
 - (b) the requirement to have the financial report audited and to obtain an auditor's report under subsection 301(1);
 - (c) the requirement to report to its members under section 314 within the time required by section 315;
 - (d) the requirement to send reports to a member in accordance with a request under subsection 316(1) within the time required by subsection 316(2)
 - (e) a requirement (if any) under section 327B to appoint an auditor of AHG at its Annual General Meeting (*AGM*) for the 2020 calendar year.
5. The directors of AHG do not have to comply with:
 - (a) the requirement under section 317 to lay reports before the AGM of the Company following the Relevant Financial Year.
 - (b) a requirement under section 327C (if any) in relation to the appointment of an auditor following any casual vacancy occurring before 31 March 2020.
6. A.P. Eagers Limited ACN 009 680 013 (*A.P. Eagers*) does not have to comply with subsection 292(1) of the Act in relation to its financial year ending 31 December 2019 to the extent that any non-compliance would result merely from A.P. Eagers preparing

a financial report that includes notes to consolidated financial statements that have been prepared for the purposes of compliance with this instrument and section 6 of ASIC Corporations (Wholly-owned Companies) Instrument 2016/785 including the information specified in paragraph 6(1)(v) of that instrument.

Where this instrument applies

7. This instrument applies where:

- (a) AHG became a wholly-owned subsidiary of A.P. Eagers on or about on 24 October 2019 (*Acquisition*) pursuant to a compulsory acquisition by A.P. Eagers of all of the remaining shares in AHG that were not already owned by A.P. Eagers following the close of A.P. Eagers' off-market takeover bid for AHG on 16 September 2019;
- (b) AHG was a public company included in the Official List of ASX Limited ACN 008 624 691 (*Official List of ASX Limited*) and a disclosing entity pursuant to section 111AC of the Act prior to the Acquisition;
- (c) AHG ceased to be a disclosing entity upon removal from of the Company from the Official List of ASX Limited on 27 September 2019 followed by the Acquisition by A.P. Eagers of all the AHG shares that A.P. Eagers did not already own on or about 24 October 2019;
- (d) A.P. Eagers' financial year ends on 31 December each year;
- (e) prior to 23 October 2019, AHG's financial year ended on 30 June each year;
- (f) to synchronise the accounting year of AHG with A.P. Eagers (and its other wholly-owned entities), AHG's current financial year was shortened so as to end on 31 December 2019 pursuant to sections 323D(3) and (4) of the Act;
- (g) A.P. Eagers and its controlled entities are a reporting entity;
- (h) AHG is ineligible to rely on *ASIC Corporations (Wholly-owned Companies) Instrument 2016/785* for the Relevant Financial Year as a wholly-owned entity of A.P. Eagers because it was a disclosing entity for part of the Relevant Financial Year;
- (i) AHG became a party to a deed of cross guarantee between A.P. Eagers (as holding entity), Eagers Nominees Pty Ltd (as trustee) and certain other wholly-owned subsidiaries of A.P. Eagers by way of an assumption deed dated 20 December 2019; and
- (j) AHG satisfies all of the requirements in section 6 of *ASIC Corporations (Wholly-owned Companies) Instrument 2016/785* for the Relevant Financial Year except for subparagraph 6(1)(b)(i) and 6(1)(f) as at 31 December 2019 as

if AHG were eligible for relief under section 5 of *ASIC Corporations (Wholly-owned Companies) Instrument 2016/785*.

8. This instrument will cease to apply on the date where any of the conditions in section 9 of this instrument are not complied with.

Conditions

9. The Orders in sections 4, 5, and 6 of this instrument are subject to the following conditions:
- (a) AHG must lodge with ASIC by 30 April 2020, a notice signed by a director or secretary using a modified ASIC Form 389 agreed with ASIC, containing a statement that AHG has taken advantage of the relief under this instrument;
 - (b) AHG must comply with the conditions in section 7 of *ASIC Corporations (Wholly-owned Companies) Instrument 2016/785* for the Relevant Financial Year as if it were relying on the relief available under section 5 of *ASIC Corporations (Wholly-owned Companies) Instrument 2016/785* for the Relevant Financial Year as a wholly-owned entity of A.P. Eagers;

Note: This means that:

- (a) AHG must lodge an opt-out notice if it does not rely on relief under *ASIC Corporations (Wholly-owned Companies) Instrument 2016/785* in respect of the immediately following financial year after the Relevant Financial Year but does not have to lodge an opt-out notice if it does rely on relief under *ASIC Corporations (Wholly-owned Companies) Instrument 2016/785* in respect of the immediately following financial year after the Relevant Financial Year, and
 - (b) AHG must lodge a Form 389 opt-in notice for the purposes of relying on relief under *ASIC Corporations (Wholly-owned Companies) Instrument 2016/785* in respect of the immediately following financial year after the Relevant Financial Year;
- (c) A.P. Eagers must include a statement explaining the relief under this instrument in the notes to its consolidated financial statements prepared by it for its financial year ending 31 December 2019 for the purposes of compliance with this instrument in relation to AHG and compliance with *ASIC Corporations (Wholly-owned Companies) Instrument 2016/785* in relation to any other companies that are wholly-owned entities of A.P. Eagers under *ASIC Corporations (Wholly-owned Companies) Instrument 2016/785* for the financial year ending 31 December 2019;
 - (d) A.P. Eagers must disclose with its consolidated financial statements for its financial year ending 31 December 2019 any change in ownership of any members of the closed group or parties to the deed of cross-guarantee between A.P. Eagers (as holding entity), Eagers Nominees Pty Ltd (as trustee) and certain other wholly-owned subsidiaries of A.P. Eagers by way of an assumption deed dated 20 December 2019 that occurs following 31 December 2019 and before the lodgement of its consolidated financial statements for the financial year ending 31 December 2019; and

- (e) A.P. Eagers must lodge its consolidated financial statements together with notes for its financial year ending 31 December 2019 that comply with this Instrument in relation to AHG and with *ASIC Corporations (Wholly-owned Companies) Instrument 2016/785* in relation to any other companies that are wholly-owned entities of A.P. Eagers under *ASIC Corporations (Wholly-owned Companies) Instrument 2016/785* by no later than 31 March 2020.

Interpretation:

In this instrument:

assumption deed means a deed in ASIC Pro Forma 27 and as defined in section 4 of *ASIC Corporations (Wholly-owned Companies) Instrument 2016/785*.

deed of cross guarantee means a deed as defined in section 4 of the definition of deed of cross guarantee in *ASIC Corporations (Wholly-owned Companies) Instrument 2016/785*.
