**Title**

2. This instrument is ASIC Instrument 20-0691.

**Commencement**

3. This instrument commences on 8 July 2020.

**Declarations**

4. Chapters 6 and 6C of the Act apply to DUG Technology Ltd ACN 169 944 334 (the *Company*) as if section 609 were modified or varied by, after subsection (13) (as notionally inserted by ASIC Class Order [CO 13/520]) inserting:

"(13A) A person does not have a relevant interest in securities merely because, under an escrow agreement entered into by the person, the person applies restrictions on the disposal of the securities by the holder."
