Australian Securities and Investments Commission Corporations Act 2001 – Paragraph 655A(1)(b) – Declaration

Enabling legislation

The Australian Securities and Investments Commission (ASIC) makes this instrument under paragraph 655A(1)(b) of the Corporations Act 2001 (Cth) (the Act).

Title

2 This instrument is ASIC Instrument 20-0741.

Commencement

3 This instrument commences on the date it is signed.

Declarations

- 4 Chapter 6 of the Act applies to ARA Real Estate Investors 28 Limited, a company incorporated in the Cayman Islands with registration number 354324 (ARA BidCo), as if section 621(3A), as notionally inserted by ASIC Corporations (Minimum Bid Price) Instrument 2015/1068, were further modified or varied by omitting paragraphs (a) and (b) and substituting the following:
 - "(a) the decrease resulted from the target:
 - (i) declaring a cash distribution;
 - (ii) converting its interests in a registered scheme into a larger number;
 - (b) the date on which the operator of the market on which the bid class securities are quoted changes the basis of quotation of the securities to signify that trading in that class no longer carries the entitlement to the distribution or larger number of interests in a registered scheme, is:
 - (i) after the date the relevant purchase or agreement is made; and
 - (ii) on or before the date of the bid."

Where this instrument applies

5 This instrument applies to the proportional off-market takeover bid made by ARA BidCo to acquire 29% of the fully paid stapled securities in CMW that the ARA Group, comprising of ARA Asset Management Holdings Pte. Ltd. (a company incorporated in Singapore with company number 201629830D) and its controlled entities, does not already own, where:

- the decrease in the value of the CMW securities resulted from a cash distribution of \$0.01875 per security declared by CMW on 4 June 2020 to be paid on or about 21 August 2020;
- (b) the date on which the financial market operated by ASX changes the basis for quotation for the class of bid securities to signify that trading in that class no longer carries the entitlement to the distribution was before the date the bid is made; and
- (c) the Bidder's Statement contains a statement describing the need for and the effect of the relief provided by this instrument as it applies to ARA BidCo.

Interpretation

6 In this instrument:

ASX means ASX Limited ACN 008 624 691.

Bidder's Statement means the bidder's statement in relation to the proportional off-market takeover bid by ARA BidCo to acquire 29% of the stapled securities in CMW that the ARA Group does not already own, lodged with ASIC on 21 July 2020.

CMW means Cromwell Property Group, comprising of Cromwell Corporation Limited ACN 001 056 980 and Cromwell Diversified Property Trust ARSN 102 982 598, for which the responsible entity is Cromwell Property Securities Limited ACN 079 147 809.

Australian Securities and Investments Commission Corporations Act 2001 – Subsection 655A(1) – Exemption and Declaration

Enabling legislation

 The Australian Securities and Investments Commission (ASIC) makes this instrument under subsection 655A(1) of the Corporations Act 2001 (the Act).

Title

This instrument is ASIC Instrument 20-0742.

Commencement

3. This instrument commences on the date it is signed.

Exemption

- ASIC exempts the following persons from section 606 of the Act:
 - (a) BGH Capital Pty Ltd (ACN 617 386 982) (BGH Capital), in its capacity as investment manager or adviser to the constituent entities of the BGH Capital Fund I (BGH Fund), VRG Holdco Limited (ACN 642 854 313), VRG A Pty Limited (ACN 642 859 023), VRG B Pty Limited (ACN 642 859 434), VRG Mezzco Pty Limited (ACN 642 861 014) and VRG Bidco Pty Limited (ACN 642 862 422) (together, BGH);
 - (b) John Kirby, Robert Kirby and Graham Burke (together, the VRC Principals);
 - (c) Positive Investments Pty Ltd (ACN 004 743 426) (Positive Investments);
 - (d) VRC Investment Co Pty Ltd (ACN 103 262 308) (VRC Investment); and
 - (e) Village Roadshow Corporation Pty Ltd (ACN 004 318 610) (VRC),

(together, the Joint Bidders).

Declaration

- Chapter 6 of the Act applies to the Joint Bidders as if item 9 of the table in section 611 were modified or varied by inserting at the end of the item:
 - "In determining a person's voting power in a company 6 months before an acquisition for the purposes of paragraph (b), disregard any relevant interests a person or their associate had in voting shares in the company at that time that was acquired or arose as a result of, or in connection with, any relevant agreement relating to a proposed compromise or arrangement under Part 5.1

between the company and its members in respect of which each of the following are satisfied:

- (c) the compromise or arrangement was proposed in accordance with an agreement (Joint Bidding Agreement) entered into by the person, or an associate of the person; and
- (d) ASIC has provided an exemption from a provision of this Chapter under section 655A with respect to the acquisition of any relevant interest in securities resulting from entry into the Joint Bidding Agreement."

Where this instrument applies

- 6. The exemption in paragraph 4 of this instrument applies to an acquisition by the Joint Bidders of a relevant interest in ordinary shares in Village Roadshow Limited (ACN 010 672 054) (VRL) arising solely as a result of the entry by the Joint Bidders into the Joint Bidding Agreement on or about 4 August 2020 and BGH into the Share Sale Agreement and VRC into the Direct Sale Agreements for the purpose of pursuing the Transaction, where:
 - (a) the terms of the Joint Bidding Agreement are the same, in all material respects, as those set out in the draft Joint Bidding Agreement provided to ASIC on 13 July 2020;
 - (b) immediately prior to entry into the Joint Bidding Agreement:
 - VRC and Positive Investments and VRC Investment have, in aggregate, voting power of not more than 39.92% in VRL and a relevant interest of not more than 33.78% of the issued shares in VRL; and
 - (ii) John Kirby had voting power of 39.92% in VRL and a relevant interest of not more than 35.52% of the issued shares in VRL;
 - (iii) Graham Burke had voting power of 39.92% in VRL and a relevant interest of not more than 36.4% of the issued shares in VRL;
 - (iv) Robert Kirby had voting power of 39.92% in VRL and a relevant interest of not more than 35.56% of the issued shares in VRL; and
 - (v) BGH had a relevant interest in 0% of the issued shares in VRL.
- The declaration in paragraph 5 of this instrument applies to an acquisition of a relevant interest in issued shares in VRL by a Joint Bidder within 6 months of the later of:
 - (a) immediately the date the Joint Bidding Agreement terminates or is terminated; and

(b) the date that any relevant agreement relating to the Structure A Scheme that affects a Joint Bidder's voting power in VRL ceases to affect the Joint Bidder's voting power.

Conditions

- The exemption in paragraph 4 is subject to the following conditions:
 - (a) the Joint Bidders will immediately terminate, or procure the termination of, the Joint Bidding Agreement if shareholders of VRL do not approve the Structure A Scheme in accordance with section 411(4)(a)(ii) of the Act or the Court makes a determination not to approve the Structure A Scheme where such determination is final and cannot be appealed;
 - (b) the Share Sale Agreement and Direct Sale Agreements must be terminated if, and promptly after, the Joint Bidding Agreement is terminated;
 - (c) the Joint Bidders must notify ASIC of, and on request provide ASIC with:
 - (i) any amendment to the Joint Bidding Agreement; and
 - (ii) any other relevant agreement that affects a Joint Bidder's voting power in VRL and relates to the Transaction;
 - (d) the Joint Bidders must use their best endeavours to have VRL engage an independent expert to prepare a report, to be included in or to accompany the explanatory statement for the Structure A Scheme, on whether, in the expert's opinion, the Structure A Scheme is in the best interests of VRL shareholders not associated with the Joint Bidders or their respective associates;
 - (e) the Joint Bidders must not, and must ensure that each of their associates do not, vote any shares in VRL in which they have a relevant interest at any meeting convened by order of the Court under section 411(1) of the Act to approve the Structure A Scheme; and
 - (f) following the execution of the Joint Bidding Agreement:
 - BGH will give a substantial holding notice in accordance with section 671B of the Act, specifying its voting power in VRL following execution of the Joint Bidding Agreement; and
 - (ii) BGH will attach a copy of the Joint Bidding Agreement to the substantial holding notice.

Interpretation

In this instrument:

Direct Sale Agreements means the share sale agreements pursuant to which VRC agrees to acquire the:

- (a) 2,235,133 ordinary shares in VRL of which RGK Superannuation Pty Ltd (ACN 131 829 233) is the legal owner;
- (b) 634,035 ordinary shares in VRL of which RGK Retirement Nominees Pty Ltd (ACN 073 168 297) is the legal owner;
- (c) 604,035 ordinary shares in VRL of which Robert Kirby Investments Pty Ltd (ACN 167 272 728) is the legal owner;
- (d) 894,231 ordinary shares in VRL of which Graham Burke is the legal owner;
- (e) 3,624,212 ordinary shares in VRL of which GW Burke Investments Pty Ltd (ACN 602 447 058) is the legal owner;
- (f) 302,017 ordinary shares in VRL of which GWB Superannuation Pty Ltd (ACN 131 786 224) is the legal owner;
- (g) 302,017 ordinary shares in VRL of which RAB Superannuation Pty Ltd (ACN 131 795 769) is the legal owner;
- (h) 2,475,006 ordinary shares in VRL of which C&J Kirby Investments Pty Ltd (ACN 151 761 992) is the legal owner; and
- 909,000 ordinary shares in VRL of which JRK Retirement Nominees Pty Ltd (ACN 073 168 279) is the legal owner.

Joint Bidding Agreement means the agreement to be entered into between the Joint Bidders in relation to the Transaction.

Share Sale Agreement means the share sale agreement to be entered into between VRG Holdco Limited (ACN 642 854 313), VRG Bidco Pty Limited (ACN 642 862 422), Positive Investments, John Kirby (in his own capacity and as trustee for John Kirby Family Trust No 2), Robert Kirby (in his own capacity and as trustee for Robert Kirby Family Trust No 2), Graham Burke and Burvil Investments Pty. Ltd. (ACN 005 159 320) (in its own capacity and as trustee for Graham William Burke).

Structure A Scheme means a proposed arrangement between VRL and holders of ordinary shares in VRL (excluding VRC, the VRC Principals and the other sellers of VRL Shares under the Direct Sale Agreement) conducted in accordance with Part 5.1 of the Act pursuant to which VRC would acquire all of the shares in VRL it, the VRC Principals and the other sellers under the Direct Sale Agreement do not own.

Transaction means the acquisition by VRC of all of the issued shares in VRL not held by VRC pursuant to the Structure A Scheme and the Direct Sale Agreements.

Commencement

3. This instrument commences on the day it is signed.

Order

- ASIC exempts Pasminco Limited (subject to Deed of Company Arrangement) ACN 004
 368 674 (the Company) from the obligation to hold an annual general meeting (AGM)
 under section 250N of the Act:
 - a. at least once in each calendar year; and
 - within 5 months after the end of each financial year ending during the period between the commencement and cessation of this instrument.

Conditions

- This order applies for so long as the deed administrators maintain arrangements for answering, free of charge, reasonable enquiries from the Company's members about the consequences of the external administration and Deed of Company Arrangement.
- Within 2 months of the termination of the Deed of Company Arrangement, the Company must hold an AGM.
- The Deed Administrators must arrange for a notice explaining the relief granted by this instrument in relation to the Company to be published in a place that is readily accessible on a website maintained by the Deed Administrators.

Where this instrument ceases to apply

- 8. This instrument ceases to apply at the earlier of:
 - a. 16 August 2022; and
 - 2 months after the date of termination of the Deed of Company Arrangement of the Company, including (for the avoidance of doubt) where the Deed of Company Arrangement is terminated.

Interpretation:

In this instrument:

Deed Administrators means an administrator of the Deed of Company Arrangement.

Deed of Company Arrangement means the deed of company arrangement in relation to the Company that was executed and dated 4 October 2002.
