    - (iii) transfer the unpaid units, on the member's behalf, to the buyer.

(d) the Responsible Entity acts in accordance with the sale authority, in respect of the sale of the member's unpaid units in the circumstances specified in paragraphs 2 and 3 of the Schedule (hardship sale).

#### Where the exemption applies

- The exemption in paragraph 4 applies if:
  - (a) where the sale authority permits the Responsible Entity to exercise a discretion in relation to a hardship sale, the Responsible Entity complies with paragraph 5(b), 6(a) and 6(b) in relation to the discretion; and
  - the Responsible Entity acts reasonably when exercising any discretion covered by paragraph 5(a).

- For the purposes of paragraph 4(d) of the instrument, the circumstances referred to in paragraphs 2 and 3 of this Schedule are specified.
- 2. Subject to this paragraph and paragraph 3 of this Schedule, the Responsible Entity may provide assistance to a member in respect of the sale of any unpaid units in the Scheme in accordance with the constitution of the Scheme and any sale authority provided by the member to the Responsible Entity if the Responsible Entity is satisfied that:
  - the member has experienced hardship or is likely to experience hardship if the member's unpaid units are not sold; or
  - (b) where the member is an operator a person (instructor) who has asked the operator (whether directly or through one or more operators) to issue a sale authority to the Responsible Entity has experienced hardship or is likely to experience hardship if the member's unpaid units are not sold; or

  - (d) one or more of the following criteria and conditions are satisfied:

	<u>Criteria</u>	Condition
1	Severe Financial Hardship	The sale of the unpaid units is necessary to extinguish debt and provide any net proceeds of sale, to relieve the person of the burden of debt and enable the person to meet reasonable and immediate living expenses for themselves and/or their dependants.
2	Unemployment	Where the person has not been in gainful employment for a period of at least 3 months and has no other means of financial support (except government assistance, such as unemployment benefits).
3	Compassionate Grounds	The sale of the unpaid units is necessary to extinguish debt provide any net proceeds of sale to the person (and/or the person's dependant):
		(a) to help pay for medical costs (and transport costs) required to treat a life-threatening illness or injury, to alleviate acute or chronic pain, or to alleviate an acute or chronic mental disturbance

		where a registered medical practitioner has provided certified statements confirming the medical condition to this effect; or  (b) to fund specific modifications (to a principal place of residence or vehicle) that are necessary to accommodate special needs arising from a severe disability or to provide equipment or care for a disabled person; or  (c) to assist with funeral and other expenses related to the death of the person's dependants; or  (d) to enable the person to provide care for another person who is dying from a terminal illness, including home care; or  (e) to prevent the person's mortgagee (lender) from selling the person's principal place of residence; or  (f) to meet a binding financial obligation entered into by the person prior to the responsible entity issuing the call including rent or mortgage payments; or
		(g) to meet expenses in other cases consistent with grounds mentioned in paragraphs (a) to (f), where the person does not otherwise have the financial capacity to meet the expense.
4	Permanent Incapacity	Where, on the date a call is due, the person has ceased gainful employment and the responsible entity is satisfied that the person is unlikely ever again to engage in gainful employment of the type for which the person is reasonably qualified by education, training or experience.
5	Aged care	The sale of the unpaid units is necessary to enable the person to make payments required to be made to secure, or remain in, aged care.

- The Responsible Entity must not transfer unpaid units in accordance with a sale authority unless the Responsible Entity is satisfied that:
  - (a) where paragraph 2(b) of this Schedule applies any sale proceeds paid to an operator will be paid to the instructor after deduction of any fees and charges payable to the operator; and

Note: In making any payment to an instructor, an operator must comply with any obligations under the terms of the relevant trust or arrangement under which it acts and other applicable laws. For example, the responsible entity of a registered scheme must comply with Part 5C.6 of the Act as modified by any relief applicable to that scheme and the trustee of a superannuation entity or self managed superannuation fund must comply with the requirements under the Superannuation Industry (Supervision) Act 1993.

(b) where paragraph 2(c) of this Schedule applies – any sale proceeds paid to an executor or administrator of the estate will be paid to the beneficiary after deduction of any fees and charges payable to the executor or administrator.

#### Interpretation

- For the purposes of this Schedule:
  - (a) aged care means residential care (within the meaning of section 41-3 of the Aged Care Act 1997) that is provided by a person or body in respect of which an approval under Part 2.1 of that Act is in force.
  - (b) another person, when used in paragraph (d) of item 3 of paragraph 2(d) of this Schedule, means any natural person.
  - (c) operator means a person who is a member of the Scheme in its capacity as responsible entity or custodian of a registered scheme, trustee of a trust, trustee or custodian of a superannuation entity within the meaning of the Superannuation Industry (Supervision) Act 1993, trustee of a selfmanaged superannuation fund within the meaning of the Superannuation Industry (Supervision) Act 1993 or provider or acquirer in relation to a custodial arrangement as defined in section 1012IA of the Act.
  - (d) the person means:
    - a member of the Scheme;
    - (ii) where the member of the relevant Scheme is an operator—a
      person who has asked the operator to issue a sale authority to the
      Responsible Entity; and
    - (iii) where the member of the relevant Scheme is dead—a person who is a beneficiary of the estate of the member.

  - (a) an entity is wholly owned by another entity if all of the shares or interests (as applicable) in the first-mentioned entity are held by, or held by a nominee for (in the case of the secondmentioned entity being a company), or form part of the trust property of (in the case of the second-mentioned entity being a trust), the second-mentioned entity or a wholly owned entity of it; and
  - (b) a reference to the giving of a benefit to an entity which is a trust is a reference to the giving of a benefit to the trustee of the trust so as to form part of the trust property of the trust or for the benefit of the trust beneficiaries."
