**Australian Securities and Investments Commission
Corporations Act 2001 - Paragraph 601QA(1)(b) - Declaration**

Enabling legislation

1. The Australian Securities and Investments Commission makes this instrument under paragraph 601QA(1)(b) of the *Corporations Act 2001* (the *Act*).

Title

2. This instrument is ASIC Instrument 21-0078.

Commencement

3. This instrument commences on the date it is signed.

Declaration

4. Chapter 5C of the Act applies to BlackWall Fund Services Limited ACN 079 608 825 in its capacity as the responsible entity of BlackWall Property Trust ARSN 109 684 773 (the *BWR Trust*) as if the following provisions of that Chapter were modified or varied as follows:

- (a) after section 601FE insert:

“601FEA Modification of duties: stapled securities

- (1) This section applies to a registered scheme where the interests in the scheme and shares in companies are components of stapled securities.
 - (2) For the purposes of paragraphs 601FC(1)(c) and 601FD(1)(c), an obligation to act in the best interests of the members of the scheme is an obligation to act in the best interests of the members of the scheme having regard to their interests as members of the scheme and of the companies.
 - (3) For the purposes of paragraphs 601FC(1)(e), 601FD(1)(d) and 601FD(1)(e), and subsection 601FE(1), an obligation to not make use of information, or not make improper use of position, in order to cause detriment to the members of the scheme is an obligation not to do those things in order to cause detriment to the members of the scheme having regard to their membership of the scheme and the companies.”;
 - (b) after subsection 208(2) as notionally inserted by section 601LC, insert:

“(2A) Member approval is not required for the giving of a financial benefit and the benefit need not be given within 15 months if all the following conditions are satisfied:

- (a) the benefit either:
 - (i) is given out of the scheme property of a registered scheme; or
 - (ii) could endanger the scheme property;
- (b) all of the interests in the scheme and all of the shares in the companies are components of stapled securities;
- (c) the benefit is given by:
 - (i) the responsible entity of the scheme; or
 - (ii) an entity that the responsible entity controls; or
 - (iii) an agent of, or person engaged by, the responsible entity;
- (d) the benefit is given to:
 - (i) an entity wholly owned, whether directly or indirectly, by the scheme; or
 - (ii) either or both of the companies, or an entity wholly owned, whether directly or indirectly, by a stapled entity; or
 - (iii) an entity wholly owned, whether directly or indirectly, by one or more of the scheme and the companies.

(2B) For the purposes of this section:

- (a) an entity is wholly owned by another entity if all of the shares or interests (as applicable) in the first-mentioned entity are held by, or held by a nominee for (in the case of the second-mentioned entity being a company), or form part of the trust property of (in the case of the second-mentioned entity being a trust), the second-mentioned entity or a wholly owned entity of it; and
- (b) a reference to the giving of a benefit to an entity which is a trust is a reference to the giving of a benefit to the trustee of

the trust so as to form part of the trust property of the trust or for the benefit of the trust beneficiaries.”;

- (c) insert after section 601PC:

“601PD Stapled securities

For the purposes of this Chapter:

stapled securities means three or more financial products including at least one interest in a registered scheme where:

- (a) under the terms on which each of the products are to be traded, they must be transferred together; and
- (b) there are no financial products in the same class as those financial products which may be transferred separately.”.

Where this declaration applies

5. This declaration applies where each BWR Unit must, under the terms upon which it is to be traded, only be transferred with a Planloc Share and a WOTSO Share.

Where this declaration ceases to apply

6. This declaration ceases to apply if:
- (a) a component of the Stapled Securities is issued which on the terms on which it is traded can be transferred separately without also transferring any other component; or
 - (b) interests in any class, other than the class of BWR Units, WOTSO Shares and Planloc Shares that will be on issue on the Implementation Date, are issued.

BWR Unit means an ordinary unit issued in the BWR Trust;

Implementation Date has the same meaning as the term is defined in the Scheme Implementation Deed;

Stapled Securities means the stapled securities comprised of one WOTSO Share, one Planloc Share and one BWR Unit, stapled in accordance with the Stapling Proposal;

WOTSO means WOTSO Limited ACN 636 701 267;

WOTSO Share means a fully paid ordinary share in the capital of WOTSO.

**Australian Securities and Investments Commission
Corporations Act 2001 – Paragraph 601QA(1)(a) – Exemption**

Enabling legislation

1. The Australian Securities and Investments Commission (*ASIC*) makes this instrument under paragraph 601QA(1)(a) of the *Corporations Act 2001 (Act)*.

Title

2. This instrument is ASIC Instrument 21-0079.

Commencement

3. This instrument commences on the date it is signed.

Exemption

4. BlackWall Fund Services Limited ACN 079 608 825 (*BWR Trust RE*) in its capacity as the responsible entity of the BlackWall Property Trust ARSN 109 684 773 (*BWR Trust*) does not have to comply with paragraph 601FC(1)(d) of the Act, to the extent that it requires the responsible entity of a registered scheme to treat members who hold interests of the same class equally.

Where this instrument applies

5. The Stapling Proposal is implemented on terms that allow BWR Trust RE to determine that an Ineligible Foreign Unitholder is to be excluded from participating in the Stapling Proposal except by receiving cash as described under paragraph 8.
6. BWR Trust RE reasonably concludes and documents its conclusions in writing that:
 - (a) it would be unlawful (under the laws of the relevant foreign jurisdiction) for Ineligible Foreign Unitholders to be offered, transferred or issued Planloc Shares and WOTSO Shares (as components of the Stapled Securities); or
 - (b) it would be unduly onerous on BWR Trust RE for Ineligible Foreign Unitholders to participate in the Stapling Proposal having regard to:
 - (i) the number of holders of BWR Units in that jurisdiction;
 - (ii) the number and value of BWR Units held by Ineligible Foreign Unitholders in that jurisdiction; and
 - (iii) the cost of and process for seeking advice as to the requirements for doing so in relation to those jurisdictions and/or the cost of complying with legal requirements and the requirements of any relevant regulatory authority applicable to Ineligible Foreign Unitholders participating in the Stapling Proposal in that jurisdiction.

7. BWR Trust RE reasonably believes that having regard to the rights and interests of all members of the BWR Trust, it would be in the best interests of all members of the BWR Trust for Ineligible Foreign Unitholders to be treated in the manner as set out in paragraph 5.
8. Where BWR Trust RE has determined that a holder of BWR Units is an Ineligible Foreign Unitholder under paragraph 5:
 - (a) BWR Units held by that Ineligible Foreign Unitholder on the Record Date are transferred to the Sale Agent;
 - (b) Planloc Shares that the Ineligible Foreign Unitholder would otherwise have been entitled to be transferred under the Stapling Proposal, are transferred to the Sale Agent; and
 - (c) WOTSO Shares that the Ineligible Foreign Unitholder would otherwise have been entitled to be issued under the Stapling Proposal, are issued to the Sale Agent,

and following the implementation of the Stapling Proposal, the Sale Agent sells the Stapled Securities the Ineligible Foreign Unitholder would otherwise have been entitled to hold under the Stapling Proposal on the ASX, with the proceeds of such sale being remitted to the Ineligible Foreign Unitholder on the terms described in the Explanatory Materials.

Interpretation

9. In this instrument:

ASX means the financial market operated by ASX Limited ACN 008 624 691;

BWR Unit means an ordinary unit issued in the BWR Trust;

Explanatory Materials means the Notice of Extraordinary General Meeting and Explanatory Memorandum for the Stapling Proposal sent to persons who hold BWR Units in relation the Stapling Proposal which is substantially in the same form as provided to ASIC on 18 December 2020;

Ineligible Foreign Unitholder means a person who as at the Record Date holds a BWR Unit and whose registered address is outside of Australia, Hong Kong, New Zealand or United Kingdom, unless BWR Trust RE is satisfied, acting reasonably, that the laws of the jurisdiction permit the offer, transfer and/or issue of Planloc Shares and WOTSO Shares to that person pursuant to the Stapling Proposal, either unconditionally or after compliance with conditions that BWR Trust RE in its sole discretion regards as acceptable and not unduly onerous or impracticable;

Planloc means Planloc Limited ACN 062 367 560;

Planloc Share means a fully paid ordinary share in the capital of Planloc;

Record Date has the same meaning as the term is defined in the Scheme Implementation Deed;

Sale Agent means Morgans Financial Limited ACN 010 669 726;

Scheme Implementation Deed means the scheme implementation deed dated 17 November 2020 between WOTSO, BWR Trust and Planloc (and amended by a deed of restatement and amendment dated 16 December 2020);

Stapling Proposal means the arrangement under which each WOTSO Share, each Planloc Share and each BWR Unit will be stapled together and jointly quoted as stapled securities on the ASX;

Stapled Securities means stapled securities comprised of one WOTSO Share, one Planloc Share and one BWR Unit, stapled together in accordance with the Stapling Proposal.

WOTSO means WOTSO Limited ACN 636 701 267;

WOTSO Share means a fully paid ordinary share in the capital of WOTSO.

4. Chapter 6 of the Act applies to amaysim Australia Limited ACN 143 613 478 (*Target*) and WAM Capital Limited ACN 086 587 395 (*Bidder*) as if Part 6.5 were modified or varied as follows:

- (a) at the end of section 648C, add:

“; or

- (c) in accordance with section 648CA.”;

- (b) after section 648C, insert:

“648CA Deemed manner of sending documents

- (1) A bidder’s statement, offer (within the meaning of section 620) or target’s statement is deemed to have been sent to a holder of securities in relation to offers under an off-market bid for the purposes of this Chapter where either:

- (a) all of the following are satisfied:

- (i) the holder has nominated an electronic address for the purposes of receiving electronic copies of shareholder communications from the person sending the target’s statement;
 - (ii) an electronic message is sent to the nominated electronic address of the holder, which contains links to an electronic copy of the bidder’s statement, offer or target’s statement that is in a form that allows text within the copy to be searched by a computer;


- (iii) the person sending the electronic message does not receive a notification to the effect that the electronic message is unable to be delivered to the nominated electronic address; and
 - (iv) facilities are in place that enable the holder, either through an online portal or website that is accessible by the holder or a telephone number, to request that the bidder's statement, offer or target's statement is to be sent to the holder by a manner specified in subsections 648C(a) or (b); or
- (b) all of the following are satisfied:
- (i) the holder has not nominated an electronic address for the purposes of receiving electronic copies of shareholder communications from the person sending the target's statement;
 - (ii) a letter is sent to the nominated address of the holder, which contains a Uniform Resource Locator to an electronic copy of the bidder's statement, offer or target's statement that is in a form that allows text within the copy to be searched by a computer; and
 - (iii) facilities are in place that enable the holder, either through an online portal or website that is accessible by the holder or a telephone number, to request that the bidder's statement, offer or target's statement is to be sent to the holder by a manner specified in subsections 648C(a) or (b)."

Where this instrument applies

5. This instrument applies in relation to the proposed off-market takeover bid announced by the Bidder on 15 December 2020 for all of the ordinary shares in the Target (*Bid*), where by 7:30pm AEDT on the date of this declaration, the Target has provided to ASX Limited ACN 008 624 691 (*ASX*) for release on the financial market operated by ASX, an announcement:
- (a) explaining the effect of the declaration;
 - (b) that includes a statement to the effect that Target shareholders may request to be sent hard copies of the bidder's statement and target's statement:
 - (i) if the holder is outside of Australia—by pre-paid airmail post or by courier; or
 - (ii) if the holder is in Australia—by pre-paid ordinary post or by courier,and a statement that explains how shareholders can make this request; and
 - (c) includes a statement to the effect that the fact that ASIC has granted this relief in connection with the Bid should not be taken as a reflection of ASIC's views on any other aspect of the Bid.

Enabling legislation

1. The Australian Securities and Investments Commission (**ASIC**) makes this instrument under paragraphs 601QA(1)(a), 926A(2)(a) and 1020F(1)(a) of the *Corporations Act 2001* (the *Act*).

Title

2. This instrument is ASIC Instrument 21-0082.

Commencement

3. This instrument commences on the date it is signed.

Exemptions

4. The Sale Nominee does not have to comply with:
 - (a) section 601ED of the Act in relation to the Sale Facility;
 - (b) divisions 2 to 5 of Part 7.9 of the Act in relation to an interest in the Sale Facility; and
 - (c) section 911A(1) of the Act for the provision of the following financial services:
 - (i) dealing in an interest in the Sale Facility; and
 - (ii) the provision of general advice in relation to an interest in the Sale Facility.

Where this instrument applies

5. The exemptions in paragraph 4 apply where all of the following are satisfied:
 - (a) the securities that may be sold through the Sale Facility are OBL Shares;
 - (b) the OBL Shares of US Retail Shareholders to be sold through the Sale Facility are pooled;

6. In order for the Sale Nominee to rely on the exemptions in paragraph 4, the Company must do all of the following:
 - (a) give and send to the US Retail Shareholders the document set out in paragraph 7 by:
 - (i) giving the document to the holder personally; or
 - (ii) sending the document:
 - (A) by post to the address for the holder in the register of members or an alternative address (if any) nominated by the holder; or
 - (B) to the fax number or electronic address (if any) nominated by the holder; or
 - (iii) making the document available to the holder by a nominated electronic means;
 - (b) before the payment of the net proceeds to US Retail Shareholders under the Sale Facility, make an announcement to the ASX which includes a statement that US Retail Shareholders must participate in the Sale Facility;
 - (c) take reasonable steps to ensure that the Sale Facility is not operated during any period where a control transaction has been publicly proposed and has not ended; and
 - (d) ensure that the Sale Facility does not remain open for longer than 12 months.
7. The document:
 - (a) must contain all of the following:
 - (i) a statement that the Sale Facility is open until the expiry date set out in the document;
 - (ii) information about the minimum and maximum number of OBL Shares that US Retail Shareholders can sell through the Sale Facility;
 - (iii) a statement that the market price of OBL Shares is subject to change from time to time;

- (iv) information about how to obtain up-to-date information on the market price of the OBL Shares;
 - (v) information about any expenses relating to the sale of the OBL Shares that will be paid by the US Retail Shareholders;
 - (vi) information about how the proceeds of sale of OBL Shares disposed of through the Sale Facility will be allocated between US Retail Shareholders;
 - (vii) information as to whether the amount of money received by US Retail Shareholders for OBL Shares that are disposed of through the Sale Facility may be more or less than the actual price that is received by the Sale Nominee for the OBL Shares;
 - (viii) information about any other significant characteristics or features of the Sale Facility or of the rights and obligations of US Retail Shareholders in relation to the Sale Facility; and


