Overview

- <u>ASIC Connect</u> is the online system used to manage your business name.
- You can cancel a business name from your ASIC Connect account.

Get started

- 1. Visit our website at <u>asic.gov.au</u>.
- 2. Select the **ASIC portals** button in the top-right to view further options.
- 3. Under the **Business name holder** option, choose (from the drop-down menu):
 - Cancel or transfer my business name and log in to ASIC Connect, or
 - Learn more about ASIC's online services for more information on how to access our portals.

How to cancel a business name

STEP 1:

Select the Lodgements & Notifications tab at the top of the screen.

- 1. Select the radio button next to the business name you wish to transfer.
- 2. In the transactions column, select **Cancel/Transfer Business Name**.
- 3. Select Go to continue.
