  - (a) PS Apollo, LLC, an entity incorporated under the laws of Delaware in the United States of America (PSA).

#### Declaration

5. Chapter 6 of the Act applies to PSA as if item 9 of the table in section 611 were modified or varied by inserting at the end of the item:

"In determining a person's voting power in a company 6 months before an acquisition for the purposes of paragraph (b), disregard any relevant interests a person or their associate had in voting securities in the company at that time which were acquired or arose as a result of, or in connection with, any relevant agreement relating to a proposed compromise or arrangement under Part 5.1 between the company and its members in respect of which each of the following are satisfied:

- (a) the compromise or arrangement was proposed in accordance with a scheme implementation deed with ASK to implement the Schemes; and
- (b) ASIC has provided an exemption from a provision of this Chapter under section 655A with respect to the acquisition of

any relevant interest in securities resulting from entry into the Joint Acquisition Deed."

The exemption in paragraph 4 of this instrument applies to an acquisition of a relevant interest in ordinary securities in ASK which arises solely as a result of the entry by PSA and Ki (together, the *Joint Acquirers*) into the Joint Acquisition Deed for the purpose of enabling the Joint Acquirers to pursue the Members' Scheme and the Trust Scheme and the execution of this instrument, where:
