How to register a business name if the holder is a trust

ASIC Connect user guide | Published October 2025



Note: The screens and data pictured in this guide are examples only. Actual screens can have minor differences in text and layout.

Overview

- [ASIC Connect](#) is the online system used to manage your business name.
- You can lodge an application for a business name online from your ASIC Connect account.
- This guide explains how to apply for a business name if the holder is a [trust](#). Other business name holder types will result in different screens and questions being asked.
- You must have an [Australian Business Number \(ABN\)](#) registered to a trust or an ABN application reference number to apply for a business name (unless an exemption applies). Please note: if you are in the process of reinstating a cancelled ABN you will need to wait for this to be finalised with the Australian Business Register before you apply for a business name with ASIC.
- We have different [payment methods](#) you can use to pay your registration fee. These include paying online by credit card or later by BPAY or invoice.

myTransaction

Once you have logged in, the home screen will be visible.

my Transactions displays your most recent transactions. The following information may be visible under Transaction status, depending on what transactions you have started recently:

- Incomplete - The transaction has not been completed and must be resumed and submitted in order for ASIC to process it.
- Validated - The transaction has not been completed and must be resumed and submitted in order for ASIC to process it.
- In Progress - The transaction has been submitted and is currently being processed, it cannot be resumed.
- Completed - The transaction has been fully submitted and processed, it cannot be resumed.

1. Select the **Licences & Registrations** tab to begin registering a business name.

Before you start

The application takes an average of 15 – 20 minutes to complete. You can choose to save and exit the application if you cannot complete it in one sitting. If you do, the information you entered will be saved for 90 days but the business name you entered will not be held and will be available for someone else to register.

Resume your application by logging on to your account. Go to 'myTransactions' under the 'Lodgements and notifications' tab to resume your application.

Who can lodge an application?

The proposed business name holder or a person authorised by them may lodge the application. Here are the steps to apply for a business name and the information you will need on hand. Step by step information is available in our [How to apply for a business name guide](#).

Step 1 Enter the Australian Business Number (ABN) or ABN application reference number of the entity that will hold the business name

[Find the ABN before you start.](#) Don't have an ABN? [Visit the Australian Business Register to apply.](#)

If you apply with an ABN application reference number, the business name will be held (but not registered) until your ABN application has been determined by the ABR.

Step 2 Enter the proposed business name and decide if you want to register it for 1 or 3 years

To get ready you can [check to see if the name is available](#).

Enter the business name you would like to register and select 'Check Name Availability'.

Business name registration is case sensitive. You must enter the name exactly as it should appear on the register.

Step 3 Enter the details of the proposed business name holder

Depending on the type of holder, details may include the:

- full name, date and place of birth, and residential address of individuals
- ACN or ABRN of companies or registered bodies, or
- organisation representatives for organisations that are not companies or registered bodies (do not have an ACN or ARBN)

Step 4 Enter the addresses of the business

You will need to provide:

- a street address for the service of documents
- a street address for the principal place of business, and
- an email address

You can also provide a mobile phone number for SMS reminders.

Step 5 Confirm eligibility to hold a business name

You will be asked to make specific declarations before you lodge the application including a declaration that the proposed business name holder (or any person involved in the management of the business) is not [disqualified under the Business Names Registration Act 2011](#).

Step 6 Review and change the information if required

You will have the opportunity to double-check all the information you have entered and edit it if required.

Step 7 Declare

You will be asked to declare that you understand the terms of lodgement of the application and that the information provided is true and correct. If you are lodging this application on behalf of the proposed holder, you will be asked to declare that you have the appropriate authority to lodge and make declarations on their behalf.

Step 8 Pay the registration fee

Have your Visa or MasterCard ready to pay the registration fee, or pay by BPAY. If you choose to pay later you will need to provide an email address so we can send you an invoice. We must receive payment within 10 business days or we won't register the name.

Things to be aware of

- ☒ Registering a business name does not give the holder exclusive name rights. The holder may be subject to legal action for using a business name that has the potential to mislead the public.
- ☒ The holder may be inadvertently infringing someone else's trade mark with the proposed business name. Choosing a business name that infringes an existing trade mark can be a costly exercise—it could mean hefty legal bills, drawn out disputes and even the closure of the business. That is why it's so important to undertake a trade mark (TM) check. [Visit P Australia to search trademarks](#)
- ☒ A holder that is part of a franchise needs consent from the franchise owner to use the business name. [Visit the Franchise Council of Australia for more information about franchises.](#)

Business name availability

1. Review the proposed business name holder details.
2. Enter your proposed business name in the field provided.
3. Select **Check Name Availability**.

The name you have entered will display either one of the following colours:

- green - the name is available for registration
- amber - requires manual decision by ASIC, or
- red - the name is unavailable. You will need to enter another business name.

4. Review the existing business names similar to the one you have proposed.
5. Select your preferred registration period (1 year or 3 years).
6. Select **Next** to continue.

Note: If you select **Save & Exit** this will save the application for resuming at a later date. This does not complete the transaction.

You may register your business name for 1 year or 3 years and your registration will expire unless renewed on the anniversary of the registration, in 1 or 3 years respectively.

You can [request an alternative registration period](#) for your business name to end on:

- the same date as another business name registered to you (with the same ABN), or
- the same date as your company annual review date (enter this date).

When you select your preferred registration period, available options will be presented.

If choosing to align to your company review date, the date must be within the next 18 months (if a 1 year registration period is selected) or the next 3 years and 6 months (if a 3 year registration period is selected).
