# Australian Securities and Investments Commission Corporations Act 2001 – Paragraph 655A(1)(a) – Exemption

# Enabling legislation

 The Australian Securities and Investments Commission (ASIC) makes this instrument under paragraph 655A(1)(a) of the Corporations Act 2001 (Cth) (Act).

#### Title

This instrument is ASIC Instrument 25-0843.

#### Commencement

This instrument commences on the date that it is signed.

# Exemption

4. Gaston and its Controllers do not have to comply with section 606 of the Act.

# Where this instrument applies

- This instrument applies where:
  - Gaston and its Controllers acquire a relevant interest in the Shares as a result of the transfer of the Shares to Gaston on implementation of the Court Order and pursuant to the DOCA;
  - the Deed Administrators made available to Shareholders the following documents at the Website:
    - i. Explanatory Statement;
    - ii. Independent Expert's Report; and
    - iii. the Originating Process,
  - on or before 25 September 2025, a notice informing Shareholders of the Proceedings was sent by post or electronic mail to Shareholders by the Deed Administrators, with such notice advising Shareholders the documents at paragraph 5(b) would be available for download at the Website; and

# Australian Securities and Investments Commission Corporations Act 2001 – Paragraph 1020F(1)(b) – Exemption

# Enabling legislation

 The Australian Securities and Investments Commission (ASIC) makes this instrument under paragraph 1020F(1)(b) of the Corporations Act 2001 (Act).

#### Title

This instrument is ASIC Instrument 25-0844.

#### Commencement

This instrument commences on the date it is signed.

# Exemption

 A CDI over a Share in the Company is exempt from subsection 1020B(2) of the Act.

# Where the exemption applies

- The exemption in paragraph 4 applies to an offer to sell Sale CDIs to Applicants where all of the following are satisfied:
  - the Selling Shareholder holds, before the time of the offer, a Convertible Note which not later than Listing will be converted to CDIs pursuant the terms of the Convertible Note;
  - the Selling Shareholder has, before the time any sale offer is made under the Block Trade (and outside of the Prospectus), entered into the Block Trade Agreement;
  - (c) the offer for the sale of Sale CDIs to Applicants is conditional on the Listing and Conversion occurring and the Company's CDIs being admitted (subject to usual conditions) to the official list of ASX;

**Block Trade** means the offer of CDIs in accordance with the Block Trade Agreement.

Block Trade Agreement means a block trade agreement under which the Selling Shareholder irrevocably agrees to sell up to 50% of the CDIs the Selling Shareholder is due to receive pursuant to Conversion, representing approximately 5% in the post Listing issued capital of the Company.

CDI means, in relation to the Shares of the Company, units of beneficial ownership in Shares, that are issued for the purpose of enabling the Shares to be recorded and transferred in accordance with operating rules of ASX Settlement Pty Limited ACN 008 504 532.

Company means BMC Minerals Ltd ARBN 647 860 124.

Conversion means the conversion of the Convertible Note into CDIs.

Convertible Note means the convertible note in the Company which converts into CDIs not later than on Listing, issued to the Selling Shareholder on 22 December 2021.

Listing means admission of the Company to the official list of the ASX.

Prospectus means the prospectus lodged by the Company with ASIC on or about 10 November 2025 in relation to its initial public offering of CDIs and includes any supplementary or replacement prospectus in relation to that Prospectus.

Sale CDIs means the CDIs the subject of the Block Trade Agreement.

Selling Shareholder means OMF Fund III (Bi) LP.

Shares means fully paid common shares in the Company.

#### Title

This instrument is ASIC Instrument 25-0846

#### Commencement

3. This instrument commences on the day it is signed.

# Exemption

ASIC exempts Deltroit Asset Management (UK) LLP (body), a limited liability
partnership incorporated in the United Kingdom (UK) (registered number OC448813)
and registered with the United Kingdom Financial Conduct Authority, reference number
1020296, from the requirement to hold an Australian financial services licence.

# Cessation

- 5. The exemption in paragraph 4 ceases to have effect on the earlier of:
  - (a) the date specified in subsection 1(3) of Schedule 2 of the ASIC Corporations (Repeal and Transitional) Instrument 2016/396 as amended from time to time; or
  - (b) the body failing to comply with any written notice given by ASIC directing the body to give to ASIC, within the time specified in the notice, a written statement containing specified information about the financial services business operated by the body in this jurisdiction; or
  - (e) the body being notified in writing by ASIC that it is excluded from relying on this instrument.

# Schedule A

- The exemption in paragraph 4 applies where all of the following apply:
  - (a) the body has a current Part 4A Permission;
  - (b) the body is a partnership formed in the UK;

- (c) the body has an Agent at the time the body first purports to rely on this instrument and, from that time, has not failed to have an Agent for any consecutive period of 10 business days;
- (d) the body's primary business is the provision of financial services;
- (e) neither the body nor its Agent has been notified by ASIC that the body is excluded from relying on this instrument;

  - (ii) 30 business days have not passed from ASIC receiving those particulars from the body without ASIC notifying the body that it may continue to rely on this instrument; and
- (g) the body has not notified ASIC that it will not rely on this instrument.

#### Schedule B

- Where the body provides any of the following financial services (the financial services) in this jurisdiction to wholesale clients:
  - (a) providing financial product advice; or
  - (b) dealing in a financial product;

in respect of any of the following financial products:

- (c) securities;
- (d) derivatives;
- (e) foreign exchange contracts;
- (f) debentures, stocks or bonds issued by a government;
- (g) managed investment products; or
- (h) interests in a managed investment scheme that is not required to be registered under Chapter 5C of the Act.

- 2. Where the body has provided ASIC with:
  - (a) a copy of the Part 4A Permission;
  - (b) a notice that it will provide financial services in this jurisdiction in reliance on this instrument;
  - (c) a deed of the body for the benefit of and enforceable by ASIC and the other persons referred to in subsection 659B(1) of the Act that applies notwithstanding that the body may have ceased to rely, or never have relied, on this instrument, which deed provides that:
    - the deed is irrevocable except with the prior written consent of ASIC;
    - (ii) the body submits to the non-exclusive jurisdiction of the Australian courts in legal proceedings conducted by ASIC (including under section 50 of the ASIC Act) and, in relation to proceedings relating to a financial services law, by any person referred to in subsection 659B(1) of the Act and whether brought in the name of ASIC or the Crown or otherwise;
    - (iii) the body covenants to comply with any order of an Australian court in respect of any matter relating to the provision of the financial services;
    - (iv) if the body is not registered under Division 2 of Part 5B.2 of the Act, service of process on the body in relation to legal proceedings conducted by ASIC (including under section 50 of the ASIC Act) and, in relation to proceedings relating to a financial services law, by any person referred to in subsection 659B(1) of the Act and whether brought in the name of ASIC or the Crown or otherwise can be effected by service on the Agent; and
    - (v) the body covenants that, on written request of either the FCA or ASIC, it will give or vary written consent and take all other practicable steps to enable and assist the FCA to disclose to ASIC and ASIC to disclose to the FCA any information or document that FCA or ASIC has that relates to the body; and
  - (d) written consents to the disclosure by the FCA to ASIC and ASIC to the FCA of any information or document that the FCA or ASIC has that relates to the body. The consents must be in such form (if any) as ASIC specifies in writing.

# Schedule C

- The body must:
  - (a) provide each of the financial services in this jurisdiction in a manner which would comply, so far as is possible, with the UK regulatory requirements if the financial service were provided in the United Kingdom in like circumstances; and

- (b) notify ASIC, as soon as practicable and in any event within 15 business days after the body became aware or should reasonably have become aware, and in such form if any as ASIC may from time to time specify in writing, of the details of:
  - (i) each significant change to, including the termination of, the Part 4A Permission applying to the body relevant to the financial services the body provides or intends to provide in this jurisdiction; and
  - (ii) each significant particular exemption or other relief which the body obtains from the UK regulatory requirements relevant to the financial services the body provides or intends to provide in this jurisdiction; and
  - (iii) each action or investigation of the following kinds taken by the FCA, PRA or other overseas regulatory authority against the body in a foreign jurisdiction in relation to financial services provided in the foreign jurisdiction:
    - (A)significant enforcement action;
    - (B) significant disciplinary action;
    - (C) significant investigation (unless, after having taken reasonable steps to enable notification to be given to ASIC, the body is prohibited by law from giving such notification but only to the extent of the prohibition); and
- (c) provide written disclosure to all persons to whom the financial services are provided in this jurisdiction (before the financial services are provided) containing prominent statements to the following effect:
  - the body is exempt from the requirement to hold an Australian financial services licence under the Act in respect of the financial services; and
  - (ii) the body is authorised and regulated by the FCA under the UK laws, which differ from Australian laws; and
- (d) if ASIC gives the body a written notice directing the body to lodge with ASIC, within the time specified in the notice, a written statement containing specified information about any financial service provided by the body in this jurisdiction comply with the notice.

# Interpretation

Agent means a natural person resident in this jurisdiction or a company, whose name and address were last notified to ASIC by the body for the purposes of this instrument, and

who is authorised to accept on the body's behalf, service of process from ASIC and, in relation to proceedings relating to a financial services law, from any person referred to in s659B(1) of the Act;

ASIC Act means the Australian Securities and Investments Commission Act 2001;

financial product advice has the meaning given by section 766B of the Act;

financial services law has the meaning given by section 761A of the Act;

FCA means the Financial Conduct Authority of the United Kingdom and, for the avoidance of doubt, includes the Financial Services Authority of the United Kingdom as it was previously known before 1 April 2013;

FSM Act means the Financial Services and Markets Act 2000 of the United Kingdom;

foreign exchange contract has the meaning given by section 9 of the Act;

notice and notified mean, respectively, written notice and notified in writing;

overseas regulatory authority means a foreign regulatory authority (other than the FCA or PRA) which regulates financial services and which is established by or for the purposes of a foreign government or legislative body;

Part 4A Permission means a permission given under Part 4A of FSM Act or having effect as if so given under that Part;

PRA means the Prudential Regulation Authority of the United Kingdom;

United Kingdom regulatory requirements means the rules that apply in relation to the financial services including any applicable legislation, instruments made under that legislation and any relevant policies or other documents (however described) issued by the FCA or PRA.

# Exemption

- 4. A shareholder of TradeWindow who makes an offer of ordinary shares in TradeWindow for sale (sale offer) within 12 months after their issue does not have to comply with subsection 707(3) of the Act where:
  - (a) at the time of the issue of the shares:
    - (i) TradeWindow was listed on the financial market operated in New Zealand by NZX Limited for a period of at least 3 months and was not listed on the financial market operated in Australia by ASX Limited; and
    - (ii) a notice that complied with clause 20 of Schedule 8 of the Financial Markets Conduct Regulations 2014 of New Zealand was given to NZX Limited; or
  - (b) the issue of the shares relates to an exercise of options that have been on issue for a period of 12 months or more prior to exercise; and

at the time of the sale offer, TradeWindow is listed on the financial market operated in Australia by ASX Limited as a foreign exempt listing.

# Declaration

- Chapter 6D of the Act applies in relation to TradeWindow as if the following provisions were modified or varied:
  - (a) in section 708A:

  - (a) trading in that class of securities on a declared financial market on which they were quoted was not suspended for more than a total of 5 days during:
    - if this section applies because of subsection (1)—the shorter of the period during which the class of securities were quoted, and the period of 12 months before the day on which the relevant securities were issued; or
    - (ii) if this section applies because of subsection (1A)—the shorter of the period during which the class of securities were quoted, and the period of 12 months before the day on which the relevant securities were sold by the controller; and

# (b) either:

- (i) if this section applies because of subsection (1)—the body gives the relevant market operators for the body a notice that the body reasonably believes complies with clause 20 of Schedule 8 of the Financial Markets Conduct Regulations 2014 of New Zealand before the sale offer is made; or
- (ii) if this section applies because of subsection (1A)—both the body, and the controller, gives the relevant market operators for the body a notice that the body and the controller reasonably believe complies with clause 20 of Schedule 8 of the Financial Markets Conduct Regulations 2014 of New Zealand before the sale offer is made; and

- (c) the notice given under paragraph (b) states, in addition to any requirements of the Financial Markets Conduct Act 2013 of New Zealand and of the Financial Markets Conduct Regulations 2014 of New Zealand at the time the notice is given, that:
  - if this section applies because of subsection (1)—the body issued the relevant securities without disclosure to investors under this Part; or

# Written Notice

 This is a notice by the Australian Securities and Investments Commission (ASIC) of the kind described in clause A6-1(4) of Appendix 6 to the constitution of Family First Credit Union Limited ACN 087 650 057 (the Company).

#### Commencement

This notice takes effect when ASIC has published it and given a copy of it to the Company.

#### Background

- 3. The Company has requested that ASIC publish a notice that Appendix 6 (other than clause A6-1(5)) to the Company's constitution ceases to have effect in relation to a proposed resolution to be put to members at a Special General Meeting on 29 January 2026, and give a copy of the notice to the Company.
- 4. ASIC Report 369 Response to submissions on CP 210 Demutualisation approval procedure rules: Minimum member participation requirement outlines the two situations in which ASIC will issue a written notice disapplying rules such as those in Appendix 6 to the Company's constitution. Those two situations are:
  - (a) where an entity's circumstances raise potential prudential concerns and the Australian Prudential Regulation Authority considers it necessary for a particular proposed transaction to occur expeditiously; and
  - (b) where the only trigger for the application of the rules is the adoption of 'mutual bank' status and branding by an entity.
- 5. The Company is a credit union and proposes to hold a special resolution of its members at the 29 January 2026 Special General Meeting for their approval for a total transfer of the Company's business to Beyond Bank Australia Limited ACN 087 651 143 (Beyond Bank). This is the resolution in respect of which the Company has sought to have Appendix 6 disapplied.
- A scenario in which Appendix 6 in the Company's constitution is triggered is set out in clause A6-1(1)(3)(f):

The credit union (whether acting through its board, its members or otherwise) proposes to conduct a reduction of capital, scheme of arrangement, deed of arrangement, transfer of business, or any other form of corporate restructure, where after completion of the restructure:

...

- (f) the successor to the credit union's business is not entitled to use either the words 'credit union', 'credit society' or 'credit co-operative' in its name.
- 7. Beyond Bank is a mutual authorised deposit-taking institution that, in 2018, adopted the term 'bank' in its name. A consequence of adopting the term 'bank' was that Beyond Bank was no longer permitted under the Banking Act 1959 to use the term 'credit union' in its name.
- ASIC considers that the Company's request is consistent with the policy referred to in paragraph 4(b) and publishes and gives this notice on that basis.

#### Cessation

 Appendix 6 (other than clause A6-1(5)) to the Company's constitution ceases to have effect in relation to the Company, subject to paragraphs 10 to 15 of this notice.

#### Transfer of business resolution

- 10. Paragraph 9 of this notice applies only in relation to a resolution (Transfer of Business Resolution), to be considered by the Company's members at a Special General Meeting on 29 January 2026, the effect of which, if approved by members, would be to allow for the total transfer of the Company's business to Beyond Bank in accordance with the Financial Sector (Transfer and Restructure) Act 1999 (Transfer Act).
- 11. Appendix 6 to the Company's constitution continues to have effect on its terms in relation to a resolution other than the Transfer of Business Resolution.

#### Conditions

- 12. The Company must convene and conduct its 29 January 2026 Special General Meeting in accordance with the Corporations Act 2001 (Corporations Act), the Transfer Act and the terms of its constitution other than Appendix 6. The Company must consider the Transfer of Business Resolution as a special resolution.
- 13. The Company must ensure that the notice of meeting for the Company's 29 January 2026 Special General Meeting clearly states that ASIC has issued this notice to cease the effect of Appendix 6 (other than clause A6-1(5)) to the Company's constitution in relation to the Transfer of Business Resolution, and either:
  - (a) include a copy of this notice; or
  - (b) include a web address of the page on ASIC's website where this notice is published.

- 14. The Company must ensure that the Transfer of Business Resolution is only passed at the Company's 29 January 2026 Special General Meeting if at least 75% of the votes cast by members entitled to vote on the Transfer of Business Resolution approve the Transfer of Business Resolution.
- 15. If the Company does not comply with any of the conditions in paragraphs 12 to 14, this notice ceases to have effect in relation to the Transfer of Business Resolution.
