The Plaintiff seeks declarations of contraventions of the Act, pecuniary penalty orders and costs.

- 2. An order under s 1317G(1) of the Act that the Defendant pay to the Commonwealth a pecuniary penalty in relation to the contraventions referred to in paragraph 1 above.
- 3. An order that the Defendant pay the Plaintiff's costs of and incidental to the proceeding.
- 4. Such further or other orders as the Court thinks fit.
