  - (a) subsection 911A(1) of the Act for the provision of any of the following financial services:
    - (i) dealing in derivatives that are factoring arrangements;

#### Title

2. This instrument is ASIC Instrument [23-0078].

#### Commencement

3. This instrument commences on the date it is signed.

#### Declarations

- 4. Parts 7.6 (other than Divisions 4 and 8), 7.7, 7.8A and 7.9 and section 992A of the Act apply to Bank of Queensland Limited ACN 009 656 740 (BOQ) in relation to a Notice Saver Account, as if the definition of basic deposit product in section 761A of the Act were modified or varied as follows:
  - (a) omit paragraph (c);
  - (b) omit paragraph (d), substitute:
    - "(d) funds are able to be withdrawn or transferred from the facility on the instruction of, or by authority of, the depositor subject to a prior notice requirement that does not exceed a period of 31 days from the first business day after the notice is given, to which the withdrawal or transfer relates; and".
- 5. Parts 7.6 (other than Divisions 4 and 8), and 7.8A, and section 992A of the Act apply in relation to a Notice Saver Account, as if the definition of basic banking product in section 910A of the Act were omitted and substituted with the following:

"basic banking product means any of the following:

- (a) a basic deposit product;
- (b) a facility for making non-cash payments (see section 763D);
- (d) a facility for providing traveller's cheques;
- (e) any other product prescribed by the regulations for the purposes of paragraph 961F(e)".
- 6. Part 7.8A of the Act applies to BOQ in relation to a Notice Saver Account, as if paragraph 7.8A.07(a) of the Corporations Regulations 2001 (the Regulations) were omitted and substituted with the following:
  - "(a) the product is a basic deposit product within the meaning of section 910A of the Act; and".
- Part 7.9 of the Act applies to BOQ in relation to a Notice Saver Account as if that Part
  were modified or varied by inserting after subsection 1012D(7A) (as notionally
  inserted by regulation 7.9.07FA of the Regulations).

"Depositor warning in relation to offer of notice deposit

(7AA) Subsections (7AB) to (7AF) apply to an ADI that:

- (a) offers to issue a basic deposit product to which subparagraph (d)(ii) of the definition of basic deposit product in section 761A applies; and
- does not give the depositor a Product Disclosure Statement for the basic deposit product because of subsection (7A).
- (7AB) The ADI must, at or before the time the ADI makes the offer give the depositor the following information in accordance with subsections (7AD) to (7AF):
  - that if the depositor requests the funds standing to the credit of the product to be withdrawn or transferred a notice period applies to such requests;
  - the duration of the notice period and that the ADI has the discretion to delay the withdrawal or transfer until the end of the notice period;

(c) that if the depositor may have a need in the future to immediately withdraw or transfer funds standing to the credit of the product, other deposit products may be more suitable.

How information and statements must be given

- (7AD) Information referred to in subsection (7AB) must be given to the depositor:
  - (a) orally; or
  - (b) in a document containing the governing terms of the product; or
  - (c) in a one-page document which contains the information but nothing more.
- (7AE) If the ADI gives the depositor the information in a document referred to in paragraph (7AD)(b), the ADI must obtain a written acknowledgement from the depositor, in immediate proximity to where the information is stated, that the depositor has read the information.
- (7AF) Information and statements referred to in subsection (7AB);
  - (a) must be worded and presented in a clear, concise and effective manner;
     and
  - (b) must be:
    - (i) given to the depositor, or the depositor's agent, personally, or
    - (ii) sent to the depositor, or the depositor's agent at an address (including an electronic address) or fax number nominated by the person or the agent; and
  - (c) may be in printed or electronic form or, in the case of information or statements given under subparagraph (b)(i), may be given orally".

#### Where the declarations apply

- 8. The declarations in paragraphs 4, 5, 6 and 7 of this instrument apply where:
  - (a) the words 'Notice Account' or 'Lock Saver Feature' are used to describe the product or notice feature of the Notice Saver Account;

- (b) any offer, request or invitation made in relation to a 'Lock Saver Feature' on a Notice Saver Account is made in the course of contact with the consumer that the consumer initiated for any purpose; and
- (c) under the terms of the Notice Saver Account, if a depositor experiences hardship they can request immediate withdrawal of part or all of the Notice Saver Account balance and BOQ will consider waiving the notice period.

#### Interpretation

9. In this instrument:

**Notice Saver Account** means a deposit product issued by BOQ that satisfies each of the following:

- (a) the conditions in paragraphs (a), (b) and (e) of the definition of basic deposit product in section 761A of the Act (ignoring any modifications or variations to the definition notionally made by this instrument) are satisfied;
- (b) either:
  - a. amounts deposited into the product are not available for withdrawal or transfer, unless the depositor gives a notice to BOQ requesting that all or part of the balance of the product be withdrawn or transferred to a nominated account or otherwise made available for withdrawal or transfer; or
  - the depositor can request that amounts deposited into the product be locked (*lock request*) and not available for immediate withdrawal or transfer while the balance of the product is locked;
- (c) under the terms of the product where the depositor can make a lock request:
  - a specified interest rate applies to amounts credited to the balance of the product;
  - (ii) where the balance of the product is locked and not available for immediate withdrawal or transfer:
    - a. at any time, the depositor can give a notice (withdrawal notice) to BOQ requesting that all or part of the balance of the product be

withdrawn or transferred to a nominated account or otherwise made available for withdrawal or transfer;

- at any time, the depositor can give a notice (unlock notice) to BOQ requesting that the locked balance of the product be unlocked;
- if unlock notice is given, BOQ must make the balance of the product available for withdrawal or transfer from the end of a period that does not exceed 31 days from the first business day after the unlock notice is given;
- d. a specified additional interest rate (*locked rate*) applies to amounts credited to the balance of the product up to but excluding the date the depositor gives unlock notice to BOQ;
- e. if withdrawal notice is given, the locked rate continues to apply on the full balance;
- f. there is no reduction to the amount of any interest that accrued during the period during which the balance of the product was locked; and
- g. no fee or charge is applied in connection with giving withdrawal notice or unlock notice.

Lock, locked, or locking means an optional product feature, which if enabled through a lock request by the depositor, has the effect of requiring a notice to withdraw or transfer all or part of the balance with a notice period meeting the requirements set out in this Instrument.

Unlock or unlocking means – where a depositor can and has made a lock request - the process for a depositor to disable the locking feature of a product by giving the unlock notice.

- 5. The exemption in paragraph 4 applies where each of the following is met:
  - (a) HWAU provides to a person (Client) that is a wholesale client, a facility through which payments may be made using foreign currency (Foreign Currency Payment Facility);
  - (b) money (Client Money) referred to in section 981A of the Act is paid to HWAU, or to a HWAU Affiliate as a representative of HWAU, for the purposes of funding a future payment to another person using the Foreign Currency Payment Facility;
  - (c) the Client Money is:
    - (i) denominated in a foreign currency; and
    - (ii) accompanied by an instruction from the Client for an amount equivalent to the amount of the Client Money, less any amounts owed to HWAU, to be paid to another person;
  - (d) a written agreement is in place between HWAU and the Client under which the Client Money:
    - may be paid by or on behalf of the Client into an account (Foreign Funding Account) held by HWAU or a HWAU Affiliate with a Relevant Foreign Institution; and

- (ii) is required to be held on trust for the benefit of the Client while held in a Foreign Funding Account;
- (e) HWAU has notified the Client in writing, before Client Money is paid into a Foreign Funding Account by or on behalf of the Client, that:
  - the Foreign Funding Account may not be subject to the same regulation as accounts held with an Australian ADI; and
  - (ii) the Foreign Funding Account may also contain Client Money of other clients of HWAU and, if the Foreign Funding Account is held by a HWAU Affiliate, money that has been paid to the HWAU Affiliate by or on behalf of clients of the HWAU Affiliate; and
- (f) HWAU has in place a written agreement with PayPal Pte. Ltd. that provides PayPal Pte. Ltd. will indemnify HWAU for losses suffered or incurred by HWAU as a result of, or in connection with, directly or indirectly, any claim made by a client of HWAU in relation to the use of Hyperwallet Services.
