Attendance

Why has ASIC decided to keep the Annual Forum as an in-person Event?

In line with previous years, ASIC would like to retain a high level of interaction and engagement between attendees. ASIC believes this is best supported by an in-person Event.

What is the dress code for both the ASIC Annual Forum and the ASIC Annual Dinner?

Business attire.

Will ASIC and the Hilton cater to my dietary requirements?

All dietary requirements must be identified during the online registration process. Alternatively, requests can be made in writing to <u>asic@thinkbusinessevents.com.au</u>. ASIC and the Hilton will make reasonable efforts to cater for dietary requirements identified in the attendees' registration process, but they cannot guarantee all dietary requirements will be met and they reserve the rights to offer reasonable alternative substitutes to any affected attendees.

Travel and accommodation

Is transport provided between the airport and the Hilton Hotel Sydney (the Hilton)?

Refunds

Is ASIC offering refunds to registered attendees and is there a cancellation fee?

Given ASIC's decision to defer the AAF2022 to the new dates of Thursday 3 and Friday 4 November 2022 and ASIC acting in good faith and reasonably, ASIC will offer and allow an existing attendee to submit a cancellation or refund request in writing to the dedicated email address below for a full refund with no cancellation fee to apply to it up to and no later than close of business (i.e. 5pm AEST) on 30 June 2022.

Any cancellation or refund request received by ASIC on and after 1 July 2022 will attract a cancellation fee as set out in the relevant cancellation table in the Registration Term and Conditions.

How is ASIC addressing COVID-19 safety protocols?

They will also refer to the Public Health orders at the time of the Event for any other requirements.

Do I have to be fully vaccinated to attend? If so, what documentation will you require to prove this?

ASIC and the Hilton will follow the latest health advice from either or both of the Australian Government and the New South Wales Government.

If at the time vaccinations are required, attendees will be required to be vaccinated and Event staff may be required to check attendees' vaccination status on arrival at the Event.

We will advise all registered attendees prior to the Event if a current vaccination status is required for entry to the Event.

Will I be required to wear a mask?

ASIC and the Hilton will follow the latest health advice from either or both of the Australian Government and the New South Wales Government. If at the time masks are mandated, attendees will be required to wear a mask. If masks are not mandated, attendees may choose to wear a mask at their discretion.

Will the Hilton enforce social distancing rules during the Event?

The Hilton will adhere to the latest health advice from either or both of the Australian Government and the New South Wales Government.

What will happen if I have COVID-19 symptoms at the time of the Event?

ASIC and the Hilton expect attendees to follow the latest health advice if they are feeling unwell. However, for the comfort of other guests, attendees who are suffering from cold or flu-like symptoms (such as coughing or sneezing) should reconsider their attendance at the Event. ASIC may offer a refund to attendees who are ill at the time of the Event at its discretion (see the Terms and Conditions).
