**Australian Securities and Investments Commission  
Corporations Act 2001 - Paragraph 601QA(1)(b) – Declaration**

**Enabling legislation**

1. The Australian Securities and Investments Commission (ASIC) makes this instrument under paragraph 601QA(1)(b) of the Corporations Act 2001 (Cth) (the Act).

**Title**

2. This instrument is ASIC Instrument 2025-0924.

**Commencement**

3. This instrument commences on the day it is signed.

**Declaration**

4. Chapter 5C of the Act applies to Equity Trustees Limited ABN 46 004 031 298 (EQT) in its capacity as responsible entity of the:

- (a) Antipodes Asia Fund ARSN 134 226 029;
- (b) Antipodes China Fund ARSN 116 380 771; and
- (c) Antipodes Emerging Market Debt Fund ARSN 151 270 423,

(each a **Fund** and collectively the **Funds**) as if the definition of *extraordinary resolution* in section 9 of the Act were modified or varied by omitting paragraph (b) of the definition and substituting:

"(b) that has been passed by at least 50% of the total votes that may be cast by eligible persons.

For the purposes of this definition:

*abstaining member* means a member of the scheme that:

- (a) is an operator or custodian of an IDPS and/or is acting in its capacity as trustee of a registerable superannuation entity (and includes a trustee or custodian entity of any of the foregoing);
- (b) where the person mentioned in paragraph (a) above (including in the case of a sub-custodian that has authorised the operator or custodian of an IDPS) has a written policy of not voting their interests in relation to a resolution arising from the client's investments in the IDPS or the registerable superannuation entity (as applicable); and

- (c) has abstained from voting in relation to the resolution in respect of the relevant interests.

*custodian*, in relation to an IDPS, has the meaning given in ASIC Corporations (Investor Directed Portfolio Services) Instrument 2023/669.

*eligible persons* means members of the scheme (excluding abstaining members) entitled to vote on the resolution at the meeting (including members who are not present in person or by proxy).

*IDPS* has the meaning given in ASIC Corporations (Investor Directed Portfolio Services) Instrument 2023/669.

*operator*, in relation to an IDPS, has the meaning given in ASIC Corporations (Investor Directed Portfolio Services) Instrument 2023/669.

*registerable superannuation entity* has the meaning given in subsection 10(1) of the Superannuation Industry (Supervision) Act 1993."

#### Where this instrument applies

5. This instrument applies where:

- (a) EQT has issued a notice of meeting to call a meeting of scheme members to vote on an extraordinary resolution to approve the retirement of EQT as responsible entity of each Fund and the appointment of Maple-Brown Abbott Limited ABN 73 001 208 564 (**MBAL**) as responsible entity of each Fund;
- (b) the notice of meeting includes an explanation of the effect of this instrument in relation to the resolutions to be considered at each Fund's meeting; and
- (c) the abstaining members for the Funds are those set out in **Schedule 1** of this Instrument.

*Bond Street* means Bond Street Custodians Limited ABN 57 008 607 065.

**Australian Securities and Investments Commission  
Corporations Act 2001 – Paragraph 926A(2)(a) – Exemption**

**Enabling legislation**

1. The Australian Securities and Investments Commission (*ASIC*) makes this instrument under paragraph 926A(2)(a) of the *Corporations Act 2001* (the *Act*).

**Title**

2. This instrument is ASIC Instrument 26-0008.

**Commencement**

3. This instrument commences on the day it is signed.

**Exemption**

4. ASIC exempts Aviva Investors Asia Pte. Limited (Company Registration Number 200813519W) (the *body*), a body incorporated in Singapore, from the requirement to hold an Australian financial services licence (*AFS licence*) in the case referred to in Schedule A, on the conditions specified in Schedule B.

**Cessation**

5. The exemption in paragraph 4 ceases to have effect on the earlier of:
  - (a) subparagraph 7(1) of the *ASIC Corporations (Foreign Financial Services Providers) Instrument 2025/798* ceasing to have effect in relation to the relief that was provided under ASIC Class Order [CO 03/1102] *Singapore MAS regulated financial service providers*; or
  - (b) the body not complying with any written notice given by ASIC directing the body to give to ASIC, within the time specified in the notice, a written statement containing specified information about the financial service business operated by the body in this jurisdiction; or
  - (c) the body being notified in writing by ASIC that it is excluded from relying on this instrument.

**Schedule A**

1. The exemption in paragraph 4 applies where all of the following apply:
  - (a) the body has a current capital markets services licence granted by the Monetary Authority of Singapore (*MAS*) under section 86 of the Securities and Futures Act;
  - (b) the body is either a body corporate incorporated in Singapore or a partnership formed in Singapore;

- (c) the body:
    - (i) is registered under Div 2 of Pt 5B.2 of the Act; or
    - (ii) has an agent at the time the body first purports to rely on this instrument and, from that time, has not failed to have an agent for any consecutive period of 10 business days;
  - (d) the body's primary business is the provision of financial services;
  - (e) neither the body nor its agent has been notified by ASIC that the body is excluded from relying on this instrument;
  - (f) if the body becomes aware or should reasonably have become aware of matters that give it reason to believe that it has failed, other than in an immaterial respect, to comply with a requirement set out in Schedule B:
    - (i) 15 business days have not passed since the body became so aware or should reasonably have become so aware without the body providing full particulars of the failure to ASIC (to the extent that the body knows those particulars or would have known them if it had undertaken reasonable enquiries); and
    - (ii) 30 business days have not passed from ASIC receiving those particulars from the body without ASIC notifying the body that it may continue to rely on this instrument; and
  - (g) the body has not notified ASIC that it will not rely on this instrument.
2. Where the body provides any of the following financial services (the *financial services*) in this jurisdiction to wholesale clients:
- (a) providing financial product advice; and
  - (b) dealing in a financial product,
- in respect of any of the following financial products:
- (c) securities;
  - (d) derivatives;
  - (e) debentures, stocks or bonds issued or proposed to be issued by a government;
  - (e) foreign exchange contracts;
  - (f) managed investment products; and

(g) interests in a managed investment scheme that is not required to be registered under Chapter 5C of the Act.

3. Where the body has provided ASIC with all of the following:

(a) evidence that paragraph 1(a) of Schedule A is satisfied that ASIC has stated in writing is adequate;

(b) a notice that it will provide the financial services in this jurisdiction in reliance on this instrument;

(c) a deed of the body for the benefit of and enforceable by ASIC and the other persons referred to in s659B(1) of the Act that applies notwithstanding that the body may have ceased to rely, or never have relied, on this instrument, which deed provides that:

(i) the deed is irrevocable except with the prior written consent of ASIC; and

(ii) the body submits to the non-exclusive jurisdiction of the Australian courts in legal proceedings conducted by ASIC (including under s50 of the ASIC Act) and, in relation to proceedings relating to a financial services law, by any person referred to in s659B(1) of the Act and whether brought in the name of ASIC or the Crown or otherwise; and

(iii) the body covenants to comply with any order of an Australian court in respect of any matter relating to the provision of the financial services; and

(iv) if the body is not registered under Div 2 of Pt 5B.2 of the Act, service of process on the body in relation to legal proceedings conducted by ASIC (including under s50 of the ASIC Act) and, in relation to proceedings relating to a financial services law, by any person referred to in s659B(1) of the Act and whether brought in the name of ASIC or the Crown or otherwise can be effected by service on the agent; and

(v) the body covenants that, on written request of either MAS or ASIC, it will give or vary written consent and take all other practicable steps to enable and assist MAS to disclose to ASIC and ASIC to disclose to MAS any information or document that MAS or ASIC has that relates to the body;

(d) written consents to the disclosure by MAS to ASIC and ASIC to MAS of any information or document that MAS or ASIC has that relates to the body. The consents must be in such form (if any) as ASIC specifies in writing.

#### Schedule B

1. The body must provide each of the financial services in this jurisdiction in a manner which would comply, so far as is possible, with the Singaporean regulatory requirements if the financial service were provided in Singapore in like circumstances.

## 2. The body must:

(a) notify ASIC, as soon as practicable and in any event within 15 business days after the body became aware or should reasonably have become aware, and in such form if any as ASIC may from time to time specify in writing, of the details of:

- (i) each significant change to, including the termination of, the capital markets services licence applying to the body relevant to the financial services the body provides or intends to provide in this jurisdiction; and
- (ii) each significant particular exemption or other relief which the body may obtain from the Singaporean regulatory requirements relevant to the financial services the body provides or intends to provide in this jurisdiction; and
- (iii) each action or investigation of the following kinds taken by MAS or other overseas regulatory authority against the body in a foreign jurisdiction in relation to financial services provided in the foreign jurisdiction:

(A) significant enforcement action;

(B) significant disciplinary action;

(C) significant investigation (unless, after having taken reasonable steps to enable notification to be given to ASIC, the body is prohibited by law from giving such notification but only to the extent of the prohibition); and

(b) provide written disclosure to all persons to whom the financial services are provided in this jurisdiction (before the financial services are provided) containing prominent statements to the following effect:

- (i) the body is exempt from the requirement to hold an Australian financial services licence under the Act in respect of the financial services; and
- (ii) the body is regulated by MAS under Singaporean laws, which differ from Australian laws; and

(c) if ASIC gives the body a written notice directing the body to lodge with ASIC, within the time specified in the notice, a written statement containing specified information about any financial service provided by the body in this jurisdiction – comply with the notice.

**Interpretation**

## 1. In this instrument:

*Act* means the *Corporations Act 2001*;

**address**, in relation to a company, means the address of the registered office of the body;

**agent** means a natural person resident in this jurisdiction or a company, whose name and address were last notified to ASIC by the body for the purposes of this instrument, and who is authorised to accept on the body's behalf, service of process from ASIC and, in relation to proceedings relating to a financial services law, from any person referred to in s659B(1) of the Act;

**ASIC Act** means the *Australian Securities and Investments Commission Act 2001*;

**capital markets services licence** means a capital markets services licence granted by MAS under section 86 of the Securities and Futures Act;

**derivative** has the meaning given by section 9 of the Act;

**financial product advice** has the meaning given by section 766B of the Act;

**financial services law** has the meaning given by section 761A of the Act;

**foreign exchange contract** has the meaning given by 761A of the Act;

**managed investment products** has the meaning given by s764A(1)(ba) of the Act;

**MAS** means the Monetary Authority of Singapore;

**notice and notified** mean, respectively, written notice and notified in writing;

**overseas regulatory authority** means a foreign regulatory authority (other than MAS) which regulates financial services and which is established by or for the purposes of a foreign government or legislative body;

**securities** has the meaning given by section 9 of the Act;

**Securities and Futures Act** means the *Securities and Futures Act 2001* of Singapore;

**Singaporean regulatory requirements** means the rules that apply in relation to the financial services including any applicable legislation, instruments made under that legislation and any relevant policies or other documents (however described) issued by MAS; and

**wholesale client** has the meaning given by section 761G of the Act.

Corporations Act 2001 – Paragraphs 741(1)(a) and 741(1)(b) – Exemption and  
Declaration**

**Enabling legislation**

1. The Australian Securities and Investments Commission (*ASIC*) makes this instrument under paragraphs 741(1)(a) and 741(1)(b) of the *Corporations Act 2001* (the *Act*).

**Title**

2. This instrument is ASIC Instrument 26-0012.

**Commencement**

3. This instrument commences on the date it is signed.

**Exemption**

4. Predictive Discovery Limited ACN 127 171 877 (*Predictive*) does not have to comply with Part 6D.2 or 6D.3 of the Act for an offer of Predictive Shares to holders of Target Securities.

**Declaration**

5. Chapter 6D of the Act applies to holders of Predictive Shares as if section 707 were modified or varied by omitting subsections 707(3) and (4) and substituting:

“(3) An offer of a body’s securities for sale within 12 months after their issue needs disclosure to investors under this Part if the body issued the securities:

- (a) without disclosure to investors under this Part; and
- (b) with the purpose of the person to whom they were issued:
  - (i) selling or transferring them; or
  - (ii) granting, issuing or transferring interests in, or options or warrants over, them;

and section 708 or 708A does not say otherwise.”.

**Where this instrument applies**

6. This instrument applies:
- (a) in connection with the Plan of Arrangement on the terms and conditions set out in the Information Circular;
  - (b) where the Information Circular is prepared for a special meeting of the Target and provided to holders of the Target Securities;
  - (c) where the Information Circular is provided to ASX for release to the market prior to any on-sale of Predictive Shares issued under the Plan of Arrangement; and
  - (d) where the Plan of Arrangement complies with all statutory requirements under the *Business Corporations Act* (Québec).

**Interpretation**

7. In this instrument:

**AcquireCo** means 9548-5991 Québec Inc., a directly wholly-owned subsidiary of Predictive incorporated in the Province of Québec, Canada.

**Arrangement Agreement** means the arrangement agreement entered into by the Target, Predictive and AcquireCo dated 5 October 2025 (as amended, supplemented or otherwise modified from time to time).

**ASX** means ASX Limited ACN 008 624 691 or the stock exchange operated by ASX Limited.

**Information Circular** means the information circular dated 11 November 2025, filed on SEDAR+ with the securities commission in the province of Québec and TSXV and prepared in connection with the Arrangement Agreement, with any such amendments, variations or supplements as are approved by the Superior Court of Québec.

**OTCQX** means the OTCQX Market operated by the OTC Markets.

**Predictive Shares** means fully paid ordinary shares in Predictive.

**Plan of Arrangement** means the plan of arrangement involving Predictive, AcquireCo, the Target and the holders of Target Securities pursuant to Chapter XVI – Division II of the *Business Corporations Act* (Québec), agreed pursuant to the Arrangement Agreement.

**Target** means Robex Resources Inc., a company incorporated in Québec, existing under the laws of Canada and listed on the TSXV, OTCQX, Frankfurt Stock Exchange and ASX.

*Target Securities* means common shares in the Target (including CHES depositary interests over common shares) and warrants, options, restricted share units and deferred share units to acquire common shares in the Target.  
*TSXV* means the TSX Venture Exchange.
