# Australian Securities and Investments Commission Corporations Act 2001 — s926A(2)(a) — Exemption

## **Enabling legislation**

 The Australian Securities and Investments Commission (ASIC) makes this instrument under s926A(2)(a) of the Corporations Act 2001 (the Act).

#### Title

2. This instrument is ASIC Instrument 25-0304.

#### Commencement

3. This instrument commences on the day it is signed.

#### Exemption

4. ASIC exempts The Informed Momentum Company LLC, a company incorporated in California, United States with registered number CRD# 144908/SEC#801-70305 (the body) from the requirement to hold an Australian financial services (AFS) licence, in the case specified in Schedule A, on the conditions specified in Schedule B.

## Cessation

- 5. The exemption in paragraph 4 ceases to have effect on the earlier of:
- a. Sub-paragraph 1(1) of Schedule 2 of the ASIC Corporations (Repeal and Transitional) Instrument 2016/396 ceasing to have effect in relation to the relief that was provided under ASIC Class Order [CO 03/1100] US SEC regulated financial service providers;
- the body not complying with any written notice given by ASIC directing the body to give to ASIC, within the time specified in the notice, a written statement containing specified information about the financial service business operated by the body in this jurisdiction; or
- the body being notified in writing by ASIC that it is excluded from relying on this
  instrument.

#### Schedule A

- The exemption in paragraph 4 of this instrument applies where all of the following apply:
  - a. the body is:

    - a registered broker dealer that is an OTC derivatives dealer within the meaning of Rule 3b-12 promulgated under the Exchange Act who is affiliated within the meaning of that Rule with a registered broker dealer who is a member of FINRA; or
    - iii. a registered investment adviser;
  - the body is either:
    - i. a body corporate incorporated in the US or a State of the US; or
    - a partnership formed in the US or a State of the US;
  - c. the body:
    - i. is registered under Division 2 of Part 5B.2 of the Act; or
    - has an Agent at the time the body first purports to rely on this
      instrument and, from that time, has not failed to have an Agent for any
      consecutive period of 10 business days;
  - d. the body's primary business is the provision of financial services;
  - neither the body nor its Agent has been notified by ASIC that the body is excluded from relying on this instrument;
  - f. if the body becomes aware or should reasonably have become aware of matters that give it reason to believe that it has failed, other than in an immaterial respect, to comply with a requirement set out in Schedule B:
    - 15 business days have not passed since the body became so aware or should reasonably have become so aware without the body providing full particulars of the failure to ASIC (to the extent that the body

- knows those particulars or would have known them if it had undertaken reasonable enquiries); and
- 30 business days have not passed from ASIC receiving those particulars from the body without ASIC notifying the body that it may continue to rely on this instrument; and
- g. the body has not notified ASIC that it will not rely on this instrument.
- 2. Where the body provides any of the following financial services (the financial services) in this jurisdiction to wholesale clients:
  - a. providing financial product advice;
  - dealing in a financial product;
     in respect of any of the following financial products:
  - c. securities;
  - interests in a managed investment scheme that is not required to be registered under Chapter 5C of the Act.
- 3. Where the body has provided ASIC with all of the following:
  - a. evidence that paragraph 1(a) of Schedule A is satisfied;
  - a notice that it will provide financial services in this jurisdiction in reliance on this instrument;
  - c. a deed of the body for the benefit of and enforceable by ASIC and the other persons referred to in subsection 659B(1) of the Act that applies notwithstanding that the body may have ceased to rely, or never have relied, on this instrument, which deed provides that:
    - i. the deed is irrevocable except with the prior written consent of ASIC;
    - ii. the body submits to the non-exclusive jurisdiction of the Australian courts in legal proceedings conducted by ASIC (including under section 50 of the ASIC Act) and, in relation to proceedings relating to a financial services law, by any person referred to in subsection 659B(1) of the Act and whether brought in the name of ASIC or the Crown or otherwise;

- the body covenants to comply with any order of an Australian court in respect of any matter relating to the provision of the financial services;
- iv. if the body is not registered under Division 2 of Part 5B.2 of the Act, service of process on the body in relation to legal proceedings conducted by ASIC (including under section 50 of the ASIC Act) and, in relation to proceedings relating to a financial services law, by any person referred to in subsection 659B(1) of the Act and whether brought in the name of ASIC or the Crown or otherwise can be effected by service on the Agent; and
- v. the body covenants that, on written request of either the SEC or ASIC, it will give or vary written consent and take all other practicable steps to enable and assist the SEC to disclose to ASIC and ASIC to disclose to the SEC any information or document that the SEC or ASIC has that relates to the body; and
- d. written consents to the disclosure by the SEC to ASIC and ASIC to the SEC of any information or document that the SEC or ASIC has that relates to the body. The consents must be in such form (if any) as ASIC specifies in writing.

## Schedule B

#### The body must:

- provide each of the financial services in this jurisdiction in a manner which would comply, so far as is possible, with the US regulatory requirements if the financial service were provided in the US in like circumstances;
- notify ASIC, as soon as practicable and in any event within 15 business days after the body became aware or should reasonably have become aware, and in such form if any as ASIC may from time to time specify in writing, of the details of:

  - i. significant enforcement action;
  - significant disciplinary action;
  - significant investigation (unless, after having taken reasonable steps to enable notification to be given to ASIC, the body is prohibited by law from giving such notification but only to the extent of the prohibition);
- provide written disclosure to all persons to whom the financial services are provided in this jurisdiction (before the financial services are provided) containing prominent statements to the following effect:
  - the body is exempt from the requirement to hold an Australian financial services licence under the Act in respect of the financial services; and
  - the body is regulated by the SEC under US laws, which differ from Australian laws; and
- 4. if ASIC gives the body a written notice directing the body to lodge with ASIC, within the time specified in the notice, a written statement containing specified information about any financial service provided by the body in this jurisdiction—comply with the notice.

dealing has the meaning given by section 9 of the Act;

examining authority, in relation to a body, means a self-regulatory organisation to which the body belongs which has not been relieved of responsibility relating to the body under section 17(d)(1)(A) of the Exchange Act in any respect;

Exchange Act means the Securities and Exchange Act of 1934 of the US;

financial product has the meaning given by section 9 of the Act;

financial product advice has the meaning given by section 766B of the Act;

financial services law has the meaning given by section 761A of the Act;

FINRA means the Financial Industry Regulatory Authority of the US;

interest in a managed investment scheme has the meaning given by section 9 of the Act;

managed investment scheme has the meaning given by section 9 of the Act;

notice and notified mean, respectively, written notice and notified in writing;

overseas regulatory authority means a foreign regulatory authority (other than the SEC) which regulates financial services and which is established by or for the purposes of a foreign government or legislative body;

registered broker dealer means a broker or dealer registered under section 15(b) of the Exchange Act;

registered investment adviser means a body corporate or a partnership formed in the US or a State of the US registered under section 203(c) of the Investment Advisers Act of 1940 of the US:

SEC means the Securities and Exchange Commission of the US;

securities has the meaning given by section 9 of the Act;

US means the United States of America;

US regulatory requirements means the rules that apply in relation to the financial services including:

- (a) any applicable legislation, instruments made under that legislation and any relevant policies or other documents (however described) issued by the SEC; and
- (b) if the body is covered by subparagraph (1)(a)(i) of Schedule A but not subparagraphs (1)(a)(ii) or (iii) of that Schedule—any applicable rules, policies or other documents (however described) of FINRA; and

wholesale client has the meaning given in section 761G of the Act.

  - (a) the expiration date specified in subitem 1(3) of Schedule 2 of the ASIC Corporations (Repeal and Transitional) Instrument 2016/396 ceasing to have effect in relation to the relief that was provided under ASIC Class Order [CO 03/1100] US SEC regulated financial service providers; or
  - (b) ABN AMRO Capital Markets (USA) LLC, a limited liability company formed under the laws of the state of Delaware under file number 7259985 and registered with the SEC under number 8-71059 (the body), not complying with any written notice given by ASIC directing the body to give to ASIC, within the time specified in the notice, a written statement containing specified information about the financial service business operated by the body in this jurisdiction; or
  - (c) the body being notified in writing by ASIC that it is excluded from relying on this instrument.

# Exemption

  - (a) evidence and submissions that paragraphs 1(a) and 1(b) of Schedule A of this instrument is satisfied;
  - a notice that it will provide financial services in this jurisdiction in reliance on this instrument;
  - (c) a deed of the body for the benefit of and enforceable by ASIC and the other persons referred to in subsection 659B(1) of the Act that applies notwithstanding that the body may have ceased to rely, or never have relied, on this instrument, which provides that:

- the deed is irrevocable except with the prior written consent of ASIC;
   and

#### Commencement

3. This instrument commences on the date it is signed.

## Exemption

- Thakral Corporation Ltd (Thakral), a foreign company incorporated in Singapore, does not have to comply with any of the following provisions of the Act:
  - a. subsection 734(2); and
  - b. subsection 1018A(2).

## Where this instrument applies

- 5. This instrument applies to any advertisements or publications of statements that:
  - a. refer to an intended or proposed offer of stapled securities related to GemLife and which are comprised of one fully paid ordinary share in a holding company and one or more fully paid ordinary units in one or more registered schemes by the holding company and the responsible entity of the registered schemes respectively (GemLife Communities), stapled together to be quoted on the ASX (Stapled Security) (Offer);
