**Australian Securities and Investments Commission  
Corporations Act 2001 – Paragraph 1020F(1)(a) – Exemption**

**Enabling provisions**

1. The Australian Securities and Investments Commission (*ASIC*) makes this instrument under paragraph 1020F(1)(a) of the Corporations Act 2001 (*Act*).

**Title**

2. This instrument is ASIC Instrument 21-0835.

**Commencement**

3. This instrument commences on the date it is signed.

**Exemption**

4. BG&E Group Limited ACN 650 895 426 (**Company**) does not have to comply with Division 5A of Part 7.9 of the Act for written invitations and related communications to shareholders to make offers to sell any or all of their shares on the Trading Intention Noticeboard.

**Where the exemption applies**

5. The exemption in paragraph 4 applies where:
  - (a) the Company advises shareholders (and prospective shareholders) of an independent valuation of the Company's shares and invites them to:
    - (i) make offers to buy or sell shares on the Trading Intention Noticeboard; or
    - (ii) update any existing buy or sell requests on the Trading Intention Noticeboard;
  - (b) the Company engages in any related communications with shareholders or prospective shareholders in relation to any of the matters in paragraph 5(a) above.
