Australian Securities and Investments Commission Corporations Act 2001 — Paragraph 601QA(1)(b) — Declaration

Enabling legislation

1. The Australian Securities and Investments Commission (ASIC) makes this instrument under paragraph 601QA(1)(b) of the Corporations Act 2001 (the Act).

Title

2. This instrument is ASIC Instrument 25-0033.

Commencement

3. This instrument commences on the day it is signed.

Declaration

- 4. Chapter 5C of the Act applies to Copia Investment Partners Ltd ACN 092 872 056 (*Copia*) as responsible entity of the Vertium Equity Income Fund ARSN 620 093 423 (*VEIF*) as if section 253LA of the Act were modified or varied by:
 - (a) omitting paragraph 253LA(2)(b) and substituting:
 - "(b) the resolution must be passed by at least 50% of the total votes that may be cast by eligible persons; and"; and
 - (b) after subsection 253LA(2), inserting:
 - "(3) For the purposes of subsection (2):

abstaining member means a member of the scheme that:

- (a) is an operator and custodian of an IDPS and/or is acting in its capacity as a registerable superannuation entity (and includes a trustee or custodian entity or sub-custodian of any of the foregoing);
- (b) has a written policy of not voting their interests in relation to a resolution arising from the client's investments in the IDPS or registrable superannuation entity (as applicable), has not signalled their intention to vote on the extraordinary resolution by providing a voting proxy, or does not attend the meeting to vote; and
- (c) has abstained from voting on the resolution.

custodian in relation to an IDPS, has the meaning given in ASIC Corporations (Investor Directed Portfolio Services) Instrument 2023/669.

eligible persons means members of the scheme (excluding abstaining members) entitled to vote on the resolution at the meeting (including members who are not present in person or by proxy).

IDPS has the meaning given in ASIC Corporations (Investor Directed Portfolio Services) Instrument 2023/669.

operator in relation to an IDPS, has the meaning given in ASIC Corporations (Investor Directed Portfolio Services) Instrument 2023/669

registerable superannuation entity has the meaning given in subsection 10(1) of the Superannuation Industry (Supervision) Act 1993.

sub-custodian in relation to an IDPS, has the meaning given in ASIC Corporations (Investor Directed Portfolio Services) Instrument 2023/669.

Where this instrument applies

- 5. This instrument applies where:
 - (a) Copia has called a meeting of scheme members of VEIF to vote on a resolution to the effect that Equity Trustees Limited ACN 004 031 298 replaces Copia as responsible entity of VEIF upon the retirement of Copia as responsible entity;
 - (b) The Explanatory Materials include an explanation of the effect of this instrument in relation to the resolution to be considered at the meeting, which may be by way of a supplement provided to members of VEIF; and
 - (c) the abstaining members.

Interpretation

6. In this instrument:

Explanatory Materials means the explanatory memorandum and notice of meeting sent to members of VEIF which is substantially in the same form as that provided to ASIC on or about 14 January 2025 as modified or supplemented for the purposes of paragraph 5(b) of this instrument.

Australian Securities and Investments Commission Corporations Act 2001 — s926A(2)(a) — Exemption

Enabling legislation

1. The Australian Securities and Investments Commission (ASIC) makes this instrument under s926A(2)(a) of the Corporations Act 2001 (the Act).

Title

2. This instrument is ASIC Instrument 25-0068.

Commencement

3. This instrument commences on the day it is signed.

Exemption

4. ASIC exempts Ravenswood Partners LP, a partnership formed in a State of the US (Delaware), and registered with the US Securities and Exchange Commission under file number 801-131619 (the *body*) from the requirement to hold an Australian financial services (*AFS*) licence, in the case specified in Schedule A.

Cessation

- 5. The exemption in paragraph 4 ceases to have effect on the earlier of:
 - (a) subparagraph 1(1) of Schedule 2 of the ASIC Corporations (Repeal and Transitional) Instrument 2016/396 ceasing to have effect in relation to the relief that was provided under ASIC Class Order [CO 03/1100] US SEC regulated financial services providers; or
 - (b) the body not complying with any written notice given by ASIC directing the body to give to ASIC, within the time specified in the notice, a written statement containing specified information about the financial service business operated by the body in this jurisdiction; or
 - (c) the body being notified in writing by ASIC that it is excluded from relying on this instrument.

Schedule A

- 1. The exemption in paragraph 4 of this instrument applies where all of the following apply:
 - (a) the body is a registered investment adviser;

- (b) the body is a partnership formed in the US or a State of the US;
- (c) the body has an Agent at the time the body first purports to rely on this instrument and, from that time, has not failed to have an Agent for any consecutive period of 10 business days;
- (d) the body's primary business is the provision of financial services;
- (e) neither the body nor its Agent has been notified by ASIC that the body is excluded from relying on this instrument;
- (f) if the body becomes aware or should reasonably have become aware of matters that give it reason to believe that it has failed, other than in an immaterial respect, to comply with a requirement set out in Schedule B:
 - 15 business days have not passed since the body became so aware or should reasonably have become so aware without the body providing full particulars of the failure to ASIC (to the extent that the body knows those particulars or would have known them if it had undertaken reasonable enquiries); and
 - (ii) 30 business days have not passed from ASIC receiving those particulars from the body without ASIC notifying the body that it may continue to rely on this instrument; and
- (g) the body has not notified ASIC that it will not rely on this instrument.
- 2. Where the body provides any of the following financial services (the *financial services*) in this jurisdiction to wholesale clients (and the body is authorised under US regulatory requirements to provide the financial services in the US):
 - (a) providing financial product advice;
 - (b) dealing in a financial product;

in respect of any of the following financial products (and in respect of which the body is authorised under US regulatory requirements to provide financial services in the US):

- (c) derivatives;
- (d) foreign exchange contracts;
- (e) securities;
- (f) debentures, stocks or bonds issued by a government;

- (h) interests in a managed investment scheme that is not required to be registered under Ch 5C of the Act.
- 3. Where the body has provided ASIC with all of the following:
 - (a) evidence and submissions that paragraph 1(a) of Schedule A is satisfied;
 - (b) a notice that it will provide financial services in this jurisdiction in reliance on this instrument:
 - (c) a deed of the body for the benefit of and enforceable by ASIC and the other persons referred to in s659B(1) of the Act that applies notwithstanding that the body may have ceased to rely, or never have relied, on this instrument, which deed provides that:
 - (i) the deed is irrevocable except with the prior written consent of ASIC;
 - (ii) the body submits to the non-exclusive jurisdiction of the Australian courts in legal proceedings conducted by ASIC (including under s50 of the ASIC Act) and, in relation to proceedings relating to a financial services law, by any person referred to in s659B(1) of the Act and whether brought in the name of ASIC or the Crown or otherwise;
 - (iii) the body covenants to comply with any order of an Australian court in respect of any matter relating to the provision of the financial services;
 - (iv) if the body is not registered under Division 2 of Part 5B.2 of the Act, service of process on the body in relation to legal proceedings conducted by ASIC (including under s50 of the ASIC Act) and, in relation to proceedings relating to a financial services law, by any person referred to in s659B(1) of the Act and whether brought in the name of ASIC or the Crown or otherwise can be effected by service on the Agent; and
 - (v) the body covenants that, on written request of either the SEC or ASIC, it will give or vary written consent and take all other practicable steps to enable and assist the SEC to disclose to ASIC and ASIC to disclose to the SEC any information or document that the SEC or ASIC has that relates to the body; and
 - (d) written consents to the disclosure by the SEC to ASIC and ASIC to the SEC of any information or document that the SEC or ASIC has that relates to the body The consents must be in such form (if any) as ASIC specifies in writing.

Schedule B

- The body must provide each of the financial services in this jurisdiction in a manner which would comply, so far as is possible, with the US regulatory requirements if the financial service were provided in the US in like circumstances.
- 2. The body must:
 - (a) notify ASIC, as soon as practicable and in any event within 15 business days after the body became aware or should reasonably have become aware, and in such form if any as ASIC may from time to time specify in writing, of the details of:
 - (i) each significant change to, including the termination of, the registration as a registered investment adviser applying to the body relevant to the financial services the body provides or intends to provide in this jurisdiction; and
 - (ii) each significant particular exemption or other relief which the body obtains from the US regulatory requirements relevant to the financial services the body provides or intends to provide in this jurisdiction; and
 - (iii) each action or investigation of the following kinds taken by the SEC or other overseas regulatory authority against the body in a foreign jurisdiction in relation to financial services provided in the foreign jurisdiction:
 - (A) significant enforcement action;
 - (B) significant disciplinary action;
 - (C) significant investigation (unless, after having taken reasonable steps to enable notification to be given to ASIC, the body is prohibited by law from giving such notification but only to the extent of the prohibition); and
 - (b) provide written disclosure to all persons to whom the financial services are provided in this jurisdiction (before the financial services are provided) containing prominent statements to the following effect:
 - (i) the body is exempt from the requirement to hold an AFS licence under the Act in respect of the financial services; and
 - (ii) the body is regulated by the SEC under US laws, which differ from Australian laws; and
 - (c) if ASIC gives the body a written notice directing the body to lodge with ASIC, within the time specified in the notice, a written statement containing specified

information about any financial service provided by the body in this jurisdiction—comply with the notice.

Interpretation

In this instrument:

address, in relation to a company, means the address of the registered office of the company;

Agent means a natural person resident in this jurisdiction or a company, whose name and address were last notified to ASIC by the body for the purposes of this instrument, and who is authorised to accept on the body's behalf, service of process from ASIC and, in relation to proceedings relating to a financial services law, from any person referred to in s659B(1) of the Act;

ASIC Act means the Australian Securities and Investments Commission Act 2001;

derivative has the meaning given by \$761 D of the Act;

financial product advice has the meaning given by s761A of the Act;

financial services law has the meaning given by s761A of the Act;

foreign exchange contract has the meaning given by s761A of the Act;

notice and notified mean, respectively, written notice and notified in writing;

overseas regulatory authority means a foreign regulatory authority (other than the SEC) which regulates financial services and which is established by or for the purposes of a foreign government or legislative body;

registered investment adviser means a body corporate or a partnership formed in the US or a State of the US registered under s203(c) of the *Investment Advisers Act 1940* (US);

SEC means the Securities and Exchange Commission of the US;

US means the United States of America;

US regulatory requirements means the rules that apply in relation to the financial services including any applicable legislation, instruments made under that legislation and any relevant policies or other documents (however described) issued by the SEC;

wholesale client has the meaning given in s761G of the Act.

 - (ii) the body submits to the non-exclusive jurisdiction of the Australian courts in legal proceedings conducted by ASIC (including under section 50 of the ASIC Act) and, in relation to proceedings relating to a financial services law, by any person referred to in subsection 659B(1) of the Act and whether brought in the name of ASIC or the Crown or otherwise;
 - (iii) the body covenants to comply with any order of an Australian court in respect of any matter relating to the provision of the financial services;
 - (iv)if the body is not registered under Division 2 of Part 5B.2 of the Act, service of process on the body in relation to legal proceedings conducted by ASIC (including under section 50 of the ASIC Act) and, in relation to proceedings relating to a financial services law, by any person referred to in subsection 659B(1) of the Act and whether brought in the name of ASIC or the Crown or otherwise can be effected by service on the Agent; and
 - (v) the body covenants that, on written request of either the FCA or ASIC, it will give or vary written consent and take all other practicable steps to enable and assist the FCA to disclose to ASIC and ASIC to disclose to the FCA any information or document that the FCA or ASIC has that relates to the body; and
 - (d) written consents to the disclosure by the FCA to ASIC and ASIC to the FCA of any information or document that the FCA or ASIC has that relates to the body. The consents must be in such form (if any) as ASIC specifies in writing.

Schedule C

- The body must provide each of the financial services in this jurisdiction in a manner which would comply, so far as is possible, with the UK regulatory requirements if the financial service were provided in the UK in like circumstances.
- 2. The body must:
 - (a) notify ASIC, as soon as practicable and in any event within 15 business days after the body became aware or should reasonably have become aware, and in such form if any as ASIC may from time to time specify in writing, of the details of:

- each significant change to, including the termination of, the Part 4A Permission applying to the body relevant to the financial services the body provides or intends to provide in this jurisdiction; and

- (b) provide written disclosure to all persons to whom the financial services are provided in this jurisdiction (before the financial services are provided) containing prominent statements to the following effect:
 - the body is exempt from the requirement to hold an Australian financial services licence under the Act in respect of the financial services; and
 - (ii) as applicable:
 - (A) for a dual-regulated body the body is authorised by the PRA and regulated by the FCA and PRA under UK laws, which differ from Australian laws;
 - (B) otherwise the body is authorised and regulated by the FCA under UK laws, which differ from Australian laws; and
- (e) if ASIC gives the body a written notice directing the body to lodge with ASIC, within the time specified in the notice, a written statement containing specified information about any financial service provided by the body in this jurisdiction – comply with the notice.

dual-regulated body means a body whose regulated activities in the United Kingdom include a PRAregulated authority within section 22A of the FSM Act;

financial product advice has the meaning given by section 766 of the Act;

financial services law has the meaning given by section 761A of the Act;

FCA means the Financial Conduct Authority of the United Kingdom and, for the avoidance of doubt, includes the Financial Services Authority of the United Kingdom as it was previously known before 1 April 2013;

FSM Act means the Financial services and Markets Act 2000 of the United Kingdom;

foreign exchange contract has the meaning given by section 766D of the Act;

notice and notified mean, respectively, written notice and notified in writing;

overseas regulatory authority means a foreign regulatory authority (other than the FCA or PRA) which regulates financial services and which is established by or for the purposes of a foreign government or legislative body;

Part 4A Permission means a permission given under Part 4A of the FSM Act or having effect as if so given under that Part;

PRA means the Prudential Regulation Authority of the United Kingdom;

securities has the meaning given by section 761A of the Act;

UK regulatory requirements means the rules that apply in relation to the financial services including any applicable legislation, instruments made under that legislation and any relevant policies or other documents (however described) issued by the FCA or PRA; and

wholesale client has the meaning given in section 761G of the Act.
