**Australian Securities and Investments Commission
Corporations Act 2001 – Subsections 601QA(1), 926A(2), 992B(1) and 1020F(1) –
Exemption**

Enabling legislation

1. The Australian Securities and Investments Commission (*ASIC*) makes this instrument under subsections 601QA(1), 926A(2), 992B(1) and 1020F(1) of the *Corporations Act 2001 (Act)*.

Title

2. This instrument is ASIC Instrument 22-0849.

Commencement

3. This instrument commences on the day it is signed.

Repeal

4. ASIC Instrument 21-0226 is repealed.

Exemption

5. Semper Securities Ltd ACN 630 113 530 (*Semper*) in its capacity as trustee of the Semper Securities Unit Trust ABN 12 859 602 492 (*Trust*) does not have to comply with the following:
 - (a) subsection 601ED(5) of the Act in relation to the operation of a managed investment scheme (*Scheme*) to the extent that it would require Semper to register a Scheme that may arise from the issue of the Semper Notes;
 - (b) subsection 992AA(1) of the Act in relation to an offer of an interest in the Scheme;
 - (c) Divisions 2 to 5 of Part 7.9 of the Act in relation to an offer, issue or recommendation to acquire an interest in the Scheme; and
 - (d) the requirement in subsection 911A(1) of the Act to hold an Australian financial services licence covering the provision of financial services to retail clients in relation to an interest in the Scheme.
6. Semper in its capacity as trustee of the Trust does not have to comply with the requirement in subsection 911A(1) of the Act to hold an Australian financial services licence covering the provision of financial services to wholesale clients in relation to an interest in the Scheme.

Where this exemption applies

7. The exemptions in paragraph 5 apply where all of the following are satisfied:
 - (a) before or at the time the Semper Notes are offered to a person as a retail client (*Noteholder*), the Noteholder is provided with information in the relevant disclosure document for the Semper Notes which sets out the terms of the relief under paragraphs 5 and 6 of this instrument; and
 - (b) the disclosure document for the Semper Notes includes a clear and prominent statement to the effect that under the Semper Notes, Semper undertakes to repay money as a debt to the Noteholder subject to the terms of their issue.
8. The exemption in paragraph 6 applies where all the following are satisfied:
 - (a) before or at the time the Semper Notes are offered to a person (other than as a retail client) (*Wholesale Noteholder*), the Wholesale Noteholder is provided with information in the relevant information memorandum which sets out the terms of the relief under paragraph 6 of this instrument; and
 - (b) the information memorandum provided to the Wholesale Noteholder includes a clear and prominent statement to the effect that under the Semper Notes, Semper undertakes to repay money as a debt to the Wholesale Noteholder subject to the terms of their issue.

Interpretation

9. In this instrument:

Master Trust Deed means the master trust deed dated 25 May 2021 in accordance with which Semper may issue the Semper Notes that are specifically secured to specified assets of Semper, and in the same form as the final draft copy provided to ASIC on 2 February 2021.

Semper Notes means debentures issued by Semper in accordance with the Master Trust Deed.

**Australian Securities and Investments Commission
Corporations Act 2001 – Subsection 655A(1)(b) - Declaration**

Enabling Legislation

1. The Australian Securities and Investments Commission (*ASIC*) makes this instrument under paragraph 655A(1)(b) of the *Corporations Act 2001* (the *Act*).

Title

2. This instrument is ASIC Instrument 22-0891.

Commencement

3. This instrument commences on the date it is signed.

Declaration

4. Chapter 6 of the Act applies to Brisbane Markets Limited ACN 064 983 017 (*Bidder*) as if section 636 as notionally modified by ASIC Class Order [13/521] and by *ASIC Corporations (Consents to Statements) Instrument 2016/72* was modified or varied as follows:

- (a) omit paragraph 636(3)(d), substitute:

“(d) the statement was made either:

- (i) in a document lodged with ASIC, or
- (ii) in a document lodged with the operator of a prescribed financial market by a listed company, managed investment scheme, notified foreign passport fund or other body in compliance with the listing rules of the prescribed financial market; or
- (iii) if the target is not a disclosing entity – in a document:
 - (A) sent to the target’s shareholders; and
 - (B) published on the target’s website without access restrictions and in a way that is publicly accessible, at the time of lodgement of the bidder’s statement;”

- (b) the statement comprises the following information (*sales information*) relating to sales of the target’s securities by private treaty:
 - (i) the date or month on which the securities were sold;
 - (ii) the number of sales transactions occurring on the relevant date or during the relevant month;
 - (iii) the approximate number of securities sold on the relevant date or during the relevant month; and

- (iv) the price, or low or high price range, of securities sold on the relevant date or during the relevant month;
- (c) the sales information is in a document published on the target's website without access restrictions and in a way that is publicly accessible, at the time of lodgement of the bidder's statement; and
- (d) the bidder's statement or the accompanying document states, close to the sales information:
 - (i) the name of the person who prepared the sales information;
 - (ii) that the person who prepared the sales information has not consented to the use of the sales information in the bidder's statement or the accompanying document (as applicable); and
 - (iii) that the information constituting the sales information may not be complete, accurate or up to date, does not constitute a recommendation and may not be a complete, accurate or reliable indication of the actual price or full consideration received in connection with any sale of shares or the value of shares;

provided that, if the bidder's statement or accompanying document includes more than one reference relating to sales information prepared by the same person, this paragraph only has to be satisfied in relation to the first occurring reference provided it is apparent that the subsequent references are from the same source."

Where this instrument applies

5. This instrument applies in relation to a proportional off-market bid (*Bid*) by the Bidder for 65% of each shareholder's ordinary shares in Perth Markets Group Limited ACN 633 346 184 publicly proposed on 6 October 2022.

1. The Australian Securities and Investments Commission makes this instrument under paragraph 601QA(1)(b) of the *Corporations Act 2001* (the *Act*).

Title

2. This instrument is ASIC Instrument 22-0904.

Commencement

3. This instrument commences on the day it is signed.

Declaration

4. Chapter 5C of the Act applies to Dexu Wholesale Property Limited ACN 006 036 442 in its capacity as the responsible entity of Dexu Wholesale Property Fund ARSN 090 499 013, Dexu Wholesale Property Trust 3 ARSN 601 440 377 and Dexu Wholesale Property Trust 4 ARSN 616 222 765 (each a *scheme*) as if the following provisions of that Chapter were modified or varied as follows:

- (a) after section 601FE insert:

“601FEA Modification of duties: stapled securities

- (1) This section applies to a registered scheme where the interests in the scheme and interests in other registered schemes are components of stapled securities.
- (2) For the purposes of paragraphs 601FC(1)(c) and 601FD(1)(c), an obligation to act in the best interests of the members of the scheme is an obligation to act in the best interests of the members of the scheme having regard to their interests as members of the scheme and of the other schemes.
- (3) For the purposes of paragraphs 601FC(1)(e), 601FD(1)(d) and 601FD(1)(e), and subsection 601FE(1), an obligation not to make use of information, or not make improper use of position, in order to cause detriment to the members of the scheme is an obligation not to do those things in order to cause detriment to the members of the scheme having regard to their membership of the scheme and of the other schemes.”;

- (b) after subsection 208(2) as notionally inserted by section 601LC, insert:
- “(2A) Member approval is not required for the giving of a financial benefit and the benefit need not be given within 15 months if all the following conditions are satisfied:
- (a) the benefit either:
 - (i) is given out of the scheme property of a registered scheme; or
 - (ii) could endanger the scheme property;
 - (b) all of the interests in the scheme and all of the interests in other registered schemes are components of stapled securities;
 - (c) the benefit is given by:
 - (i) the responsible entity of the scheme; or
 - (ii) an entity that the responsible entity controls; or
 - (iii) an agent of, or person engaged by, the responsible entity;
 - (d) the benefit is given to:
 - (i) an entity wholly owned, whether directly or indirectly, by the scheme; or
 - (ii) one of the other schemes or an entity that is wholly owned, whether directly or indirectly, by one of the other schemes; or
 - (iii) an entity wholly owned, whether directly or indirectly, jointly by the scheme and one or more of the other schemes.
- (2B) For the purposes of this section:
- (a) an entity is wholly owned by another entity if all of the shares or interests (as applicable) in the first-mentioned entity are held by, or held by a nominee for (in the case of the second-mentioned entity being a company), or form part of the trust property of (in the case of the second-mentioned entity being a trust), the second-mentioned entity or a wholly owned entity of it; and

- (b) a reference to the giving of a benefit to an entity which is a trust is a reference to the giving of a benefit to the trustee of the trust so as to form part of the trust property of the trust or for the benefit of the trust beneficiaries.”; and
- (c) insert after section 601PC:
- “601PD Stapled securities**
- For the purposes of this Chapter:
- stapled securities* means two or more financial products including at least one interest in a registered scheme where:
- (a) under the terms on which each of the products are to be traded, they must be transferred together; and
- (b) there are no financial products in the same class as those financial products which may be transferred separately.”.

Where declaration applies

5. The declaration in paragraph 4 applies where each interest in the scheme must, under the terms upon which it is to be traded, only be transferred with each interest in the other schemes.
