**Australian Securities and Investments Commission
Corporations Act 2001 – Paragraphs 741(1)(a) and 741(1)(b) – Exemption and
Declaration**

Enabling legislation

1. The Australian Securities and Investments Commission (*ASIC*) makes this instrument under paragraphs 741(1)(a) and 741(1)(b) of the *Corporations Act 2001* (the *Act*).

Title

2. This instrument is ASIC Instrument 22-0060.

Commencement

3. This instrument commences on the day it is signed.

Exemption

4. OreCorp Limited ACN 147 917 299 (*OreCorp*) does not have to comply with Parts 6D.2 and 6D.3 of the Act for an offer of securities in Solstice Minerals Limited ACN 150 154 162 (*Solstice*) (*Shares*) to shareholders of OreCorp.

Declaration

5. Chapter 6D of the Act applies to each holder of Shares as if section 707 was modified or varied by omitting subsections 707(3), (4), (5) and (6).

Where this instrument applies

6. The exemption in paragraph 4 applies to invitations by OreCorp to its shareholders to vote at a general meeting on a capital reduction of OreCorp that will be effected and satisfied by an in-specie distribution of Shares to the shareholders of OreCorp (*Demerger Proposal*), in accordance with a notice of meeting that:
 - (a) is in substantially the same form as the draft notice of meeting given to ASIC on 24 February 2022; and
 - (b) includes a statement:
 - (i) describing the need for, and the effect of, the relief contained in this instrument as it applies to shareholders; and

- (ii) that the notice of meeting is in substantially the same form as the draft notice of meeting given to ASIC on 24 February 2022.
7. The declaration in paragraph 5 applies where:
- (a) a Solstice shareholder makes an offer of their Shares for sale;
 - (b) the Shares were transferred to a holder of ordinary shares in OreCorp, or to a Sale Nominee (or its related body corporate) pursuant to the Demerger Proposal referred to in paragraph 6 within the previous 12 months; and
 - (c) the offer is not made within 12 months of a sale or transfer of the Shares by a person, other than OreCorp, who:
 - (i) controls Solstice;
 - (ii) would have been required by subsection 707(2) of the Act to give disclosure to investors under Part 6D.2 of the Act but for section 708 of the Act; and
 - (iii) did not give disclosure to investors under Part 6D.2 of the Act because of section 708 of the Act.

Interpretation

8. In this instrument:

Ineligible OreCorp Shareholders means the ineligible shareholders as defined in the notice of meeting in Schedule 1.

Sale Nominee means a participant of the financial market operated by ASX Limited ACN 008 624 691 with whom, or with whose related body corporate, OreCorp has entered into arrangements for the sale of Shares to which Ineligible OreCorp Shareholders would otherwise have been entitled to under the Demerger Proposal.

**Australian Securities and Investments Commission
Corporations Act 2001 – Subsection 926A(2)(a) – Exemption**

Enabling legislation

1. The Australian Securities and Investments Commission (*ASIC*) makes this instrument under s926A(2)(a) of the *Corporations Act 2001*.

Title

2. This instrument is ASIC Instrument 22-0070.

Commencement

3. This instrument commences on the day it is signed.

Exemption

4. ASIC exempts Mingshi Investment Management Limited, a company incorporated under the laws of Hong Kong and registered under number BRB143 in the Securities and Futures Commission of Hong Kong Register (the *body*), from the requirement to hold an Australian financial services (AFS) licence in the case referred to in Schedule A.

Cessation

5. The exemption in paragraph 4 ceases to have effect on the earlier of:
 - (a) sub-paragraph 1(3) of Sch 2 of the *ASIC Corporations (Repeal and Transitional) Instrument 2016/396* ceasing to have effect in relation to the relief that was provided under ASIC Class Order [CO 03/1103 *Hong Kong SFC regulated financial service providers*];
 - (b) the body failing to comply with any written notice given by ASIC directing the body to give to ASIC, within the time specified in the notice, a written statement containing specified information about the financial service business operated by the body in this jurisdiction.

Schedule A

1. The exemption in paragraph 4 applies where all of the following apply:
 - (a) The body holds a current licence or certificate of registration granted by the Securities and Futures Commission of Hong Kong (*SFC*);
 - (b) the body is either a body corporate incorporated in Hong Kong or a partnership formed in Hong Kong;
 - (c) the body is a registered investment adviser.

- (d) the body:
 - (i) is registered under Div 2 of Pt 5B.2 of the Act; or

 - (g) if the body becomes aware or should reasonably have become aware of matters that give it reason to believe that it has failed, other than in an immaterial respect, to comply with a requirement set out in Schedule B;
 - (i) 15 business days have not passed since the body became so aware or should reasonably have become so aware without the body providing full particulars of the failure to ASIC (to the extent that the body knows those particulars or would have known them if it had undertaken reasonable enquiries); and
 - (ii) 30 business days have not passed from ASIC receiving those particulars from the body without ASIC notifying the body that it may continue to rely on this instrument; and
 - (h) the body has not notified ASIC that it will not rely on this instrument.
2. Where the body provides any of the following financial services (the *financial services*) in this jurisdiction to wholesale clients:
- (a) providing financial product advice;
 - (b) dealing in a financial product;
- in respect of any of the following financial products:
- (a) derivatives;
 - (b) foreign exchange contracts;
 - (c) securities;
 - (d) debentures, stocks or bonds issued by a government;
 - (e) managed investment products; or
 - (f) interests in a managed investment scheme that is not required to be registered under Chapter 5C of the Act.
3. Where the body has provided ASIC with all of the following:
- (a) evidence that paragraph 1(a) of Schedule A is satisfied that ASIC has stated in writing is adequate;

- (b) a notice that it will provide the financial services in this jurisdiction in reliance on this instrument;
- (c) a deed of the body for the benefit of and enforceable by ASIC and the other persons referred to in s659B(1) of the Act that applies notwithstanding that the body may have ceased to rely, or never have relied, on this instrument, which deed provides that:
 - i. the deed is irrevocable except with the prior written consent of ASIC; and
 - ii. the body submits to the non-exclusive jurisdiction of the Australian courts in legal proceedings conducted by ASIC (including under s50 of the ASIC Act) and, in relation to proceedings relating to a financial services law, by any person referred to in s659B(1) of the Act and whether brought in the name of ASIC or the Crown or otherwise; and
 - iii. the body covenants to comply with any order of an Australian court in respect of any matter relating to the provision of the financial services;
 - iv. if the body is not registered under Div 2 of Pt 5B.2 of the Act, service of process on the body in relation to legal proceedings conducted by ASIC (including under section 50 of the ASIC Act) and, in relation to proceedings relating to a financial services law, by any person referred to in s659B(1) of the Act and whether brought in the name of ASIC or the Crown or otherwise can be effected by service on the agent; and
 - v. the body covenants that, on written request of either the SFC or ASIC, it will give or vary written consent and take all other practicable steps to enable and assist the SFC to disclose to ASIC and ASIC to disclose to the SFC any information or document that the SFC or ASIC has that relates to the body;
- (d) written consents to the disclosure by the SFC to ASIC and ASIC to the SFC of any information or document that the SFC or ASIC has that relates to the body. The consents must be in such form (if any) as ASIC specifies in writing.

Schedule B

- (1) The body must:
 - (a) provide each of the financial services in this jurisdiction in a manner which would comply, so far as is possible, with the Hong Kong regulatory requirements if the financial service were provided in Hong Kong in like circumstances;

- (b) notify ASIC, as soon as practicable and in any event within 15 business days after the body became aware or should reasonably have become aware, and in such form if any as ASIC may from time to time specify in writing, of the details of:
- (i) each significant change to, including the termination of, the registration as a registered investment adviser applying to the body relevant to the financial services the body provides or intends to provide in this jurisdiction; and
 - (ii) each significant particular exemption or other relief which the body obtains from the Hong Kong regulatory requirements relevant to the financial services the body provides or intends to provide in this jurisdiction; and
 - (iii) each action or investigation of the following kinds taken by the SFC or other overseas regulatory authority against the body in a foreign jurisdiction in relation to the financial services provided in the foreign jurisdiction:
 - (A) significant enforcement action;
 - (B) significant disciplinary action;
 - (C) significant investigation (unless, after having taken reasonable steps to enable notification to be given to ASIC, the body is prohibited by law from giving such notification but only to the extent of the prohibition); and
- (c) provide written disclosure to all persons to whom the financial services are provided in this jurisdiction (before the financial services are provided) containing prominent statements to the following effect:
- (i) the body is exempt from the requirement to hold an AFS licence under the Act in respect of the financial services; and
 - (ii) the body is regulated by the SFC under Hong Kong laws, which differ from Australian laws; and

Interpretation

In this instrument:

Act means the *Corporations Act 2001*;

address, in relation to a company, means the address of the registered office of the company;

Overseas regulatory authority means a foreign regulatory authority (other than the SFC which regulates financial services and which is established by or for the purposes of a foreign government or legislative body);

registered investment adviser means a licence granted under section 116 of the SFO or deemed to be granted under sections 22 or 25(b) of Schedule 10 to the SFO;

securities has the meaning given by s761A of the Act;


SFC means the Securities and Futures Commission of Hong Kong;

SFO means the *Securities and Futures Ordinance 2002* of Hong Kong; and

Enabling legislation

1. The Australian Securities and Investments Commission (*ASIC*) makes this instrument under paragraph 601QA(1)(a) of the *Corporations Act 2001* (the *Act*).

Title

2. This instrument is ASIC Instrument 22-0109.

Commencement

3. This instrument commences on the day it is signed.

Exemption—Unequal treatment in withdrawal from an AQUA managed fund

4. Janus Henderson Investors (Australia) Funds Management Limited ACN 164 177 244 (responsible entity) in its capacity as responsible entity for the Janus Henderson Net Zero Transition Resources Fund ARSN 657 029 822 (Fund), does not have to comply with paragraph 601FC(1)(d) of the Act to the extent that it would prevent the responsible entity from permitting only authorised participants to withdraw units in the Janus Henderson Net Zero Transition Resources Active ETF (Managed Fund) (Class), being a class of units in the Fund that is an AQUA managed fund.

Where the exemption applies

5. The exemption applies where all of the following are satisfied:
 - (a) there is a Product Disclosure Statement in relation to interests in the Class that are admitted to Trading Status as Managed Fund Product that contains statements to the effect that:
 - (i) the Class will invest in global equities and cash. The Class may also invest in other types of assets that are consistent with its objectives including cash equivalents, derivatives and managed investment schemes managed by the responsible entity;
 - (ii) the responsible entity will not treat members of the same class equally to the extent that it restricts withdrawal from the Class to authorised participants;
 - (iii) except in exceptional circumstances only authorised participants may withdraw their interests from the Class, but other members may sell their interests on the AQUA market; and
 - (iv) when interests in the Class are suspended from trading on the AQUA market for more than 5 consecutive Trading Days, members have a right to withdraw from the Class and receive payment for their

interests in money within a reasonable time of request unless any of the following apply:

- (A) the Class is being wound-up;
 - (B) the Fund is not liquid as defined in subsection 601KA(4) of the Act;
 - (C) the responsible entity suspends withdrawals in accordance with the constitution;
- (b) the constitution of the Fund does not permit a withdrawal fee per interest in the Class to be payable by a member who is not an authorised participant that is greater than the withdrawal fee per interest that would generally be payable by an authorised participant receiving redemption proceeds in cash while interests in the Class are quoted when withdrawing the minimum parcel; and
- (c) ASIC has not notified the responsible entity in writing that it is excluded from reliance on the exemption;

Note: Subparagraph 5(b) applies regardless of whether the withdrawal fees for the Fund are calculated on a per interest basis or otherwise.

Interpretation

In this instrument:

AQUA managed fund means a registered scheme with interests admitted to Trading Status as a Managed Fund Product on the financial market operated by ASX under the provisions of the operating rules of ASX relating to what is referred to in those rules as the AQUA market.

AQUA market means the financial market operated by ASX under the provisions of the operating rules of ASX relating to an AQUA Product.

AQUA Product has the same meaning as in the ASX operating rules as at the date of this instrument.

ASX means ASX Limited (ACN 008 624 691).

authorised participant means, in relation to the Class, a person who:

- (a) has an agreement with the responsible entity of the Fund in relation to making applications to acquire and withdraw interests in the Class; and
- (b) is either a Trading Participant or has engaged a Trading Participant to act on its behalf to acquire and dispose of interests in the Class.

Managed Fund Product has the same meaning as in the operating rules of ASX as at the date of this instrument.

minimum parcel means the smallest number or value of interests in the AQUA managed fund that are generally permitted to be withdrawn from the AQUA managed fund by an authorised participant while interests in the AQUA managed fund are quoted.

Trading Day has the same meaning as in the operating rules of ASX as at the date of this instrument.

Trading Participant has the same meaning as in the operating rules of ASX as at the date of this instrument.

Trading Status has the same meaning as in the operating rules of ASX as at the date of this instrument.

withdrawal fee per interest means, in relation to the Class, the fee that is payable in relation to a withdrawal from the Class divided by the number of interests in the Class to which the withdrawal relates.

- (d) written consents to the disclosure by MAS to ASIC and ASIC to MAS of any information or document that MAS or ASIC has that relates to the body. The consents must be in such form (if any) as ASIC specifies in writing.

Schedule B

1. The body must provide each of the financial services in this jurisdiction in a manner which would comply, so far as is possible, with the Singaporean regulatory requirements if the financial service were provided in Singapore in like circumstances.
2. The body must:
 - (a) notify ASIC, as soon as practicable and in any event within 15 business days after the body became aware or should reasonably have become aware, and in such form if any as ASIC may from time to time specify in writing, of the details of:
 - (i) each significant change to, including the termination of, the banking licence applying to the body relevant to the financial services the body provides or intends to provide in this jurisdiction; and
 - (ii) each significant particular exemption or other relief which the body may obtain from the Singaporean regulatory requirements relevant to the financial services the body provides or intends to provide in this jurisdiction; and
 - (iii) each action or investigation of the following kinds taken by MAS or other overseas regulatory authority against the body in a foreign jurisdiction in relation to financial services provided in the foreign jurisdiction:
 - (A) significant enforcement action;
 - (B) significant disciplinary action;
 - (C) significant investigation (unless, after having taken reasonable steps to enable notification to be given to ASIC, the body is prohibited by law from giving such notification but only to the extent of the prohibition); and
 - (b) provide written disclosure to all persons to whom the financial services are provided in this jurisdiction (before the financial services are provided) containing prominent statements to the following effect:

- (i) the body is exempt from the requirement to hold an Australian financial services licence under the Act in respect of the financial services; and
- (ii) the body is regulated by MAS under Singaporean laws, which differ from Australian laws.

Interpretation

5. In this instrument:

address, in relation to a company, means the address of the registered office of the body;

agent means a natural person resident in this jurisdiction or a company, whose name and address were last notified to ASIC by the body for the purposes of this instrument, and who is authorised to accept on the body's behalf, service of process from ASIC and, in relation to proceedings relating to a financial services law, from any person referred to in s659B(1) of the Act;

ASIC Act means the *Australian Securities and Investments Commission Act 2001*;

financial product advice has the meaning given by section 766B of the Act;

financial services law has the meaning given by section 761A of the Act;

managed investment products has the meaning given by s764A(1)(ba);

MAS means the Monetary Authority of Singapore;

notice and *notified* mean, respectively, written notice and notified in writing;

overseas regulatory authority means a foreign regulatory authority (other than MAS) which regulates financial services and which is established by or for the purposes of a foreign government or legislative body;

securities has the meaning given by section 761A of the Act;

Securities and Futures Act means the Securities and Futures Act (Cap.289);

Singaporean regulatory requirements means the rules that apply in relation to the financial services including any applicable legislation, instruments made under that legislation and any relevant policies or other documents (however described) issued by MAS; and

wholesale client has the meaning given in section 761G of the Act.
