THE COURT ORDERS BY CONSENT THAT:

- 5. On or before 4pm on 22 October 2024, the plaintiff is to file and serve any evidence it relies upon on the question of penalty and costs.
- 6. On or before 4pm on 5 November 2024, the defendant is to file and serve any evidence it relies upon on the question of penalty and costs.
- 7. On or before 4pm on 19 November 2024, the plaintiff is to file its written submissions on the question of penalty and costs and a list of authorities.

8. On or before 4pm on 2 December 2024, the defendant is to file its written submissions on the question of penalty and costs and a list of authorities.

9. On or before 4pm on 5 December 2024 the parties file and exchange notices to attend

for cross examination.

10. On or before 4pm on 5 December 2024 the parties are to file and serve a document

identifying any unresolved objections to any affidavit or document proposed to be

adduced in evidence by the other party.

11. On or before 4pm on 9 December 2024, the parties are to confer and agree a court book

index.

12. On or before 4pm on 12 December 2024, the plaintiff is to provide the defendant and

the Court with:

a. an electronic court book; and

b. an electronic bundle of authorities,

in each case in accordance with the eBooks Practice Note (GP-eBOOKS) using

Format 1.

14. There be liberty to apply.
