The person who is signing this document must use one of the following signing options:</p> <ul style="list-style-type: none">• Physically sign on a paper version of the document• Physically sign on a touchscreen device (eg. by a stylus or finger)• Digitally insert an image of the person's usual signature• Digitally type the person's name on the document
Lodgement period	<p>Must be lodged with Form 5100.</p>
Lodging fee	<p>Nil.</p>
Additional documents to be lodged	<p>This form must be lodged with a Form 5100 <i>Application for registration of a managed investment scheme</i>, and accompanied by a copy of the scheme's constitution (ASCOT Form 5101) and a copy of the scheme's compliance plan (ASCOT Form 5102)</p> <p>This form—Directors' statement—and the copy of the scheme's compliance plan must be signed by all the directors of the proposed responsible entity. Secretaries are not required to sign.</p> <p>Unless the managed investment scheme's constitution and compliance plan meet the requirements as specified in s601GA, 601GB, 601HA and 601HC of the <i>Corporations Act 2001</i>, ASIC will not register the scheme.</p>
How to provide additional information	<p>Additional Form 5103 pages</p> <p>If there is insufficient space in any section of the form, you may print additional copies of the relevant page(s) and submit as part of this lodgement.</p> <p>Annexures</p> <p>If there is insufficient space in any section of the form, you may alternately submit annexures as part of this lodgement.</p> <p>To make any annexure conform to the regulations, you must</p> <ol style="list-style-type: none">1. use A4 size paper of white or light pastel colour with a margin of at least 10mm on all sides2. show the company name and ACN or ARBN3. number the pages consecutively4. print or type in BLOCK letters in dark blue or black ink so that the document is clearly legible when photocopied5. mark the annexure with an identifying letter or symbol eg a,b,c or 1,2,3 etc.6. endorse the annexure with the words: This annexure (mark) of (number) pages referred to in form (form number and title)7. sign and date the annexure <p>The annexure must be signed by the same person(s) who signed the form.</p>
