## **ORDER**

# THE COURT NOTES THAT:

"books" has the same meaning as in the Corporations Act 2001 (Cth)

# THE COURT ORDERS BY CONSENT THAT:

- 1. By 5.00pm (AEDT) on 23 December 2024, the fourteenth defendant must (by his solicitors or personally) provide an email to the Receivers (or their solicitors) that describes:
  - (a) the books and other records of the eighth defendant (Harvey Madison Capital Pty Ltd);
  - (b) the means by or place at which those books and records were stored before 1 November 2024; and
  - (c) the means by or place at which those books and records were stored at the date of this order.
- 2. Subject to paragraph 3 below, by 5.00pm (AEDT) on 24 January 2025, the fourteenth defendant must:
  - (a) make, file and serve an affidavit that describes the matters set out in paragraphs 1(a),(b) and (c);
  - (b) make, file and serve an affidavit that:
    - (i) details any transaction or other dealing in cryptocurrency by:
      - (A) any of the defendants;



- (B) any other person (including but not limited to Amar Alamar or any other person who was an employee or contractor any of the first to thirteenth defendants) using money from any of the first to thirteenth defendants;
- (ii) explains the transactions and other matters referred to paragraph 2.3 of the email dated 10 December 2024 from Charles Haines of the Receivers' staff to the fourteenth defendant.
- 3. In the event that the fourteenth defendant wishes to object to compliance with paragraph 2 on the basis that compliance may tend to incriminate him or make him liable to a civil penalty, he must by 5.00pm on 24 January 2025, in accordance with section 128A of the *Evidence Act 1995* (Cth):
  - (a) make, file and serve an affidavit disclosing so much of the information required to be disclosed by paragraph2 to which no objection is taken;
  - (b) make an affidavit containing so much of the information required to be disclosed by paragraph 2 to which objection is taken and deliver it to the Court in a sealed envelope; and
  - (c) make, file and serve a separate affidavit setting out the basis of the objection.
- 4. Until further order, each of the first to thirteenth defendants must preserve any data or information stored on any mobile phone, laptop computer, desktop computer, tablet or other electronic device owned by it or used in its business.
- 5. Until further order, each of the fourteenth and fifteenth defendants must preserve any data, messages or information relating to the business, assets or financial affairs of any of the first to thirteenth defendants that are stored on any mobile phone, laptop computer, desktop computer, tablet or other electronic device that is in his or her possession or used by him or her.
- 6. The Receivers' costs of and incidental to this application are to be payable from the Property of the defendants.
- 7. There is liberty to apply.
