- This instrument applies to an offer of securities in Afterpay for sale by a holder of the securities where:
 - (a) the securities are issued by reason of conversion of a convertible note issued by Afterpay in the period beginning on the date of this instrument and ending on 31 June 2021;
 - (b) the offer of the convertible note did not require disclosure to investors under Part 6D.2 of the Act;
 - the terms of the convertible note are substantially the same as the terms provided to ASIC on 24 February 2021; and

This instrument is ASIC Instrument [21-0433].

Commencement

This instrument commences on 30 June 2021.

Definition

4. Agreement means the agreement between IOOF Holdings Ltd ABN 49 100 103 722 and National Australia Bank Limited ABN 12 004 044 937 entered into on 31 August 2020 for the purchase of MLC Wealth Limited ABN 97 071 514 264, including the business and assets of its subsidiary GWMAS.

financial adviser means an individual who is:

- (a) an authorised representative or an employee of an Australian financial services licensee; and
- (b) is authorised to provide personal advice to retail clients in relation to relevant financial products to retail clients.

GWMAS means GWM Adviser Services Limited ABN 96 002 071 749.

MLC Advice Adviser means a financial adviser who was authorised by GWMAS and operated under MLC Advice, a business name registered to GWMAS.

providing entity means:

- (a) a financial services licensee; or
- (b) an individual in their capacity as an authorised representative of a financial services licensee,

when either of those entities provides personal advice to a retail client.

SOA means a Statement of Advice.

Exemption

5. Bridges Financial Services Pty Limited ABN 60 003 474 977 (*Bridges*) does not have to comply with section 946A of the Act in relation to personal advice (the *further advice*) given on behalf of Bridges by a financial adviser (the

Bridges Adviser) authorised by Bridges to a person (the *client*) where all the following are satisfied:

- (a) within the 12 months preceding completion under the Agreement on 31 May 2021, the client received an SOA (the GWMAS SOA) from an MLC Advice Adviser:
- (b) the providing entity of the GWMAS SOA was either GWMAS or the MLC Advice Adviser as an authorised representative of GWMAS;
- (c) had the MLC Advice Adviser remained a financial adviser authorised by GWMAS, either GWMAS or the MLC Advice Adviser in their own right would have been able to rely on section 946B of the Act as notionally substituted by regulation 7.7.10AE of the Corporations Regulations 2001 in respect of the further advice;
- (d) the Bridges Adviser provides the further advice to the client in circumstances where:
 - (i) the MLC Advice Adviser had previously given the client the GWMAS SOA which sets out the client's relevant personal circumstances in relation to the advice (the *previous advice*) set out in the GWMAS SOA; and
 - (ii) the client's relevant personal circumstances in relation to the further advice (determined having regard to the client's objectives, financial situation and needs as currently known to the Bridges Adviser) are not significantly different from the client's relevant personal circumstances in relation to the previous advice; and
 - (iii) so far as the basis on which the advice is given relates to other matters – the basis on which the further advice is given is not significantly different from the basis on which the previous advice was given;
- (e) Bridges keeps a record of the further advice in accordance with regulation 7.7.09 of the Corporations Regulations 2001.
- The exemption in paragraph 5 applies in relation to further advice given by a Bridges Adviser for the period commencing on 30 June 2021 and ending on 30 June 2023.

Condition

- 7. Where:
 - the previous advice was provided to the client by the MLC Advice Adviser; and

Chapter 6 of the Act applies to The Go2 People Ltd ACN 616 199 896 (the *Company*) as if section 609 of the Act were modified or varied by omitting subsections 609(13C) – 609(13D) (as notionally inserted by ASIC Class Order [CO 13/520]).

Where this instrument applies

- 5. The declaration in paragraph 4 applies to the acquisition of a relevant interest in up to 249,439,675 securities of the Company (escrow securities) arising as a result of the entry into one or more voluntary escrow agreements or deeds (each an escrow agreement) between the Company and a Security Holder in connection with the proposed acquisition of all of the issued share capital of Skill Hire Australia Pty Ltd (ACN 143 386 707) where each escrow agreement:
 - (a) does not restrict the exercise of voting rights attaching to the escrow securities;
 - (b) in the case of a takeover bid (including a proportional takeover bid):

 - the issuer will make offers to issue shares under a purchase plan without disclosure to investors under Part 6D.2; and

 - (III) as at the date of the notice, the issuer has complied with its obligations under rule 1.15.2 of the listing rules of ASX Limited."

(12J) The sale offer of securities in a New Zealand foreign exempt listed body does not need disclosure to investors under this Part if:

- (a) the relevant securities are in a class of securities that were quoted securities at all times in the following period:
 - if this section applies because of subsection (1)—
 3 months before the day on which the relevant securities were issued; or
 - if this section applies because of subsection (1A)—
 3 months before the day on which the relevant securities were sold by the controller; and
- (b) trading in the class of securities on a prescribed financial market on which they were quoted was not suspended for more than a total of 5 days during:
 - if this section applies because of subsection (1) the shorter of the period during which the class of securities were quoted, and the period of 12 months before the day on which the relevant securities were issued; or
 - (ii) if this section applies because of subsection (1A) the shorter of the period during which the class of securities were quoted, and the period of 12 months before the day on which the relevant securities were sold by the controller; and
- (c) either:
 - (i) if this section applies because of subsection (1)—the body gives the relevant market operators for the body a notice that the body reasonably believes complies with clause 20 of Schedule 8 of the *Financial Markets* Conduct Regulations 2014 of New Zealand before the sale offer is made; or

 - (b) the notice states, in addition to any requirements of the Financial Markets Conduct Regulations 2014 of New Zealand at the time the notice is given, that:
 - the body will offer the relevant securities for issue without disclosure under this Part;

- (ii) the notice is being given under paragraph (2)(f); and
- (iii) as at the date of the notice, the body has complied with its obligations under rule 1.15.2 of the listing rules of ASX Limited.
