Australian Securities and Investments Commission Corporations Act 2001 – Paragraph 992B(1)(a) – Exemption

Enabling legislation

 The Australian Securities and Investments Commission (ASIC) makes this instrument under paragraph 992B(1)(a) of the Corporations Act 2001 (the Act).

Title

This instrument is ASIC Instrument 23-0743.

Commencement

This instrument commences on the day it is signed.

Exemption

- IG Power Marketing Pty Ltd (Administrators Appointed) (ACN 082 413 867) (Company)
 does not have to comply with the obligations in Subdivision C of Division 6 of Part 7.8 of
 the Act (other than under s989A of the Act) in relation to:
 - (a) the financial year of the Company ended 31 December 2022; and
 - (b) any other financial year of the Company that ends during the deferral period.

This paragraph applies until the last day of the deferral period.

Where this instrument applies

- 5. This instrument applies where:
 - the External Administrators were appointed as joint and several administrators of the Company under s436A of the Act on 24 March 2023;
 - (b) the Company holds Australian Financial Services Licence 234943;
 - (c) the External Administrators have advised ASIC that the AFSL is effectively dormant and the Company does not hold any open positions and is not undertaking any new hedging activities; and
 - (d) the Company is part of the corporate group of entities which includes IG Energy Holdings (Australia) Pty Ltd (Administrators Appointed)(ACN 090 996 142), IG Power (Callide) Ltd (Administrators Appointed)(ACN 082 413 885) and IG Power Holdings Limited (Administrators Appointed)(ACN 082 413 876) in respect of each of which the External Administrators were also appointed as joint and several administrators under s436A of the Act on 24 March 2023.

Conditions

The Company must comply with any obligation to which paragraph 4 applies by no later than the last day of the deferral period.

- This instrument will cease to apply in relation to a financial year of the Company from the date of any failure to comply with the condition in paragraph 6 in relation to a financial year.
- To avoid doubt, if an obligation to which paragraph 4 applies has not been complied with by the day after the end of the deferral period, this instrument has no application from that date to any continuing obligation.

Interpretation:

In this instrument:

deferral period means the period starting on the date of this instrument and ending on the earlier of

- (a) 24 March 2025;
- the date on which ASIC makes a specification under s915H of the Act that is inconsistent with the relief given by this instrument; or
- (c) the date that the Company ceases to be under external administration.

external administration means where an external administrator has been appointed to the Company.

external administrator means:

- an administrator of the Company appointed under s436A, 436B or 436C of the Act;
- (b) where the Company has executed a deed of company arrangement that has not yet terminated, the administrator of the deed appointed under Part 5.3A of the Act; or
- (c) a provisional liquidator of the Company.

External Administrators as at the date of this instrument means Grant Dene Sparks and Richard John Hughes.
