Enabling legislation

1. The Australian Securities and Investments Commission (*ASIC*) makes this instrument under paragraphs 741(1)(a), 741(1)(b), 926A(2)(a) and 1020F(1)(a) of the *Corporations Act 2001* (the *Act*).

Title

2. This instrument is ASIC Instrument 24-0794.

Commencement

3. This instrument commences on the day it is signed.

Exemptions

- 4. AngloGold does not have to comply with:
 - (a) Part 6D.2 or 6D.3 of the Act for an offer of its securities to holders of securities in the Company under the Scheme; and
 - (b) Division 5A of Part 7.9 of the Act in relation to an unsolicited offer to purchase securities in the Company under the Scheme.
- 5. The Company and AngloGold do not have to comply with subsection 911A(1) of the Act to the extent either provides general advice in the Scheme Document.

Declaration

- 6. Chapter 6D of the Act applies to holders of securities in AngloGold as if subsections 707(3) and (4) were omitted and substituted with:
 - "(3) An offer of a body's securities for sale within 12 months after their issue needs disclosure to investors under this Part if the body issued the securities:
 - (a) without disclosure to investors under this Part; and
 - (b) with the purpose of the person to whom they were issued selling or transferring them, or granting, issuing or transferring interests in, or options or warrants over, them;

and section 708 and 708A does not say otherwise."

 - (a) where AngloGold offers to purchase securities in the Company in return for the issue of securities in AngloGold and a cash payment pursuant to the Scheme on the terms and conditions as set out in the Scheme Document;
 - (b) where the Scheme Document and related communications, prepared for a meeting of holders of securities in the Company, are sent to all Australian resident holders of securities in the Company;
 - (c) where the Scheme Document and all related communications are provided to the London Stock Exchange and Toronto Stock Exchange for public release or otherwise publicly disclosed by the Company (including by publication on its website); and
 - (d) where the Company and AngloGold reasonably believe that the Scheme complies with all applicable laws and relevant regulatory requirements that, as at the date of the offer for issue of AngloGold securities under the Scheme, are in force in Jersey.

Interpretation

Company means Centamin Plc, a company incorporated under the laws of Jersey with registered number 109180.

AngloGold means AngloGold Ashanti Plc, a company incorporated under the laws of England and Wales with registered number 14654651.

general advice has the meaning given by subsection 766B(4) of the Act.

Scheme means the proposed scheme of arrangement under Article 125 of the Companies (Jersey) Law 1991 between the Company and its shareholders, pursuant to which AngloGold will offer a combination of securities in AngloGold and a cash payment to holders of securities in the Company as described in the Scheme Document.

Scheme Document means the document to be dated or intended to be dated on or around 30 September 2024 to be sent by the Company to holders of securities in the Company and others containing, among other things, the full terms and conditions of the Scheme and a notice of court meeting and explanatory statement in substantially the same form as provided to ASIC on or around 23 September 2024, with any such amendments, variations or supplements as are approved by the Royal Court of Jersey.
