A. DETAILS OF APPLICATION

This application is made under s 21 of the *Federal Court of Australia Act 1976* (Cth) (FCA Act), ss 75A and 75B of the *Insurance Contracts Act 1984* (Cth) (ICA), s 1101B(1) of the *Corporations Act 2001* (Cth), and the inherent or implied jurisdiction of the Court.

The plaintiff (**ASIC**) seeks declarations of contraventions of the ICA, pecuniary penalty orders and ancillary orders, including costs against the defendant (**OnePath**).

In this Originating Process, terms which are defined in the Concise Statement dated 7 December 2022 (**Concise Statement**) have the same meaning as they do in that document.

On the facts stated in the Concise Statement, ASIC claims:

Declarations of contravention

 A declaration that OnePath breached the requirements of s 13 of the ICA, and thereby contravened s 13(2A) of the ICA, on three (3) occasions, in that it failed to act towards the Insured, in respect of each matter arising under or in relation to

the contract of insurance with the utmost good faith, by reason of each of the following:

- (a) from 29 September to 7 October 2020, by proceeding to make the Determination and/or send the Avoidance Letter without first:
 - (i) enquiring of the Financial Adviser as to, or otherwise investigating, the contents of the Response Letter;
 - (ii) making any further enquiries of the Insured in consequence of the matters raised in the Response Letter;
 - (iii) considering, adequately or at all, whether the apparent nondisclosures or misrepresentations within the Application Form were fraudulent, in view of the:
 - (A) matters raised in the Response Letter; and/or
 - (B) structure and format of questions, and the format of responses, within the Application Form;
- (b) from 1 June to 7 October 2020, by proceeding to make the Determination and/or send the Avoidance Letter without first in the Procedural Fairness Letter or otherwise:
 - notifying the Insured that OnePath held concerns that nondisclosures or misrepresentations within the Application Form were fraudulent, identifying the basis for such concerns;
 - (ii) notifying the Insured that OnePath was considering whether there was a basis to avoid the Insured's income protection cover by reason of fraudulent non-disclosures or misrepresentations within the Application Form, identifying the basis for such considerations;
 - (iii) inviting the Insured to address the concerns and considerations referred to in (i) and (ii) in view of the bases for such concerns and considerations;
- (c) on or around 7 October 2020, by failing within the Avoidance Letter to inform the Insured of her rights and/or the availability of processes

(internal to OnePath and external) to dispute or appeal in respect of OnePath's decision to avoid the income protection cover within the Policy.

Penalties

2. An order pursuant to s 75B of ICA that, within 30 days of the order, OnePath pay to the Commonwealth of Australia such pecuniary penalties as the Court determines to be appropriate in respect of OnePath's conduct declared to be contraventions of s 13(2A) of the ICA.

Other Orders

- 3. An order pursuant to s 1101B(1) of the *Corporations Act 2001* (Cth), that, within 30 days of the order, OnePath take all reasonable steps to cause to be published, at its own expense, a notice stating that it has been ordered to pay a pecuniary penalty because it has contravened s 13(2A) of the ICA, in a manner and form approved by the Court.
- 4. An order that OnePath pay ASIC's costs of and incidental to the proceeding.
- 5. Such further or other orders as to Court considers appropriate.


