This application is made under sections 1317E and 1317G of the *Corporations Act* 2001 (Cth) (Corporations Act) and section 21 of the *Federal Court of Australia Act* 1976 (Cth) (Federal Court Act).

The nature of the proceeding is an application for:

- (a) declarations of contravention of civil penalty provisions against the Defendant; and
- (b) orders that the Defendant pay to the Commonwealth a pecuniary penalty.

- A declaration that MSAL's systems for compliance with sections 912DAA(1) and 912DAA(7) of the Corporations Act were deficient during the periods:
 - (a) 1 October 2021 to May 2023;
 - (b) May 2023 to August 2024; and
 - (c) August 2024 to September 2024,

and thereby contravened section 912A(1)(c) of the Corporations Act in respect of each period by failing to comply with the financial services laws.

- A declaration that MSAL's systems for compliance with sections 912DAA(1) and 912DAA(7) of the Corporations Act were deficient during the periods:
 - (a) 1 October 2021 to May 2023;
 - (b) May 2023 to August 2024; and
 - (c) August 2024 to September 2024,

and thereby contravened sections 912A(1)(a) and 912A(5A) of the Corporations Act in respect of each period by failing to do all things necessary to ensure that the financial services covered by its AFSL were provided efficiently, honestly and fairly.

- A declaration that MSAL contravened sections 912DAA(1) and 912DAA(7) of the Corporations Act by failing to notify ASIC of a reportable situation within 30 days after MSAL first knew that, or was reckless with respect to whether, there were reasonable grounds to believe that a reportable situation had arisen in respect of each of the following eight incidents:
 - (a) INC-0011906;
 - (b) INC-0013541;
 - (c) INC-0017604;
 - (d) INC-0017236;
 - (e) INC-0016363;
 - (f) INC-0016689;
 - (g) INC-0017268; and
 - (h) INC-0019650.



4 A declaration that:

- (a) MSAL contravened section 1308(4) of the Corporations Act by lodging reportable situation reports regarding INC-0011906 with ASIC dated 27 October 2023, 10 May 2024, and 15 November 2024 in circumstances where it knew, or was reckless as to whether, each report was materially false or misleading because of statements made in those documents; or
- (b) MSAL contravened section 1308(5) of the Corporations Act by failing to take all reasonable steps to ensure that the reportable situation reports regarding INC-0011906 dated 27 October 2023, 10 May 2024, and 15 November 2024 were not materially false or misleading because of statements made in those documents.

C. PECUNIARY PENALTIES
