- Introduction: s 22, and s 22 discussed the business scope of a change involving the removal of residential addresses from company extracts. The meeting aimed to clarify the scope, address technical nuances, and outline the implementation plan.
- Scope of Change: s 22 explained the scope of the change, which involves removing residential addresses of directors, secretaries, and alternate directors from company extracts. This change affects Australian companies and foreign bodies but not MISMS and other entity types. The team discussed the impact on role types and the need to consider technical changes.
- Engagement with Information Brokers: s 22 highlighted the need to engage with information brokers to gather information on their services and decide on the display and access of residential addresses. The team discussed the importance of government agencies retaining access to residential addresses and the potential impact on brokers.
